SUSPENSION OF ARCHITECT'S LICENSE

1. On June 14, 2012, the Board of Architecture, Engineering, Land Surveying, Landscape Architecture, Geoscience and Interior Design ("Board") revoked/suspended the license of Neil Weber ("Respondent"), based upon the Board's receipt of notification from the Minnesota Department of Revenue ("Department") that Respondent owed delinquent taxes, penalties or interest.

2. On June 26, 2012, the Board received a notice from the Department that Respondent had been issued a clearance certificate under the authority of Minnesota Statutes section 270C.72 (2010). The Department informed the Board that Respondent does not owe the State of Minnesota any uncontested delinquent taxes, penalties or interest and has filed all required forms.

Based on the evidence presented, the Board issues the following:

## ORDER

1. IT IS HEREBY ORDERED that the License Suspension Order issued to Respondent on June 14, 2012 is hereby RESCINDED and shall have no further force and effect.
