1. Q: Is a Historical Preservationist a required consultant for our team?
A: A “Historical Preservationist Consultant” is required due to the MSA campus setting and several 100 yrs old building in close proximity to the proposed new Frechette Hall.
2. Q: Please clarify: is a Health Services consultant a required consultant for our team?
A: A “Health Services Consultant” is not required. However, it would be an additional consideration to have a member of the team with demonstrated experience and understanding of guidelines, regulations and codes for facility that houses and educate deaf, blind and deaf-blind physically impaired individuals ranging from age 4 to 21 years of age.
3. Q: Is a security consultant a required consultant for our team?
A: A “Security Consultant” is not required. However, it would be an additional team consideration to have a member of the team with security demonstrated experience and understanding guidelines, regulations and codes for a deaf, blind and deaf / blind students in educational and housing facility.
4. Q: Is a Food Services consultant a required consultant for our team?
A: A “Food Service Consultant” is not required.
5. Q: Is Building Information Modeling (BIM) a requirement for this project?
A: “Building Information Modeling” (BIM) is required on all New State of Minnesota construction projects. The design consultant must demonstrate a high level of understanding BIM.
