SUPPLEMENTAL AGREEMENT/CONTRACT AMENDMENT NO. # 2

This SUPPLEMENTAL AGREEMENT/CONTRACT AMENDMENT is made by and between the STATE of MINNESOTA, acting through its Commissioner of Administration, "STATE," and, Independent Testing Technologies, Inc., 337 31st Ave. South, Waite Park, MN 56387, "CONSULTANT."

WHEREAS, STATE and CONSULTANT have entered into a contract, known as Department of Administration Contract No. 23034 (previously MAPS No. 442712) for Testing and Inspection Services Master Contract; which was fully executed on January 20, 2010.

WHEREAS,

1. The original contract called for testing and inspection services.
2. It is necessary to modify the original contract to include the following modification:
 - a. Paragraph 1.3, as amended by Supplemental Agreement No. 1, provides for an expiration date of December 31, 2012 and an extension is necessary.

NOW THEREFORE, it is mutually agreed to amend Contract No. 23034 (previously MAPS No. 442712) as follows:

1. Contract expiration date shall be revised to December 31, 2013.
2. Paragraph 1.3 language determining expiration date of this contract shall be changed to December 31, 2013.

Except as amended herein, the terms and conditions of the Original Contract and all previous amendments remain in full force and effect.
