

Application for Registration with the Petrofund Board as a Contractor

Under Minnesota Statutes Chapter 115C.11, all contractors who perform corrective action services in response to a petroleum tank release must register with the Petrofund Board. "Contractor" means an individual, partnership, association, private corporation, or any other legal entity that actually performs contractor services, which are services within a scope of work that can be defined by typical written plans and specifications, such as excavation, treatment of contaminated soil and groundwater, drilling, laboratory analysis, professional surveying, electrical work, plumbing, and carpentry. As part of complying with the required registration criteria, contractors must complete this form and submit it together with the indicated documentation.

Registration is effective 30 days after a complete application is received by the board and expires each year on the anniversary date of the most recent registration. Prior to its annual expiration, a registration remains in force until voluntarily terminated by the registrant, or until suspended or revoked by the Commissioner of Commerce.
