The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 - Not Small Amount Marijuana

Minnesota Statute: 152.025.2(a)(1), with reference to: 609.11.5(a), 609.101.3, 152.025.2(a)

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000

Offense Level: Felony

Offense Date (on or about): 02/17/2016

Charge Description: That on or about 2/17/2016, in Hennepin County, Minnesota, YUSSUF AHMED HAMID unlawfully possessed one or more mixtures containing a Schedule I, II, III, or IV controlled substance, to-wit: khat, while possessing a firearm.

Minimum Sentence: 3 YEARS

STATEMENT OF PROBABLE CAUSE

Your Complainant is an Investigator with the Minnesota Department of Commerce, and in that capacity has investigated the facts and circumstances of the offense alleged herein, including reviewing the reports of other officers. Your Complainant believes the following establishes probable cause:

On February 17, 2016, Commerce Fraud Bureau agents executed a search warrant at 9115 Penn Avenue, Apartment 105, Bloomington, Hennepin County, Minnesota, the residence of YUSSUF AHMED HAMID, defendant herein, the target of the warrant. In the bedroom of the residence, in an open nightstand drawer, agents located a 9 mm handgun with a loaded magazine. In an unlocked safe in an open dresser drawer, officers located a sandwich bag stuffed a green substance agents recognized as suspected khat.
