The Minnesota Public Utilities Commission will hold a public hearing to receive public comments on the Application for a Certificate of Need filed by Elm Creek Wind LLC for the Elm Creek Wind Project in Jackson and Martin Counties on **Tuesday, November 27, 2007 at Americinn, 110 Belmont Lane, Jackson, MN, beginning at 6:00 PM.**

Elm Creek Wind LLC seeks approval of the Certificate of Need and Site Permit for its Elm Creek Wind Project. Public comments on both the Certificate of Need and Site Permits applications for the 100.5 megawatt wind farm will be received at the public hearing. Several documents are available for review, including Elm Creek's Certificate of Need and Site Permit applications, an Environmental Report prepared by the Minnesota Department of Commerce on Elm Creek's need for 100.5 megawatts of wind capacity, and a draft site permit for Elm Creek's proposed 100.5 megawatt wind farm. Administrative Law Judge Steve M. Mihalchick will preside at the hearing. Interested persons are encouraged to attend and provide oral or written comments on whether the proposed project is needed and in the public interest. 
