RE: **NOTICE OF COMMENT PERIODS**

Take Note that on November 30, 2010 Northern States Power Company d/b/a Xcel Energy, and the City of Glencoe (the Applicants) filed a certificate of need application with the Minnesota Public Utilities Commission (Commission) for 115 kV transmission line upgrades to the Glenconia – Waconia 69 kV system in Carver and MacLeod Counties. The proposed project would include construction of approximately 2 miles of new 69 kilovolt (kV) transmission line, 6 miles of new 115 kV transmission line and an upgrade to approximately 20 miles of 69 kV transmission line to 115 kV capacity along with certain substation modifications located in the southwest metro areas of the Twin Cities. The Applicants state that the project is needed to address pending load serving problems in the rapidly developing regions of Scott, Carver, McLeod, and Hennepin counties located in the western Twin Cities.

Minnesota Statute §216B.243 and Minnesota Rule 7849.0120 specify the criteria the Commission applies in determining whether to grant a Certificate of Need for the project.

The Applicants filed their application with the Commission on November 30, 2010. The Commission is soliciting comments on the completeness of the Application pursuant to Minn. Rules 7849. Initial comments will be accepted through **Wednesday, December 29, 2010** and replies through **Tuesday, January 11, 2010**.

Commission staff is proposing that the deadline for Commission action on completeness be extended past the 30-day period indicated by the applicable rules. The time extension proposal (tolling time) will likely be considered by the Commission on Thursday, December 21, 2010.
