North Dakota Pipeline Company LLC ("NDPC") filed applications for a Certificate of Need ("CN") and a Pipeline Route Permit ("PRP") with the Minnesota Public Utilities Commission ("MPUC") for the Sandpiper Pipeline Project ("Project") on November 8, 2013. Those applications were revised on December 16, 2013 by NDPC and the PRP was accepted by the MPUC on January 16, 2014. NDPC further supplemented the CN and PRP applications on January 31, 2014.

Pursuant to Minnesota Statute 7852.2000 Subpart 6, NDPC is sending you this letter and enclosed CD-ROM version of the Sandpiper CN and PRP applications, as well as the January 2014 supplement, with the request that you provide them for public review.

NDPC proposes to construct the Project which consists of approximately 616 miles of 24-inch and 30-inch crude oil pipeline, including all associated valves and appurtenances. In Minnesota, the Project comprises 73 miles of 24-inch pipe west of Clearbrook, Minnesota and 229 miles of 30-inch pipe east of Clearbrook. The Project will also include a new terminal and pump station near Clearbrook, Minnesota and aboveground launcher/receiver traps near Pine River, Minnesota.

The Project will transport growing supplies of North Dakota crude oil to refining centers in the Midwest and the East Coast. The Project will be operationally integrated with the NDPC System, and will be used to transport crude oil to the Enbridge Superior terminal facilities for subsequent delivery of crude oil supplies on the Enbridge Mainline System. To meet the need for safe and economical transportation capacity, the Project will provide up to 225,000 barrels per day ("bpd") of new crude oil capacity from North Dakota. The Project will have a capacity of 375,000 bpd between Clearbrook, Minnesota and Superior, Wisconsin. The incremental 150,000 bpd will come via NDPC's existing Line 81 at Clearbrook. Additionally, the Project will have the ability to deliver crude oil at the new Clearbrook Terminal as redundant service for NDPC's existing Line 81.

The MPUC must certify that the Project is needed and issue a pipeline route permit before NDPC may begin construction. The application process is governed by Minnesota Law, including Chapters 7852 and 7853 of the Minnesota Rules and Chapter 216 of the Minnesota Statutes.
