Dear Mr. Poth

Thank you for your work with my Administration to develop a State Plan for FirstNet in Minnesota. I appreciate the attention to detail and your responsiveness to the concerns and priorities we have established for our state and its first responders.

I understand that your role is to develop and implement the First Network Responder's Act, and it was not your decision to assign the final decision to opt-in or out to me. As such, I ask you to acknowledge the 11 Federally Recognized Minnesota tribes as sovereign nations and, recognizing this sovereignty, enter into consultation with them. I urge you to work with the tribes so that they fully understand any environmental impact to their land and whether or not the FirstNet network would be beneficial to their citizens.

In the State Portal, it says:

"Builds are displayed for illustrative purposes to represent a general geographic area; actual latitude/longitude site locations cannot be provided until several steps occur, including formal land acquisition and build approval processes. Should the actual site locations vary materially from that shown here, AT&T will coordinate with the First Responder Network Authority and the State regarding alternative site location(s)."

I understand this to mean that FirstNet and AT&T will act in good faith with the tribes to ensure they are able to make an informed decision regarding the needs of their communities. While my Administration identified additional towers to address coverage gaps on tribal lands, the placement of towers on tribal lands requires tribal consent.

As you have worked to ensure Minnesota has the best network and services available for first responders, I trust you will do the same in consultation with the tribes.
