**Note:** The citations preceded by an asterisk were chosen by Justice Kelly in response to the request to select several cases that demonstrated the "Kelly approach" to the resolution of disputes and controversies. The decisions involve a number of factual situations from many areas of law and span Justice Kelly's 10-year tenure on the bench. The opinions show Justice Kelly enjoyed the difficult task of determining legislative intent, held a strong belief on the role of stare decisis and precedent in judicial reasoning and often cautioned his colleagues on the need to reflect on the ultimate consequences a particular action may have when supported by a Supreme Court majority opinion.
