

THE OPINIONS OF C. DONALD PETERSON

The pages that follow include all of the signed opinions of Justice Peterson arranged alphabetically by West Publishing Company's topic headings. Within each of these subject headings the cases are subarranged first by year of decision (the older opinions are first) and then alphabetically by case name.

Unless a case states otherwise, it is a majority opinion, in other words, a decision which decided the case and which was written for the majority of the justices. If a case is listed as a dissenting opinion, it is one in which Justice Peterson disagreed with the majority of the other justices and wrote a separate dissent that did not decide the case. A case listed as a concurring opinion is one in which Justice Peterson wrote a separate opinion, but one that agreed with the majority's decision.

To the left of many of the decisions are codes which are designed to provide more information on the cases. A decision with an asterisk (*) to the left indicates that Justice Peterson considers it to be a significant decision, while two asterisks (**) indicates that he considers it to be even more significant. Cases with an "A" to the left are those opinions that an American Law Reports annotation has been prepared for, and a "J" designates that the case was included in "Judicial Highlights," a monthly summary of important cases found in the advance sheets of West Publishing Company's reporter series. Important cases reported in the media are designated with an "M," and those cases considered important by Justice Peterson's law clerks are marked with an "L."

JUSTICE PETERSON'S PER CURIAM OPINIONS

In addition to the signed opinions written by the Justices of the Supreme Court are the per curiam decisions. These opinions were unsigned, but they were drafted by an individual justice. For the most part, per curiam decisions were disciplinary cases or those cases not creating precedent, and in 1976 the Court initiated pre-hearing conferences, thus ending the release of per curiam opinions.
