

Types of Articles Accepted

Papers relevant to the issues outlined in the editorial policy of this journal will be considered for publication, regardless of format. Specifically, all of the following types of manuscripts are acceptable: Research reports, reviews, theoretical papers, program descriptions, case studies, position papers, and book reviews.

In addition to appropriateness of content, the following criteria will be used to evaluate papers: 1.) clarity, 2.) significance, and 3.) technical ade-

Manuscript Guidelines

1. Submit the original and two copies. The manuscript should be double spaced.
2. In general, the guidelines in the Publication Manual of the American Psychological Association, Third Edition should be followed. However, some flexibility will be allowed with opinion papers & non-research manuscripts.
3. The manuscript should be accompanied by a cover letter which indicates that it is intended for publication, has not been printed elsewhere, and is not being considered by any other publication. The cover letter should also specify the name, address and phone number of the author who will be corresponding with the editors.
4. If you wish to have the copies of your manuscript returned, you must also include a stamped, self-addressed envelope.
5. Since this journal uses a blind review process, authors' names and any other identifying material should be omitted from the manuscript. Authors' names and affiliations must appear only on a separate title page. (Occasional solicited articles will not go through the blind review process.)
6. An abstract of 100-120 words should be included on a separate sheet of paper.
7. Articles should be limited to a maximum of 20 typed pages.
8. When an article is published, each author will receive two complimentary copies of that issue.
