2018 - 2019 PROGRAM OUTLINE

GOALS:

- 1) Our **GOAL** is to have at least one Community Service Report from **each** Post by Fall Conference. A GOAL, which is attainable by each and every Post!
- 2) Each VFW Post, AND Auxiliary must have one **JOINT** Community Service Report per month.
- 3) The **Goal** is to have **12** consecutive Community Service Reports.

PROCEDURES AND RULES:

- 1) The Community Service **YEAR** runs from **APRIL 1, 2018 THROUGH MARCH 31, 2019**
- 2) Send a report **EVERY CALENDAR MONTH**. One report form should cover one (1) calendar month. **Retain a copy** of each report you send.
- 3) **Report Deadline** – All Reports Must be Postmarked by the 20th of each month.
****See page 12 for a list of dates**
- 4) **VFW Post, Auxiliary** Chairmen should send their **JOINT REPORT** to the Department Chairman Dewey Hermanson, Rice Street Station - PO Box 17146, St Paul, MN 55117.
- 5) To check the status of your Post's Community Service reports go to the VFW webpage at www.mn.gov/vfw. Then go to the "Department Headquarters" page. Once there, you can click on "Post Progress Reports", and on the next page, click on "Community Service Report". Lastly, scroll down to your District.
- 6) **DO NOT assign a dollar value to Volunteer Hours. Report ONLY the money you actually spent to complete the project (including mileage actually paid).**

CATEGORIES:

- 1) For contest purposes **ONLY** (this criteria **MAY OR MAY NOT** be the same as other programs). Posts have been placed in the following categories:

Category 1
Category 2

Posts with 250 members or less
Posts with 251 members or more

RECOGNITION:

- 1) Awards will be given at the Department Convention for the **Outstanding Community Service Record Book(s)** in each category.
- 2) **NATIONAL AWARD – Outstanding Community Service Post**
 - A) There will be two awards for the state. Community Service Recordbooks are required to qualify for this award.
 - B) Two (2) Outstanding Community Service Posts will be submitted to National Headquarters.
- 3) An **AWARD** will be given by National Headquarters for the **Outstanding Community Service Project**. Details of this program may be found in the National web page at www.vfw.org and mailings you will receive throughout the year.
- 4) The contest for **ALL STATE COMMANDER HONORS** includes points for Community Service participation.
 - A) Starting with **APRIL 1, 2018 THROUGH MARCH 31, 2019** 1 POINT will be awarded for **EACH MONTH** that a report is received **ON TIME**.

NOTE: ON TIME MEANS POSTMARKED BEFORE THE 20TH DAY OF THE MONTH FOLLOWING THE MONTH BEING REPORTED. (EXAMPLE: AUGUST REPORT HAS TO BE POSTMARKED BY SEPTEMBER 20TH. LATE REPORTS DO NOT COUNT TOWARDS POINTS FOR ALL STATE COMMANDER'S HONORS.)

- 5) A special 100% in reporting posts will receive a citation at Department Convention. Reports must be completed each month and postmarked by the 20th.

CONTEST RULES:

- 1) Community Service **RECORDBOOKS** (for State competition) cover the period of **APRIL 1, 2018 THROUGH MARCH 31, 2019**. The **DEADLINE** for receiving recordbooks **AT DEPARTMENT HEADQUARTERS** for State Competition is **APRIL 17, 2019** by **4:00 P.M.**

COMMUNITY SERVICE IS VOLUNTEER WORK

Community Service is the volunteer work we do in the community. Only projects benefiting the community may be reported. You may report Community Service performed by the Post, Auxiliary and Cooties, for projects that are beneficial to the community.

You cannot take Community Service credit for anything that enhances your Post such as:

- Putting poppies on cards, or making corsages out of poppies.
- Working at a fish fry, steak fry, pancake breakfast or any other work at your VFW.
- Burning a candle or saying a prayer at your meeting.
- Driving a relative to the VA office or doctor's office or caring for a sick relative.
- Driving to the state capital to support a Veteran's Bill.
- Attending a VFW baseball tournament or hockey tournament.
- Color Guard posting colors at a Post or District meeting.
- Filling out a Community Service Report or putting together a Community Service Book.
- Flying the American or the POW/MIA Flag

You should claim all money that is actually donated but, **you cannot claim the value of the hours volunteered.** Report only your hours and members, National will assign a dollar value to your report.

You cannot claim all of your members on a project, **only the members that actually worked on the project.**

If you report an item on your Community Service Report in more than one category you may only take hours and members one time in the report.

It is our intent to send accurate reports to our National organization. In order to do that we must have accurate reports from the Post's and Auxiliary's.

If your report appears to have members, hours, dollars and projects that are not correct you will be credited for a Community Service Report but will not get credit for money, hours and members until your report has been adjusted.

POST AND AUXILIARY COMMUNITY SERVICE REPORT

REMEMBER:

- 1) Submit a separate monthly report for each calendar month to:

- 2) **DEADLINE** - Monthly Report Form must be postmarked by the 20th day of the following month.
- 3) Department has two forms- a digital form you can complete on your computer and a printable form. They are available in three locations. Every month your Post Commander can use the form in the General Orders provided. Secondly, available on the department webpage www.mn.gov/vfw on the VFW Programs Page for everyone (including your Auxiliary members). Finally, available to Commanders at the secured section of the web page, is a downloadable spread sheet to fill out on you computer.
- 4) You **must** fill out items 25, 26 and 27 on the Community Service Report form to receive credit for the monies, hours and members activities for that month.

We will not add them for you. If they are blank, they will be blank on the report that we send to our National Organization reporting how much money, how many hours and how many members participated with Community Service.


