MINUTES OF THE EXECUTIVE COUNCIL THE STATE OF MINNESOTA Friday, March 21, 2025

In attendance: Governor Tim Walz

Lieutenant Governor Peggy Flanagan

State Auditor Julie Blaha

Secretary of State Steve Simon Attorney General Keith Ellison

At approximately 9:00 AM, Governor Walz called the meeting of the Executive Council to order. A quorum was present.

Governor Walz brought forth the first agenda item, approval of the Executive Council Meeting Minutes from December 10, 2024. He called for any discussion. Hearing none, he requested a motion to approve. So moved by State Auditor Blaha. The motion was approved on a voice vote.

Moving to the second agenda item, Governor Walz recognized Minnesota Management and Budget (MMB) Assistant Commissioner Jennifer Hassemer to present the request for approval of collateral for State funds, as required under Minnesota Statutes, section 9.031, subdivisions 2 and 3.

Assistant Commissioner Hassemer provided an overview of the agenda item.

Governor Walz called for discussion. Hearing none, he requested a motion to approve. So moved by Lieutenant Governor Flanagan. The motion was approved on a voice vote.

Moving to the third agenda item, Governor Walz again recognized Assistant Commissioner Hassemer to present a request to approve designation of state community depository accounts, as required under Minnesota Statutes, section 9.031, subdivision 1.

Assistant Commissioner Hassemer provided an overview of the agenda item.

Governor Walz called for discussion. Hearing none, he requested a motion to approve. So moved by State Auditor Blaha. The motion was approved on a voice vote.

Moving to the fourth agenda item, Governor Walz recognized Department of Natural Resources (DNR) Director of Lands and Minerals Joseph Henderson to present a request to approve issuance of a state taconite iron ore mining lease to Cleveland-Cliffs Hibbing Inc., Cliffs Mining Holding Sub Company, Ontario Hibbing Company, and Hibbing Development Company, as required under Minnesota Statutes, section 93.1925.

Before reviewing the item, Director Henderson briefly addressed recent public comments regarding the need for the lease following news about temporary mine idling. He emphasized that long-term mine planning requires such leases and that they remain essential to operations.

At the Governor's request, Director Henderson also provided an overview of the consultation and outreach process, including engagement with Tribal governments.

Lieutenant Governor Flanagan commented on the recent layoffs, expressing support for impacted workers.

Governor Walz called on the individual who had requested to provide public comment, but they were not present, and no public comment was provided.

Governor Walz called for discussion. Hearing none, he requested a motion to approve. So moved by Lieutenant Governor Flanagan. The motion was approved on a voice vote.

Governor Walz called for any further discussion from members of the Executive Council. Hearing none, he requested a motion to adjourn. So moved by State Auditor Blaha. The motion carried, and the meeting was adjourned at approximately 9:10 AM.

MINUTES OF THE EMERGENCY MEETING OF THE EXECUTIVE COUNCIL THE STATE OF MINNESOTA Friday, May 23, 2025

At approximately 12:00 PM, Governor Walz called the meeting of the Executive Council to order. As Chair of the Executive Council, Governor Walz determined that the requirements of Minnesota Statute §13D.021 had been met, allowing the meeting to be conducted via interactive technology.

Governor Walz acknowledged the issuance of Executive Order 25-05 on May 20, 2025, declaring a peacetime emergency to continue assistance to communities impacted by the wildfires throughout our state. The Department of Public Safety requested an extension of this peacetime emergency.

Governor Walz then recognized Commissioner Bob Jacobson and Assistant Commissioner John Cunningham from the Department of Public Safety to present the request to extend the peacetime emergency declared in Executive Order 25-05. Assistant Commissioner Cunningham provided an update on the wildfire situation in northern Minnesota, noting there are currently three active fires, two of which are largely under control. The Jenkins Creek Fire remains mostly uncontained, though significant progress had been made in the previous 24 hours. The proposed extension of the peacetime emergency will allow HSEM and state partners to continue supporting firefighting efforts and begin transitioning to long-term recovery for affected communities.

Governor Walz opened the floor for any questions for Commissioner Jacobson or Assistant Commissioner Cunningham regarding the extension. The State Auditor expressed gratitude to all those involved in the wildfire response, noting the deep personal impact on affected communities and urging continued caution and support. Governor Walz echoed these remarks and commended the coordinated efforts of local first responders, state and federal partners, and community members. He noted the severity of conditions and the importance of maintaining resources to manage what is expected to be a challenging wildfire season.

Governor Walz called for a motion to approve the request. State Auditor Blaha moved the request. A roll call vote was taken, with each member voting as follows:


Governor Walz voted in favor of the motion, and the extension of the peacetime emergency for 30 days was approved.
