## Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. ## **Exempt Rules**

Exempt rules are excluded from the normal rulemaking procedures (*Minnesota Statutes* §§ 14.386 and 14.388). They are most often of two kinds. One kind is specifically exempted by the Legislature from rulemaking procedures, but approved for form by the Revisor of Statutes, reviewed for legality by the Office of Administrative Hearings, and then published in the State Register. These exempt rules are effective for two years only.

The second kind of exempt rule is one adopted where an agency for good cause finds that the rulemaking provisions of *Minnesota Statutes*, Chapter 14 are unnecessary, impracticable, or contrary to the public interest. This exemption can be used only where the rules:

- (1) address a serious and immediate threat to the public health, safety, or welfare, or
- (2) comply with a court order or a requirement in federal law in a manner that does not allow for compliance with *Minnesota Statutes* Sections 14.14-14.28, or
  - (3) incorporate specific changes set forth in applicable statutes when no interpretation of law is required, or
  - (4) make changes that do not alter the sense, meaning, or effect of the rules.

These exempt rules are also reviewed for form by the Revisor of Statutes, for legality by the Office of Administrative Hearings and then published in the *State Register*. In addition, the Office of Administrative Hearings must determine whether the agency has provided adequate justification for the use of this exemption. Rules adopted under clauses (1) or (2) above are effective for two years only. The Legislature may also exempt an agency from the normal rulemaking procedures and establish other procedural and substantive requirements unique to that exemption.

# Proposed Exempt Permanent Rule Adopting Federal Occupational Safety and Health Standards by Reference; Request for Comments

**NOTICE IS HEREBY GIVEN** that the Department of Labor and Industry, Occupational Safety and Health Division (Minnesota OSHA) proposes to adopt the following revisions to the Department of Labor and Industry, Occupational Safety and Health Rules, as authorized under Minnesota Statutes §182.655. This notice proposes the adoption of an Occupational Safety and Health Standard already proposed and adopted by the Federal Occupational Safety and Health Administration (Federal OSHA).

All interested or affected persons have 30 days from the date this notice is published in the State Register to submit, in writing, data and views on the proposed amendments to the rule. Comments in support of or in opposition to the proposed amendments are encouraged. Each comment should identify the portion of the proposed amendment addressed, the reason for the comment, and any proposed change.

Any person may file with the Commissioner written objections to the proposed amendments stating the grounds for those objections and may request a public hearing. A public hearing will be held if 25 or more persons submit written requests for a public hearing on the proposed amendments within the 30-day comment period. Requests for hearing must include the name and address of the person submitting the request, define the reasons for the request, and discuss any proposed changes. If a public hearing is required, the Department will proceed according to the provisions of Minnesota Statutes §182.655 and Minnesota Rules 5210.0020 to 5210.0100.

#### SUMMARY OF CHANGES

The following is a brief summary of the proposed amendments. To review the complete Federal Register notice referenced below, visit **www.osha.gov**.

(A) "Walking-Working Surfaces and Personal Protective Equipment (Fall Protection Systems); Final rule." On November 18, 2016, Federal OSHA published a final rule in the Federal Register amending its general industry standards on walking-working surfaces to prevent and reduce workplace slips, trips, and falls, as well as other injuries and fatalities associated with walking-working surface hazards. The final rule includes revised and new provisions addressing, for example, fixed ladders; rope

descent systems; fall protection systems and criteria, including personal fall protection systems; and training on fall hazards and fall protection systems. In addition, the final rule adds requirements on the design, performance, and use of personal fall protection systems, and increases consistency between the general industry and construction standards. This final rule was effective January 17, 2017, at the federal level, with some requirements having compliance dates after the effective date.

By this notice, Minnesota OSHA proposes to adopt the final rule as published in the Federal Register November 18, 2016.

Commissioner's Order: Designation of "No Registration Weekend" for All-Terrain Vehicles

**Date**: May, 01, 2017

Statutory authority: Minnesota Statutes, section 84.922, subdivision 13

#### **BACKGROUND**

**WHEREAS**, Minnesota Statutes, section 84.922, subdivision 13, requires the Commissioner of Natural Resources to designate one "no registration weekend" each year for all-terrain vehicles.

**WHEREAS**, during the designated "no registration weekend" an all-terrain vehicle may be operated on state and grant-inaid all-terrain vehicle trails without a registration or a nonresident state trail pass, notwithstanding the requirements of Minnesota Statutes, section 84.922, subdivision 1, and Minnesota Statutes, section 84.9275, subdivision 1.

**WHEREAS**, the designation must be by written order published in the *State Register*.

#### **ORDER**

**NOW, THEREFORE, IT IS HEREBY ORDERED**, pursuant to authority vested in me by law, including but not limited to Minnesota Statutes, section 84.922, subdivision 13, that June 2, June 3 and June 4, 2017 are designated a "no registration weekend" during which time an all-terrain vehicle may be operated on state and grant-in-aid all-terrain vehicle trails without the registration required by Minnesota Statutes, section 84.922, subdivision 1. Nonresidents may operate an all-terrain vehicle on state and grant-in-aid all-terrain vehicle trails without possessing a state trail pass issued under Minnesota Statutes, section 84.9275.

This order is effective upon publication in the *State Register*.

**Introduction.** Notice is hereby given that the Minnesota Department of Health (MDH) is seeking information or opinions from outside sources regarding a proposed revised version (version 7.0) of the Minnesota Uniform Companion Guide (MUCG) for the ASC X12N/005010X214E2 Health Care Claim Acknowledgment (277). The revised version is proposed by the Commissioner of Health and was developed in consultation with the Minnesota Administrative Uniformity Committee (AUC) and its Acknowledgment Technical Advisory Group (TAG).

For brevity, hereinafter "277CA" will be used in this document for "ASC X12N/005010X214E2 Health Care Claim Acknowledgment (277)."

Contact Person. MDH requests information and opinions concerning the applicability and functionality of proposed revisions be submitted to Susie Veness as described below. Interested persons or groups may submit data or views in writing, to be received no later than 4:00 p.m. June 22, 2017. Electronic submissions should be sent in Word format. **Description of the Rules.** Minnesota Statutes, section 62J.536, requires the Minnesota Commissioner of Health, in consultation with the Minnesota Administrative Uniformity Committee (AUC), to promulgate rules pursuant to section 62J.61 establishing and requiring group purchasers, clearinghouses, and health care providers to exchange specified health care administrative transactions electronically, using the applicable single, uniform companion guide adopted by the Commissioner of Health. Under Minnesota Statutes, section 62J.61, the Commissioner of Health is exempt from chapter 14, including section 14.386, in implementing sections 62J.50 to 62J.54, subdivision 3, and 62J.56 to 62J.59.

The proposed version 7.0 rule describes the data content and other transaction specific characteristics of the 277CA transaction, for use by entities subject to Minnesota Statutes, section 62J.536.

MDH, in consultation with the AUC, determined that the already lengthy and detailed v6.0 MUCG should be modified to include options for the use of numerous additional "Claims Status Code" and "Claims Status Category Code" combinations that were previously not permitted in the MUCG;

Incorporating the additional codes in v7.0 would create a lengthy document effectively very similar to the underlying ASC X12N specifications known as the 277CA "Implementation Guide" on which the MUCG is based and which it complements;

Rather than create a lengthy document similar to the Implementation Guide, MDH is proposing to incorporate the specifications of the Implementation Guide by reference in its MUCG. This enables the exchange of the 277CA transaction pursuant to the specifications of the Implementation Guide, and allows for a greater number of Claims Status Code and Claims Status Category Code combinations than the v6.0 MUCG. The incorporation by reference is also far more succinct than listing large numbers of code combinations as displayed in the v6.0 MUCG.

The proposed one-page v7.0 277CA MUCG reads as follows:

Notice of Availability of the Draft Hawk Creek Watershed Total Maximum Daily Load (TMDL) and Watershed Restoration and Protection Strategy (WRAPS) Reports and Request for Comment

Public comment period begins: May 22, 2017 Public comment period ends: June 21, 2017

The Minnesota Pollution Control Agency (MPCA) is requesting comments on the draft Hawk Creek Watershed Total Maximum Daily Load (TMDL) and Watershed Restoration and Protection Strategy (WRAPS) Reports (Reports). The Hawk Creek Watershed is located in the Minnesota River-Yellow Medicine River Watershed, in southwest Minnesota, on the north side of the Minnesota River. The watershed in these Reports includes portions of three counties (Chippewa, Kandiyohi and Renville), which are included in the project area of approximately 980 square miles.

Generally, most streams and lakes in the watershed fail to support swimming or fishing. Stream bank erosion and stormwater runoff create a negative effect on water quality. Runoff from agricultural activities carries excess phosphorus, sediment and bacteria into water bodies. These pollutants degrade water quality and are harmful to fish and other aquatic life.

Four lakes and 13 stream reaches of the river and its tributaries have been placed on the state's impaired waters list for exceeding water quality standards for excess nutrients, bacteria and turbidity. The TMDL addresses the impairments for all four lakes and the impairments for 13 sections of rivers. The TMDL report quantifies the pollutant levels, identifies pollution sources, and proposes ways to return water quality to an acceptable level. Required by the state Clean Water Legacy Act, a WRAPS is a document summarizing scientific studies of a major watershed no larger than a hydrologic unit code 8, including: the physical, chemical, and biological assessment of the water quality of the watershed; identification of impairments and water bodies in need of protection; identification of biotic stressors and sources of pollution, both point and nonpoint; TMDL for the impairments; and an implementation table containing strategies and actions designed to achieve and maintain water quality standards and goals. The WRAPS Report summarizes the monitoring, stressor identification, and TMDL work that has taken place in the watershed, as wells as identifies the strategies necessary to restore and protect the Hawk Creek Watershed. The WRAPS report identifies impaired water bodies and those in need of protection, and identifies the actions needed to achieve and maintain water quality - for example, planting buffers along shore land, stabilized stream banks, and stormwater-control projects will help improve water quality. Agricultural practices called for include greater use of cover crops, minimum or no tillage, temporary storage of water, and greater crop diversity.

Following the comments, the MPCA will revise the draft WRAPS Report and submit it to the MPCA Commissioner for approval. Comments must be received by the MPCA contact person by the public comment period end date shown above.

It should be noted that the science, analysis and strategy development described in this Report began before the accountability provisions were added to the Clean Water Legacy Act in 2013 (MS114D); thus, this Report does not address all of those provisions. At the time when this watershed is revisited (according to the 10-year cycle), the information will be updated according to the statutorily required elements of a Watershed Restoration and Protection Strategy Report.

- 2. A statement of the issues proposed to be addressed by a contested case hearing and the specific relief requested or resolution of the matter.

In addition and to the extent known, a petition for a contested case hearing should also include the following information:

- 1. A proposed list of prospective witnesses to be called, including experts, with a brief description of proposed testimony or summary of evidence to be presented at a contested case hearing;
  - 2. A proposed list of publications, references, or studies to be introduced and relied upon at a contested case hearing; and
  - 3. An estimate of time required for you to present the matter at a contested case hearing.

**MPCA Decision:** The written comments, requests, and petitions submitted on or before the last day of the public comment period will be considered in the final decision on this TMDL Report.
