Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Department of Employment and Economic Development (DEED) Notice of Public Hearing by the Minnesota Department of Employment and Economic Development with Respect to a Proposed Project and the Provision of Funds from the Minnesota Job Creation Fund Program under Minnesota Statutes 116J.8748

NOTICE IS HEREBY GIVEN that the Minnesota Department of Employment and Economic Development (“DEED”) will conduct a public hearing on **Friday, March 2, 2018 at 1:00 p.m.**, or as soon thereafter as reasonably possible at 332 Minnesota Street, Suite E200, in Saint Paul, Minnesota, on a proposal to provide funding through the Minnesota Job Creation Fund Program pursuant to authority granted under *Minnesota Statutes* 116J.8748 and *Minnesota Rules* Chapter 4301. This hearing is conducted in accordance with *Minnesota Statutes* 116J.994, Subd. 5.

Description of Project and Proposed JCF Funding:

Proto Labs Inc. may expand in Brooklyn Park (Hennepin County), Minnesota. The company manufactures custom prototypes and immediate production parts using several techniques, including 3D printing, CNC machining and injection molding. The company is publicly traded and based in Maple Plain, MN. The company is proposing to purchase a 152,000 square foot building in Brooklyn Park and add 50,000 square feet to that facility. They would relocate their CNC machining, including 225 employees, from Plymouth to Brooklyn Park, enabling injection molding growth in Plymouth and CNC growth in Brooklyn Park. The total project cost is \$29,850,000, of which \$12,000,000 would be eligible for the capital investment rebate as site improvements, new construction and renovation of an existing building. The company expects to create 139 jobs within three (3) years at an average cash wage of \$16.68 per hour. The company is requesting local assistance from the city for the cost of constructing a storm water retention pond, as well as an infrastructure grant from Hennepin County. Amounts of this potential local assistance are currently unknown. The project is eligible for a job creation award of up to \$350,000 and a capital investment rebate of up to \$500,000.

Public Notice Regarding Changes to Payment Rates and Methodologies, and Services under the Medical Assistance (MA) Program

This notice is published pursuant to Code of Federal Regulations, title 42, part 447, section 205 (42 C.F.R. § 447.205), which requires publication of a notice when there is any significant proposed change in the methods and standards for setting payment rates for Medicaid services. These changes result from legislation enacted by the 2017 Legislature.

Official Notices

Effective for services provided on or after March 1, 2018, the Department shall pay for post-arrest, community-based service coordination at the lesser of the provider's submitted charge, or \$9.54 per 15-minute unit. This change is estimated to result in a net spending increase of \$92,000 in the MA program in state fiscal year 2018.

Effective for services provided on or after July 1, 2018, the Department shall pay for peer recovery-support services provided by a recovery peer to treat substance use disorder, at the lesser of the provider's charge, or \$15.02 per 15-minute unit. This change is estimated to result in a net spending increase of \$375,000 in the MA program in state fiscal year 2019.

Effective for services provided on or after July 1, 2018, the Department shall pay for care-coordination services provided by a care coordinator to treat substance use disorder, at the lesser of the provider's charge, or \$11.71 per 15-minute unit. This change is estimated to result in a net spending increase of \$294,000 in the MA program in state fiscal year 2019.

Effective for services provided on or after July 1, 2018, the Department shall pay for a comprehensive assessment used to determine the need for services to treat substance use disorder, at the lesser of the provider's charge, or \$162.24 per session. This change is estimated to result in a net savings of \$2,097,576 in the MA program in state fiscal year 2019.

Minnesota Pollution Control Agency (MPCA) Request for Comments on Planned Rule Amendments Incorporating Federal Performance and Other Air Quality Standards, Minn. R. chs. 7002 to 7019; Revisor's ID Number R-04452

NOTICE IS HEREBY GIVEN that the Minnesota Pollution Control Agency (MPCA) is requesting comments from affected or interested parties on planned amendments to rules governing air quality. The planned amendments will primarily affect Minn. R. chs. 7007 and 7011, although miscellaneous rules in chapters 7002 to 7019 may also be amended to correct or clarify existing requirements. Comments must be submitted in writing according to the **Public Comment** section below.

Plain-Language Summary of the Request for Comments. This is the MPCA's legal notice of its intent to begin the rulemaking process to make specific amendments to rules governing air quality. This is the first opportunity for public comment and input on this rule project. At this stage, we do not have a draft rule; we want your feedback to inform us about the ideas described under the Subject of Rules section below. If you have comments or ideas about the revisions

being considered that we need to consider, please submit them in writing to the MPCA contact person listed below. Submitting your ideas and information at this early stage in rulemaking allows us more time to address issues, and helps to ensure informed decision-making.

Subject of Rules. The MPCA is considering making a number of changes necessary for the implementation of the federally delegated air quality program by incorporating by reference or clarifying requirements that are already in effect federally. The MPCA is also considering possible corrections to or clarification of existing state requirements. The changes under consideration include:

- Amending Chapter 7007 to provide an exemption from air quality permit requirements for residences that comply with the federal requirements for hydronic heaters and forced air furnaces.
- Amending Chapter 7011 to incorporate by reference New Source Performance Standards (NSPS) for:
 - Residential Hydronic Heaters and Forced-Air Furnaces (40 CFR part 60, subp. QQQQ)
 - Crude oil and natural gas production (40 CFR part 60, subp. OOOO and 40 CFR part 60, subp. OOOOa)
- Amending Chapter 7011 to incorporate specific elements of the Emission Guidelines and Compliance Times for Municipal Solid Waste Landfills (40 CFR part 60, subp. Cf), NSPS for new landfills (40 CFR part 60, subp. XXX), and clarify how those requirements apply to existing and new facilities.
- Amending Chapter 7011 to incorporate by reference National Emission Standards for Hazardous Air Pollutants (NESHAP) for:
 - Closed vent systems, control devices, recovery devices, and routing to a fuel gas system or process (40 CFR part 63, subp. SS)
 - Equipment leaks-Control Level 1 (40 CFR part 63, subp. TT) and Control Level 2 (40 CFR part 63, subp. UU)
 - Storage vessels (tanks)-Control Level 2 (40 CFR part 63, subp. WW)
 - Ethylene manufacturing process units: heat exchange systems and waste operations (40 CFR part 63, subp. XX)
 - Hospital ethylene oxide sterilizers (40 CFR part 63, subp. WWWW)
 - Electric arc furnace steelmaking facilities (40 CFR part 63, subp. YYYYY)
 - Iron and steel foundries (40 CFR part 63, subp. ZZZZ)
 - Gasoline distribution bulk terminals, bulk plants, and pipeline facilities (40 CFR part 63, subp. BBBB)
 - Paint stripping and miscellaneous surface coating operations at area sources (40 CFR part 63, subp. HHH-HHH)
 - Flexible polyurethane foam production and fabrication area sources (40 CFR part 63, subp. OOOOO)
 - Lead acid battery manufacturing (40 CFR part 63, subp. PPPPP)
 - Wood preserving area sources (40 CFR part 63, subp. QQQQQ)
 - Clay ceramics manufacturing area sources (40 CFR part 63, subp. RRRRR)
 - Glass manufacturing area sources (40 CFR part 63, subp. SSSSS)
 - Secondary nonferrous metal processing area sources (40 CFR part 63, subp. TTTTT)
 - Chemical manufacturing area sources (40 CFR part 63, subp. VVVVV)

The MPCA has been delegated the authority to implement the Clean Air Act in Minnesota on behalf of the U.S. Environmental Protection Agency (EPA). With this delegation of authority, the MPCA is responsible for rule implementation, interpretation, and enforcement of adopted rules relating to air quality protection. In order to maintain a complete delegation and keep its program up to date, the MPCA is required to adopt the above listed federal NSPS and NESHAP into *Minnesota Rules* to have the effect of state law. Maintaining the MPCA's authority to implement Clean Air Act requirements provides clear delineation of responsibility and allows the MPCA to respond more quickly to non-compliance.

The MPCA may also propose other amendments to air quality protection rules to update or align with federal rulemaking, policy, or guidance revisions, or to clarify existing rules where such amendments would aid in implementation or enforcement.

Parties Affected. The primary effect of this rule change will be to the MPCA as the administrator of the Clean Air Act in Minnesota. The MPCA must adopt EPA's NSP and NESHAP into state rule to meet the EPA delegation requirements. The federal requirements for the above-listed NSP and NESHAP are already in effect for regulated entities and as a result, the regulatory requirements for these parties will not change. Incorporating the requirements by reference into the state rules will make regulated entities subject to state permitting and compliance activities instead of permitting and compliance activities implemented at the federal level.

Wood heater manufacturers and vendors may also be affected by the proposal to exempt installed wood heaters from permitting.

Statutory Authority. *Minnesota Statutes* § 116.07, subd. 4 authorizes the MPCA to adopt or amend rules for the prevention, abatement, or control of air pollution:

“Pursuant and subject to the provisions of chapter 14, and the provisions hereof, the Pollution Control Agency may adopt, amend and rescind rules and standards having the force of law relating to any purpose within the provisions of Laws 1967, chapter 882, for the prevention, abatement, or control of air pollution. Any such rule or standard may be of general application throughout the state, or may be limited as to times, places, circumstances, or conditions in order to make due allowance for variations therein. Without limitation, rules or standards may relate to sources or emissions of air contamination or air pollution, to the quality or composition of such emissions, or to the quality of or composition of the ambient air or outdoor atmosphere or to any other matter relevant to the prevention, abatement, or control of air pollution.”

Public Comment. Interested persons or groups may submit comments or information on these possible rules in writing until 4:30 p.m. on April 6, 2018. The MPCA will not publish a notice of intent to adopt the rules until at least 60 days have elapsed from the date of this request for comments.

The state rulemaking process requires agencies to seek and consider information on specific topics relating to

the rule amendments being considered. The MPCA requests that interested persons submit:

- Information regarding the possible economic effect of the possible rule amendments.
- Information pertaining to the cumulative effect of the possible rule amendments. *Cumulative effect* means the impact that results from incremental effects of the proposed rule in addition to other rules, regardless of what state or federal agency has adopted the other rules.
- Information on the potential effect on local government ordinances or regulations as described in *Minnesota Statutes* § 14.128. The MPCA does not anticipate that the rule amendments will require a local government to adopt or amend an ordinance or other regulation. Local governments may submit written information to the contrary.
- Information related to necessary corrections or clarifications to any parts of the existing air quality rules.

Rule Drafts. The MPCA has not yet drafted the possible rule amendments. Written comments on the draft Reports must be sent to the MPCA contact person listed below by **March 22, 2018, by 4:30 p.m.** The comments should indicate as to whether they are about the WRAPS Report or the TMDLs, and specifically which TMDL. The MPCA will prepare responses to comments received and make any necessary revisions to the documents.

Required by the state Clean Water Legacy Act, a WRAPS Report is a document summarizing scientific studies of a major watershed no larger than a hydrologic unit code 8. The WRAPS Report includes the physical, chemical, and biological assessment of the water quality in the watershed; identification of impairments and water bodies needing protection; and identification of biotic stressors and sources of pollution, point and nonpoint. The science, analysis and strategy development described in this Report began before accountability provisions were added to the Clean Water Legacy Act in 2013 (MS114D); thus, this Report does not address all of those provisions. When this watershed is revisited (according to the 10-year cycle), the information will be updated according to the statutorily required elements of a WRAPS Report. TMDLs are explained for the impairments and an implementation table is included with the strategies to achieve and maintain water quality standards and goals.

The TMDL Report focuses on pollution caused by sediment, bacteria (*Escherichia coli*, or *E. coli*), nutrient levels, dissolved oxygen, and/or fish and invertebrate assemblages. The TMDL Report is a scientific study that calculates the maximum amount of a pollutant that a water body can receive (known as the "loading capacity") without exceeding water quality standards.

The St. Louis River Watershed (SLRW) is in northeastern Minnesota in the Lake Superior Basin and in the Northern Lakes and Forests ecoregion. The watershed covers portions of St. Louis, Carlton, Pine, Aitkin, and Itasca counties. This report addresses the portion of the watershed in Minnesota upstream of the Fond du Lac dam. The urban streams below the Fond du Lac dam in the urbanized Duluth area are being addressed as part of a separate effort, as is the Cloquet River. The Fond du Lac Band of Lake Superior Chippewa has federal Clean Water Act jurisdiction for waters of the reservation, which is located in the downstream portion of the SLRW. The Fond du Lac Band has established water quality standards for its waters, and implements a water quality monitoring, assessment, protection, and restoration program on the reservation. Waterbodies within the lands of the Fond du Lac Band are not addressed in this WRAPS report.

1. A statement of your interest in the draft SLRW WRAPS and TMDL;
2. A statement of the action you wish the MPCA to take, including specific references to sections of the draft documents that you believe should be changed; and
3. The reasons supporting your position, stated with sufficient specificity as to allow the Commissioner to investigate the merits of your position.

Petition for Public Informational Meeting: You also may request that the MPCA Commissioner hold a public informational meeting. A public informational meeting is an informal meeting that may be held to solicit public comment and statements on matters before the MPCA, and help clarify parts of the document and resolve issues. A petition requesting a public informational meeting must include the following information:

1. A statement identifying the matter of concern;
2. The information required under items 1 through 3 of “Written Comments,” identified above;
3. A statement of the reasons for holding a public informational meeting; and
4. The issues that you would like addressed at the public informational meeting.

Petition for Contested Case Hearing: You also may submit a petition for a contested case hearing. A contested case hearing is a formal hearing before an administrative law judge that provides evidence on issues requested to be changed. In accordance with Minn. R. 7000.1900, the MPCA will grant a petition to hold a contested case hearing if it finds that: (1) there is a material issue of fact in dispute concerning the draft WRAPS and TMDL Reports; (2) the MPCA has the jurisdiction to make a determination on the disputed material issue of fact; and (3) there is a reasonable basis underlying the disputed material issue of fact or facts such that the holding of the contested case hearing would allow the introduction of information that would aid the MPCA in resolving the disputed facts in making a final decision on the draft WRAPS and TMDL Reports. A material issue of fact means a fact question, as distinguished from a policy question, whose resolution could have a direct bearing on a final MPCA decision. A petition for a contested case hearing must include the following information:

1. A statement of reasons or proposed findings supporting the MPCA decision to hold a contested case hearing according to the criteria in Minn. R. 7000.1900, as discussed above; and
2. A statement of the issues proposed to be addressed by a contested case hearing and the specific relief requested or resolution of the matter.

In addition, and to the extent known, a petition for a contested case hearing should also include the following information:

1. A proposed list of prospective witnesses to be called, including experts, with a brief description of proposed testimony or summary of evidence to be presented at a contested case hearing;
2. A proposed list of publications, references, or studies to be introduced and relied upon at a contested case hearing; and
3. An estimate of time required for you to present the matter at a contested case hearing.

MPCA Decision: The written comments, requests, and petitions submitted on or before the last day of the public comment period will be considered in the final decision on these Reports. If the MPCA does not receive written comments, requests, or petitions during the public comment period, the MPCA staff as authorized by the Commissioner, will make the final decision on the draft Reports.
