Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Executive Orders

The governor has the authority to issue written statements or orders, called Executive Orders. as well as Emergency Executive Orders. The governor's authority is specified in the Constitution of the State of Minnesota, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

Office of the Governor

Executive Order 18-09: Amending Executive Order 18-08: Establishing the Governor's Task Force on Wild Rice

I, Mark Dayton, Governor of the State of Minnesota, by virtue of the authority vested in me by the Constitution and applicable statutes, do hereby issue this Executive Order:

Whereas, Executive Order 18-08 was filed on May 30, 2018, providing for the establishment of the Governor's Task Force on Wild Rice;

Whereas, to amend Executive Order 18-08 subsection 1 located on pages 1 and 2.

Now, Therefore, I hereby order that subsection 1 be amended to read as follows:

- 1. The Governor's Task Force on Wild Rice ("Wild Rice Task Force") is established with the following members to be appointed by the Governor:
 - a. one representative nominated by the Minnesota Chippewa Tribe;
 - b. one representative nominated by the four Minnesota Dakota Tribes, which include the Shakopee Mdewakanton Sioux Community, Prairie Island Indian Community, Lower Sioux Indian Community, and Upper Sioux Community;
 - c. one representative nominated by Red Lake Nation;
 - d. two independent scientists with expertise in wild rice research and plant-based aquatic toxicity;
 - e. one non-native wild rice harvester;
 - f. one representative from the ferrous mining industry;
 - g. one representative from the non-ferrous mining industry;
 - h. one representative from a municipal wastewater discharger;
 - i. one representative of an electric utility;
 - j. one representative of a statewide labor organization;
 - k. two representatives from environmental nongovernmental organization; and
 - l. one representative each from the Department of Natural Resources and the Minnesota Pollution Control Agency appointed by the commissioner of each entity to serve as an ex officio member.

This Executive Order is effective fifteen days after publication in the State Register and filing with the Secretary of State, and shall remain in effect until rescinded by proper authority or until it expires in accordance with Minnesota Statutes, Section 4.035, subdivision 3.

Emergency Executive Order 18-11: Declaring a State of Peacetime Emergency in the State of Minnesota

I, Mark Dayton, Governor of the State of Minnesota, by virtue of the authority vested in me by the Constitution and applicable statutes, do hereby issue this Executive Order:

Whereas, beginning on June 9, 2018 and continuing, a persistent weather pattern has repeatedly generated a series of severe summer storms producing torrential rains, flash flooding, high winds, and tornadoes across Minnesota;

Whereas, these storms have caused widespread damage to property and public infrastructure;

Whereas, the resources of local, county, and state governments are being fully utilized to ensure immediate response to protect the life and safety of persons in the affected areas, and to protect property and infrastructure from additional damage;

Whereas, the affected counties' emergency operations plans are activated, cities and counties have declared local emergencies, and local jurisdictions are requesting state assistances and resources; and

Whereas, the Department of Public Safety, Division of Homeland Security and Emergency Management activated the State Emergency Operations Center and implemented the Minnesota Emergency Operations Plan, and state agencies are providing assistance to local government.

Now, Therefore, I hereby order that:

- 1. A state of peacetime emergency pursuant to Minnesota Statutes, section 12.31 exists in the counties of Aitkin, Becker, Beltrami, Blue Earth, Brown, Carlton, Cass, Clearwater, Cottonwood, Faribault, Fillmore, Freeborn, Jackson, Kittson, Lake, Lyon, Mahnomen, Martin, Mille Lacs, Mower, Murray, Nicollet, Nobles, Pine, Pipestone, Polk, Red Lake, Redwood, Renville, Rock, Sibley, Stearns, Stevens, St. Louis, Waseca, and Watonwan and the Red Lake Nation.
- 2. The Department of Public Safety, Division of Homeland Security and Emergency Management continue coordinating the provision of on-site support and assistance to affected local governments, and determine the need for supplementary emergency assistance.
- 3. All state agencies, in cooperation with appropriate federal agencies, provide the assistance necessary to help local units of government respond to and recover from this emergency.

Pursuant to Minnesota Statutes, section 4.035, subdivision 2, this Emergency Executive Order is effective immediately and must be filed with the Secretary of State and published in the State Register as soon as possible after its issuance. This Emergency Executive Order can be extended by the Executive Council or the Legislature in accordance with Minnesota Statutes, section 12.31, subdivision 2.

NOTICE IS HEREBY GIVEN that the Minnesota Department of Employment and Economic Development ("DEED") will conduct a public hearing on Friday, July 20, 2018 at 1:00 p.m., or as soon thereafter as reasonably possible at 332 Minnesota Street, Suite E200, in Saint Paul, Minnesota, on a proposal to provide funding through the Minnesota Job Creation Fund Program pursuant to authority granted under Minnesota Statutes 116J.8748 and Minnesota Rules Chapter 4301. This hearing is conducted in accordance with *Minnesota Statutes* 116J.994, Subd. 5.

Description of Project and Proposed JCF Funding:

Graco Minnesota, Inc. is one of the world's premier manufacturers of fluid-handling equipment and systems. The company may expand its existing manufacturing facility in Rogers (Hennepin County) with approximately 330,000-square feet related to manufacturing operations and approximately 106,000-square feet for new office and lab areas. The total capital investment is \$73,665,000 with \$49,333,500 of it being eligible for the capital investment rebate. The company expects to create 84 jobs within 4 years at an average cash wage of \$21.16 per hour. There is additional local assistance in the form of a \$1,319,500 in TIF or waiving of some fees from the City of Rogers. Financial assistance from the Minnesota Investment Fund has also been requested. The project is eligible for a job creation award of up to \$300,000 and a capital investment rebate of up to \$500,000.

Environmental Analysis and Outcomes Division Public Notice on State Implementation Plan Revision

NOTICE IS HEREBY GIVEN that the Commissioner of the Minnesota Pollution Control Agency (MPCA) has determined that a State Implementation Plan (SIP) revision must be submitted to meet Minnesota's requirements under sections 110(a)(1), 110(a)(2), and 128 of the Clean Air Act (the Act). The draft SIP revision is now available for public comment.

Background. Sections 110(a)(1) and 110(a)(2) of the Act require that states prepare and submit to the U. S. Environmental Protection Agency (EPA) an "infrastructure" SIP within three years of the EPA's issuance of a new National Ambient Air Quality Standard (NAAQS) to demonstrate their continued ability to implement, maintain, and enforce the revised standards. This infrastructure SIP submission addresses the 2015 ozone NAAQS.

Official Notices

Purpose of the SIP revision. The purpose of this SIP revision is to fulfill Minnesota's responsibility under the Act to demonstrate its ability to implement, maintain, and enforce the revised ozone NAAQS cited above. This includes information about Minnesota's air quality programs such as monitoring, permitting, and modeling. Many of these requirements have already been submitted as part of the SIP.

The MPCA will consider changing the contents of the proposed SIP revision based on comments received during the comment period. Following the end of the comment period, the Commissioner will decide whether to submit the proposed SIP revision to the EPA.

Requirements: There are no statutes or rules requiring contracts to be advertised for any specific length of time, but the Materials Management Division strongly recommends meeting the following requirements: \$0 - \$5000 does not need to be advertised. Contact the Materials Management Division: (651) 296-2600 \$5,000 - \$25,000 should be advertised in the *State Register* for a period of at least seven calendar days; \$25,000 - \$50,000 should be advertised in the *State Register* for a period of at least 14 calendar days; and anything above \$50,000 should be advertised in the *State Register* for a minimum of at least 21 calendar days.
