Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Executive Orders

The governor has the authority to issue written statements or orders, called Executive Orders. as well as Emergency Executive Orders. The governor's authority is specified in the Constitution of the State of Minnesota, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

Office of the Governor

Emergency Executive Order 19-04: Declaring an Emergency and Providing for Relief from Regulations to Motor Carriers and Drivers Operating in the State of Minnesota

I, **Tim Walz**, **Governor of the State of Minnesota**, by the authority vested in me by the Constitution and applicable statutes, issue the following Executive Order:

Due to the extreme cold during the months of January and February, propane and heating fuels are in high demand, and the supply of propane and other fuels in Minnesota is extremely low.

During the winter months, approximately 95% of the propane sold in Minnesota comes from North Dakota and Canada. The weather in North Dakota and Canada has caused processing slowdowns at production and supply points, reducing the amount of propane being delivered by rail to Minnesota. The Governor of North Dakota has declared an emergency due to extremely low inventories of propane and other fuels resulting from severe weather conditions and increased heating fuel demands.

Drivers and transporters are having to travel further distances to acquire product due to both the recent heavy snowfall in the region, which has delayed rail deliveries to many markets, and localized terminal shortages of propane and other fuels.

The weather forecast calls for additional snowfall and below-zero temperatures, which will add stress to the problem.

For these reasons, I order that:

1. A state of emergency exists in Minnesota that requires relief from regulations incorporated in Minnesota Statutes 2018, section 221.0314, subdivision 9, pertaining to hours of service for carriers and drivers of commercial motor vehicles obtaining and delivering propane, diesel fuel, gasoline, or fuel oil and providing direct assistance in emergency relief efforts.

2. Motor carriers and drivers transporting propane, diesel fuel, gasoline, or fuel oil to the affected areas of the state and providing direct assistance for emergency relief efforts are exempted from paragraphs (b), (c), and (d) under the Code of Federal Regulations, title 49, part 395.3, which are incorporated in Minnesota Statutes 2018, section 221.0314, subdivision 9, pertaining to hours of service.

3. This Executive Order does not relieve motor carriers and drivers transporting propane, diesel fuel, gasoline, or fuel oil and providing direct assistance for emergency relief efforts from the requirements under paragraph (a) of the Code of Federal Regulations, title 49, part 395.3 which states, in part, a driver may drive only 11 hours during a period of 14 consecutive hours after coming on duty following 10 consecutive hours off duty.

4. Nothing in this Executive Order relieves motor carriers and drivers transporting propane, diesel fuel, gasoline or fuel oil and providing direct assistance for emergency relief efforts from regulations pertaining to driver qualifications; driving of commercial motor vehicles; commercial drivers' licenses; drug and alcohol testing for drivers; or equipment,

parts, and accessories necessary for the safe operation of vehicles.

5. No motor carrier operating under the terms of this Executive Order shall require or allow a fatigued or ill driver to operate a commercial motor vehicle. A driver who informs a carrier that he or she needs immediate rest shall be given at least ten consecutive hours off duty before the driver is required to return to service.

6. Upon the expiration date of this Executive Order, or when a driver or carrier has been relieved of all duty and responsibility to provide direct assistance to the emergency effort, a driver that has had at least 34 consecutive hours off-duty shall be permitted to start his or her on-duty status hours and 60/70-hour clock at zero.

This Executive Order is effective immediately under Minnesota Statutes 2018, section 4.035, subdivision 2. Emergency relief from regulations for motor carriers and drivers transporting propane, diesel fuel, gasoline or fuel oil to affected areas of the state remains in effect for 15 days from the date of this Executive Order, or until the motor carrier or driver stops providing direct assistance, whichever occurs first. For purposes of this Executive Order, direct assistance is defined in Minnesota Statutes 2018, section 221.0269, subdivision 3, paragraph (c).

Office of the Governor Emergency Executive Order 19-05: Declaring a Peacetime Emergency and Providing Assistance to Stranded Motorists

I, **Tim Walz**, **Governor of the State of Minnesota**, by the authority vested in me by the Constitution and applicable statutes, issue the following Executive Order:

On February 23, 2019 a powerful winter storm with heavy snowfall and strong winds has created blizzard conditions in Minnesota, closing roads and threatening public safety.

These dangerous driving conditions resulted in many stranded vehicles, placing lives and property at risk. The resources of affected local and county governments are inadequate to meet the demands caused by these severe winter weather conditions.

The Freeborn and Steele County Sheriffs requested that the Minnesota National Guard assist with the rescue of stranded motorists and provide local armories as emergency shelters.

For these reasons, I declare a peacetime emergency and order that:

1. The Adjutant General order to state active duty on February 23, 2019 the people, equipment, and facilities needed to provide assistance throughout Minnesota.

2. The Adjutant General is authorized to procure the goods and services needed to accomplish the mission.

3. The costs of this assistance shall be paid from the general fund as allowed by Minnesota Statutes 2018, section 192.52.

Executive Orders

This Executive Order and declaration of peacetime emergency is effective immediately under Minnesota Statutes 2018, section 4.035, subdivision 2, and remains in effect until the emergency conditions caused by the winter storm subside or it expires in accordance with Minnesota Statutes 2018, section 12.31, subdivision 2.

REQUEST FOR COMMENTS for Possible Amendment to Rules Governing Cosmetology Licensing and Practice Requirements, *Minnesota Rules*, 2105 and 2110; Revisor's ID Number 4552

Subject of Rules. The Minnesota Board of Cosmetology requests comments on its possible amendments to rules governing licensing and practice requirements for cosmetologists, estheticians, advanced practice estheticians, nail technicians, eyelash technicians, salons, designated licensed salon managers, and instructors. Specifically, the board is considering possible changes as described below:

- Elimination of dispensary requirements replaced by requirement for designated handwashing sink and disinfecting area (2105.0360);
- Removal of requirements for the storage of hazardous products (2105.0360);
- Alternatives to the current requirement for a handwashing sink in each work area such as requiring the continuous presence of hand sanitizer (2105.0360);
- Continued requirement for a sink in each suite of a suite style salon;
- Elimination or change in current work experience requirements for salon manager (2105.0145);
- Elimination or change in current licensure requirement for a high school diploma or equivalent (2105.0145);
- Changes to license cycle on renewals of expired licenses (2105.0215);
- Removal of course and test requirements for instructors applying for an instructor license in a second field (2105.0145);
- Removal of outdated provisions for grandfathering (2105.0182, etc.);
- Clarification of current rule requirements related to posting inspection reports and posting licenses;
- Technical and editorial changes

In addition, the Board may consider other suggestions from commenters on these and other rules in Chapter 2105 as time allows.

Plain language summary. This request for comments is the Board's legal notice of its intent to begin rulemaking. This is the first of several opportunities for public comment and input on this rulemaking. At this stage, we want your feedback and suggestions for change about these and any other issues addressed in the rules on cosmetology. If you have other ideas related to this rulemaking that we need to consider, please submit them in writing. Submitting your ideas and information at this early stage in rulemaking allows us more time to address issues that may come up, and helps to ensure informed decision-making on our part.

Persons Affected. The amendment of the rules would likely affect all board licensees and applicants for licensure, including cosmetologists, estheticians, advanced practice estheticians, nail technicians, , instructors, designated licensed salon managers, and salons, schools, and students, as well as persons receiving cosmetic services from board licensees.

Statutory Authority. The Board's statutory authority is contained in:

Minnesota Statutes, section 155A.26 authorizes the Board to develop and adopt rules that the Board considers necessary to carry out sections 155A.21 through 155A.36.

Minnesota Statutes, 155A.27 Subd. 2 provides that qualifications for licensing in each classification shall be determined by the board and established by rule, and shall include educational and experiential prerequisites. The rules shall require a demonstrated knowledge of procedures necessary to protect the health of the practitioner and the consumer of cosmetology services, including but not limited to chemical applications.

Minnesota Statutes, 155A.29 Subd. 2 provides that the conditions and process by which a salon is licensed shall be established by the board by rule.

Minnesota Statutes, 155A.29 Subd. 3 provides that Minimum infection control standards for the operation of a salon shall be established by rule.

Public Comment. Interested persons or groups may submit comments or information on these possible rules in writing until 4:30 p.m. on Monday, April 8, 2019. The Board will not publish a notice of intent to adopt the rules until more than 60 days have elapsed from the date of this request for comments. The Board does not plan to appoint an advisory committee to comment on the possible rules.

Rules Drafts. The Board does not anticipate that a draft of the rules amendments will be available before the publication of the proposed rules.

The Minnesota Pollution Control Agency (MPCA) is requesting comments on the proposed site-specific (SSS) selenium water quality standard for the lower Minnesota River and associated floodplain lakes in Hennepin and Dakota counties. For more information about the site-specific standard, see *https://www.pca.state.mn.us/water/site-specific-water-quality-standards*.

Background

The MPCA designates beneficial uses for all waters of the state (as defined in *Minn. Stat. § 115.01*, subd. 22) and develops water quality standards to protect those uses. Most streams, rivers, drainage ways, lakes, ponds, wetlands, etc. in Minnesota are designated Class 2. Class 2 protects: 1) the ability to swim in and boat on the water (recreation); and 2) the organisms that live in or on the water or aquatic substrates as well as the organisms that depend on aquatic habitats to fulfill any part of their life cycle (aquatic life). The proposed change to the selenium standard is for the Class 2 standard.

The current Class 2 selenium standard applied state-wide is 5 μ g/L total selenium, as a one-day average (chronic standard), and 20 μ g/L total selenium, as a four-day average (maximum standard). This standard is over 30 years old, and much has been learned about selenium toxicity since the U.S. Environmental Protection Agency (EPA) developed this criterion in 1987.

Excess selenium can harm the aquatic life use by accumulating up the food chain and into fish tissue, which results in reproductive effects. The EPA studied the effects of selenium on aquatic organisms, and published an updated water quality criterion for selenium in 2016. The new science and criterion show that the most harmful effect of selenium on aquatic organisms is due to its bioaccumulative properties. These longer-term effects are observed at lower concentrations than acute (short-term) effects.

Accumulation of selenium occurs primarily through the diet of aquatic organisms, rather than through exposure to selenium in the water. Selenium that accumulates in the organism can be transferred to the eggs, causing reproductive effects. EPA's document also points out that the accumulation of selenium varies on a site-specific basis. This updated information is not included in Minnesota's current state-wide standard for selenium, which was based on EPA's 1987 criteria guidance and adopted in Minnesota Rule in 1990. The state's existing selenium standard can be found in *Minn. R.* 7050.0222.

As acknowledged by the EPA, site-specific data can show that different standards are appropriate to protect aquatic life and recreation in a specific water body. In these cases, the MPCA can modify existing standards with a

site-specific standard approved by the EPA. Such a modification requires public notice, a public meeting and the opportunity for comment.

Minnesota River site

The Minnesota River runs 320 miles east across southern Minnesota until it flows into the Mississippi River. The upper 80 miles of the river are periodically dammed and the lower 240 miles are free-flowing through a highly developed (agriculture and residential) watershed.

A lead-acid battery recycler, Gopher Resource, LLC (Gopher) discharges effluent containing selenium to the Seneca wastewater treatment plant (WWTP), which ultimately discharges treated wastewater that contains selenium to the lower Minnesota River. Gopher collected water column and fish tissue data from the site to utilize in the development of an updated site-specific standard that takes into consideration the additional knowledge about selenium toxicity.

The extent of the site-specific standard is a six-mile reach that runs from the Seneca WWTP effluent outfall on the Minnesota River (AUID 07020012-505) in Dakota County to the confluence with the Mississippi River (AUID 07010206-505). The standard also applies to the two connected floodplain lakes (Long Meadow Lake and Gun Club Lake) and oxbow habitats since these still-water systems are connected to the Minnesota River at high flows when the floodplain is flooded.

Proposed site-specific standard

The proposed standard (see table below) contains the fish tissue concentrations from EPA's 2016 criterion, given as egg/ovary, whole body, and muscle tissue. Additionally, two water column values that are protective of the tissue concentrations in two habitat types were developed, based on site-specific conditions, using the methodology outlined in EPA's 2016 criterion guidance.

Selenium generally accumulates to a greater degree in still water than in flowing water. Therefore, a water column value that protects the main channel was developed separately from the value that protects the oxbow and floodplain lakes areas, where fish tissue concentrations were higher. To assess compliance with these criteria, fish tissue or water column data can be collected, but the fish tissue data will supersede any water column data.

1. Fish tissue elements are expressed as steady-state.

2. Egg/ovary supersedes any whole-body, muscle, or water column element when fish egg/ovary concentrations are measured.

3. Fish whole-body or muscle tissue supersedes water column element when both fish tissue and water concentrations are measured.

4. Water column values are based on total selenium in water and are derived from fish tissue values via bioaccumulation modeling. Water column

values are the applicable criterion element in the absence of steady-state condition fish tissue data.

5. Fish tissue data provide instantaneous point measurements that reflect integrative accumulation of selenium over time and space in fish population(s) at a given site.

6. The bioaccumulation of selenium into fish tissue occurs over a longer time period than with typical acute or chronic toxic effects to aquatic life. Therefore, a longer duration for the averaging period is appropriate for the selenium SSS. Additionally, because of this longer averaging period, the minimum stream flow (see *Minn. R. 7053.0205*, subp. 7) for which wastes must be controlled to meet the SSS will be the 30Q, flow.

Basis and rationale for site-specific standard

The Clean Water Act, federal regulations, Minnesota's State Water Pollution Control Act (*Minn. Stat. Ch. 115*) and Minnesota's Rules establish opportunities to use site-specific approaches. Site-specific options allow the MPCA to consider data on local characteristics to apply more precise numeric standards to protect the beneficial uses of an individual water body.

Minnesota Rule chapter 7050 provides water quality standards for waters of the state as well as the legal basis for consideration and adoption of site-specific water quality standards (*Minn. R. 7050.0220*, subp. 7).

The MPCA considered the following in developing the SSS:

- The current selenium standard found in *Minn. R. 7050.0222* is based on outdated science. Effects of selenium on fish have been demonstrated to be caused by its bioaccumulative properties, with toxicity primarily occurring as reproductive effects, after transfer of selenium to offspring in the eggs. The 2016 EPA criteria document uses the more recent information about selenium toxicity to develop criteria values for selenium concentrations in fish tissue, as well as a translation into a water column criterion. The document also outlines methods for developing site-specific water column standards for selenium.
- The tissue criterion elements outlined in EPA's 2016 criteria document are appropriate for Minnesota, as the values are based on fish species found in the state.
- Where site-specific data are available, translating the fish tissue values into a protective water column value can protect the aquatic life designated use at the site. Considerable data were collected to develop the SSS, and the data were used to derive a water column value for the site using EPA's updated methods.
- The Minnesota River site consists of flowing and still-water habitats. These two types of habitats can result in differing amounts of selenium accumulation into fish tissue. Therefore, water column values that are protective of the different habitat types were developed.

TMDLs are explained for the impairments and an implementation table is included with the strategies to achieve and maintain water quality standards and goals. Key strategies include erosion control, water storage, nutrient management and expanded use of cover crops.

The TMDL Report focuses on pollution caused by excess bacteria and associated pathogens, sediment, and excess nutrients/lake eutrophication. The TMDL Report is a scientific study that calculates the maximum amount of a pollutant that a water body can receive (known as the "loading capacity") without exceeding water quality standards.

The Cedar River Watershed is located in Mower, Freeborn, Dodge and Steele counties in Southern Minnesota. The Cedar River Watershed (in Minnesota) includes about 54 miles of the Cedar River, with a contributing watershed of 592 square miles. The Cedar River in Minnesota flows into Iowa, and is part of the overall Cedar River Basin which is 7,485 square miles in size.
