# Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and with-drawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. # **Adopted Rules**

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

**KEY: Proposed Rules** - <u>Underlining</u> indicates additions to existing rule language. <del>Strikeouts</del> indicate deletions from existing rule language. If a proposed rule is totally new, it is designated "all new material." **Adopted Rules** - <u>Underlining</u> indicates additions to proposed rule language. Strikeout indicates deletions from proposed rule language.

### **Pollution Control Agency** Adopted Permanent Rules Relating to Underground Storage Tanks

The rules proposed and published at State Register, Volume 43, Number 9, pages 212-261, August 27, 2018 (43 SR 212), are adopted with the following modifications:

#### 7150.0030 DEFINITIONS.

Subp. 51a. Unusual operating condition. "Unusual operating condition" means:

- A. a condition, equipment deficiency, or occurrence that: results in a release of a regulated substance;
  - (1) results in a release of a regulated substance;
  - (2) indicates the possibility of a leak from a UST system;
  - (3) creates a reasonable expectation that a leak from a UST system is probable; or
  - (4) may cause an undetected leak;
- B. an unexplained presence of water in the tank; or
- C. liquid in the interstitial space of secondary-containment systems-;
- D. erratic behavior of product dispensing equipment;
- E. a sudden loss of product from the UST system; or
- F. monitoring results that indicate the possibility of a leak from a UST system.

#### 7150.0205 DESIGN AND CONSTRUCTION.

#### Subp. 6. Submersible pump sumps.

B. Any submersible pump installed before December 22, 2007, and not in a secondarily contained sump used for interstitial monitoring must be accessible for visual inspection and must not be covered by soil, water, or other obstacles that prevent visual inspections.

# **Adopted Rules**

E<u>B</u>. The following codes of practice are incorporated by reference under part 7150.0500 and must be used to meet the requirements of this subpart, as applicable:

#### Subp. 7. Dispenser sumps.

A. Owners and operators must install secondary containment under a dispenser if:

(4) the concrete or base material under the dispenser is replaced, repaired, or modified.

Subp. 8. **Emergency stops.** Owners and operators must have an emergency disconnect switch that <u>complies with the</u> <u>Minnesota State Fire Code and</u> is readily available to persons dispensing a regulated substance <u>so as</u> to disconnect electric power to pumps and dispensers<del>, in accordance with the Minnesota State Fire Code</del>, in the event of an emergency. For purposes of this subpart, "readily available" means that an emergency disconnect switch is located within 100 feet of, but not less than 20 feet from, an exterior dispenser, and, for interior dispensers, the emergency disconnect switch is installed at a location approved by the local fire chief or the chief's designee.

#### 7150.0216 OPERATING, MAINTAINING, AND TESTING UST SYSTEMS.

Subpart 1. General.

A. Owners and operators must maintain, test, operate, and inspect tanks, piping, and associated components of a UST system as described in this part and in accordance with one of the following methods:

(1) the requirements of the manufacturer;

(2) the following codes of practice developed by a nationally recognized association and incorporated by reference under part 7150.0500: the practices incorporated by reference in part 7150.0500, subpart 2, item G, subitems (2) and (4); or

(a) Petroleum Equipment Institute, Recommended Practices for the Testing and Verification of Spill, Overfill, Leak Detection and Secondary Containment Equipment at UST Facilities, PEI/RP1200; and

(b) Petroleum Equipment Institute, Recommended Practices for the Inspection and Maintenance of UST-Systems, PEI/RP900; or

#### Subp. 3. Release-detection equipment.

C. As applicable to the facility, testing under this subpart must, at a minimum, include the following components and criteria:

(1) for automatic tank gauges and other controllers, <u>the tester must</u> test alarms, verify system configuration, and test battery backup.

(2) for probes and sensors, <u>the tester must</u> inspect for residual buildup, ensure floats move freely, ensure the shaft is not damaged, ensure cables are free of kinks and breaks, and test alarm operability and communication with controller;

(3) for automatic line-leak detectors, <u>the tester must</u> test the operation to <u>meet ensure that it meets</u> the criteria under part 7150.0340, subpart 2, item D;

(4) for vacuum pumps and pressure gauges, <u>the tester must</u> ensure proper communication with sensors and controllers;

(5) for spill buckets and containment sumps, the tester must visually inspect spill buckets and containment

sumps used for interstitial monitoring, including seals at piping, electrical, and other penetration points, for deficiencies; and

(6) for handheld leak-detection materials, <u>the tester must</u>ensure that any measuring sticks, fuel-finding pastes, or other handheld items used for leak detection are in a functional condition.

Subp. 5. **Overfill-prevention equipment.** Owners and operators must ensure overfill-prevention equipment is inspected at least every three years. The inspection must ensure that the overfill-prevention equipment is set to activate at the correct level, as specified in part 7150.0205, subpart 5, item A, subitem (2), and will activate when a regulated substance reaches that level. Beginning no later than October 13, 2020, inspections under this subpart must be performed by an agency-approved tester.

#### 7150.0250 RESTORATION, CORRECTIVE ACTIONS, AND REQUIRED PERMANENT CLOSURE.

#### Subp. 3. Replacement.

A. Components of a UST system that do not meet the performance standards in part 7150.0100 must be repaired or replaced. Owners and operators must replace:

(1) any component that has corrosion that may cause the component to not function as intended by the manufacturer or that may cause a release of a regulated substance; and

(2) any component not functioning properly according to this chapter.

#### 7150.0345 REPORTING, INVESTIGATING, AND CONFIRMING RELEASES.

#### Subpart 1. Investigating and confirming.

C. Within 24 hours of Upon discovering an unusual operating condition or confirming an unusual operating condition according to item B, subitem (2), the owners and operators must initiate within 24 hours and complete within seven days the following:

Subp. 2. **Reporting releases or suspected releases.** A person who has knowledge of a release from a UST system <u>under that person's control</u> must immediately notify the Minnesota duty officer upon discovering the release by calling 1-800-422-0798 and must begin recovering the substance according to Minnesota Statutes, section 115.061. Notice under this subpart is also required if:

#### 7150.0445 CLASS A, B, AND C OPERATOR REQUIREMENTS.

#### Subp. 5. Class A and B operator examinations.

B. A class B operator must retake the examination under item A within 30 days after a change in any of the following components of a UST system, <u>unless the class B operator has been previously certified in the newly installed</u> system component:

# **Executive Orders**

The governor has the authority to issue written statements or orders, called Executive Orders. as well as Emergency Executive Orders. The governor's authority is specified in the Constitution of the State of Minnesota, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

# **Office of the Governor** Emergency Executive Order 19-30: Declaring a State of Peacetime Emergency in the State of Minnesota

**I**, **Tim Walz**, **Governor of the State of Minnesota**, by the authority vested in me by the Constitution and applicable statutes, do hereby issue this Executive Order:

Beginning on March 12, 2019, rapid snowmelt floodwaters have inundated large portions of Minnesota, severely impacting communities across the state resulting in extensive damage to public infrastructure and private property.

On April 10, 2019, Winter Storm Wesley, with heavy snowfall and strong winds, created blizzard conditions in Minnesota, closing roads, damaging the electrical distribution system causing widespread power outages, and threatening public safety.

The resources of local, Tribal, county, and state government are being fully utilized to ensure immediate response to protect the life and safety of persons in the affected areas, and to protect property and infrastructure from additional damage.

The following Tribal Nations have been impacted: Prairie Island Indian Community, Red Lake Band of Chippewa, and Upper Sioux Community. As set forth in Minnesota Statutes 2018, section 12.31, subdivision 2, the State Director of Emergency Management has consulted with tribal authorities about this Executive Order.

The electrical distribution system (power grid) has been damaged in the counties of Blue Earth, Brown, Cottonwood, Dodge, Faribault, Freeborn, Houston, Jackson, Le Sueur, Lyon, Mower, Murray, Nobles, Olmsted, Pipestone, Rock, Sibley, Steele, Waseca, and Yellow Medicine.

The Federated Rural Electric Cooperative in Southern Minnesota has requested mutual aid assistance from the Iowa Association of Electric Cooperatives to assist in repair and restoration of the power grid.

The Marshall County Sheriff has requested the assistance of the Minnesota National Guard, for personnel to assist with over watch of the cities' dikes and flood protection systems and to potentially support rescue and evacuation operations within the community of Oslo, Minnesota.

The counties Freeborn, Marshall, Mower, and Steele have requested Minnesota National Guard assistance with the rescue of stranded motorists, community safety patrols, and to provide local armories as emergency shelters.

The affected counties' emergency operations plans are activated. Many Cities, Tribes, and counties have declared local emergencies, and local jurisdictions are requesting state assistance and resources.

The Department of Public Safety, Division of Homeland Security and Emergency Management (HSEM) activated the State Emergency Operations Center and implemented the Minnesota Emergency Operations Plan and state agencies are providing assistance to local governments.

# **Executive Orders**

For these reasons, I hereby order that:

1. A state of peacetime emergency pursuant to Minnesota Statutes 2018, section 12.31 exists in the impacted Tribal Nations of Prairie Island Indian Community, Red Lake Band of Chippewa, and Upper Sioux Community, as well as the counties of Anoka, Beltrami, Becker, Benton, Big Stone, Blue Earth, Brown, Carver, Cass, Chippewa, Chisago, Clay, Cottonwood, Dakota, Faribault, Fillmore, Freeborn, Goodhue, Grant, Hennepin, Houston, Isanti, Jackson, Kittson, Lac Qui Parle, Le Sueur, Lyon, Marshall, Martin, McLeod, Mille Lacs, Mower, Morrison, Murray, Nicollet, Nobles, Norman, Olmsted, Pennington, Pipestone, Polk, Ramsey, Red Lake, Redwood, Renville, Rock, Scott, Sherburne, Sibley, Stearns, Steele, Stevens, Swift, Todd, Traverse, Wabasha, Wadena, Waseca, Washington, Watonwan, Wilkin, Winona, Wright, Yellow Medicine.

2. The Adjutant General order to state active duty on April 11, 2019 in the service of the State, such personnel, equipment, and resources of the military forces needed to support emergency mitigation and response.

3. The Department of Public Safety, Division of Homeland Security and Emergency Management continue coordinating the provision of on-site support and assistance to affected local governments, and determine the need for supplementary emergency assistance.

4. All state agencies, in cooperation with appropriate federal agencies, provide the assistance necessary to help local units of government respond to and recover from this emergency.

This Executive Order is effective immediately. It remains in effect until emergency assistance and resources of the State are no longer required or it expires in accordance with Minnesota Statutes 2018, section 12.31, subdivision 2.

#### **Emergency Executive Order 19-31: Providing for Emergency Relief from Regulations to Motor Carriers Operating in Minnesota**

**I**, **Tim Walz**, **Governor of the State of Minnesota**, by the authority vested in me by the Constitution and applicable statutes, issue the following Executive Order:

Winter Storm Wesley brought heavy snowfall, strong winds and blizzard-like conditions to several states throughout the Plains and Upper Midwest regions. Much of Minnesota has been impacted by the storm; resulting in road closures and damage to the electrical distribution system causing widespread power outages.

The citizens of approximately 20 counties in Southern Minnesota are without power. The resources of the state are being fully utilized to respond to the emergency, to protect the health and safety of persons in the affected areas and to protect property and infrastructure from additional damage.

The Federated Rural Electric Cooperative in Southern Minnesota has requested mutual aid assistance from the Iowa Association of Electric Cooperatives to assist in repair and restoration of the power grid in the impacted counties.

# **Executive Orders** :

On April 11, 2019, Emergency Executive Order 19-30 was issued, declaring a Peacetime State of Emergency in Minnesota; requesting assistance from the Minnesota National Guard; activating the Department of Public Safety, Division of Homeland Security and Emergency Management's State Emergency Operations Center; and implementing the Minnesota Emergency Operations Plan.

For these reasons, I order that:

1. The requirements for interstate vehicle registration and reciprocity in Minnesota Statutes 2018, section 168.187, the fuel tax requirements in Minnesota Statutes 2018, chapter 168D, and the registration requirements in Minnesota Statutes 2018, section 221.60 are hereby suspended throughout the duration of a motor carrier's direct assistance to emergency relief efforts and until assisting carriers and vehicles have returned to their base state.

2. In accordance with the Code of Federal Regulations, title 49, part 390.23, the requirements contained in the Federal Motor Carrier Safety Regulations, title 49, parts 390-399 do not apply to those interstate carriers who are providing direct assistance for the immediate restoration of essential electrical power. The relief from the Code of Federal Regulations, title 49, parts 390-399 provided in this order is valid for the duration of a motor carrier's direct assistance to the emergency relief effort or the duration of this order, whichever is less.

3. Motor carriers and drivers providing direct assistance to the emergency relief effort and operating under the terms of this order must comply with the following Federal Motor Carrier Safety Regulations: title 49, part 392.2 related to the operation of a commercial motor vehicle in accordance with state laws and regulations, including compliance with applicable speed limits and other traffic restrictions; title 49, part 392.3 prohibiting an ill or fatigued driver from operating a commercial motor vehicle; and title 49, parts 392.4 and 392.5 prohibiting a driver from operating under the influence of a controlled substance or alcohol or operating while in possession of a controlled substance or alcohol.

4. Nothing contained in this Emergency Executive Order relieves drivers or carriers from the regulations and requirements pertaining to controlled substances and alcohol use and testing, commercial drivers' licenses, financial responsibility (insurance), transportation of hazardous materials, applicable size and weight limits, or any other portion of the regulations not specifically authorized pursuant to the Code of Federal Regulations, title 49, part 390.23.

This Executive Order is effective immediately under Minnesota Statutes 2018, section 4.035, subdivision 2. It will remain in effect for 30 days, or until the direct assistance has ended, whichever occurs earlier. For purposes of this Executive Order, direct assistance to an emergency relief effort terminates when a driver or commercial motor vehicle is used to transport cargo not destined for the emergency relief effort, or when the carrier dispatches that driver or vehicle to another location for operations in regular commerce.

**Requirements:** There are no statutes or rules requiring contracts to be advertised for any specific length of time, but the Materials Management Division strongly recommends meeting the following requirements: \$0 - \$5000 does not need to be advertised. Contact the Materials Management Division: (651) 296-2600 \$5,000 - \$25,000 should be advertised in the *State Register* for a period of at least seven calendar days; \$25,000 - \$50,000 should be advertised in the *State Register* for a period of at least 14 calendar days; and anything above \$50,000 should be advertised in the *State Register* for a minimum of at least 21 calendar days.
