Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Proposed Rules

Comments on Planned Rules or Rule Amendments. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

Rules to be Adopted After a Hearing. After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

Rules to be Adopted Without a Hearing. Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.1414.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Introduction. The Office of Administrative Hearings (Agency) intends to adopt rules without a public hearing following the procedures in the rules of the Office of Administrative Hearings, *Minnesota Rules*, parts 1400.2300 to 1400.2310, and the Administrative Procedure Act, *Minnesota Statutes*, sections 14.22 to 14.28. You may submit written comments on the proposed rules and may also submit a written request that a hearing be held on the rules until September 28, 2018.

Subject of the Rules and Statutory Authority. The proposed rules are about workers' compensation intervention practices. The rules allow counsel for the employee and/or employer/insurer to jointly file a partial stipulation. The statutory authority to adopt the rules is Minn. Stat. 176.83, subd. 12. A copy of the proposed rules is published in the State Register and attached to this notice as mailed. The proposed rules may be also viewed at *https://minnesotaoah.granicusideas.com/.*

Comments. You have until 4:30 p.m. on September 28, 2018, to submit written comment in support of or in opposition to the proposed rules and any part or subpart of the rules. Your comment must be in writing and received by the Agency contact person by the due date. The Agency encourages comment. Your comment should identify the portion of the proposed rules addressed and the reason for the comment. In addition, you are encouraged to propose any change desired. You must also make any comments that you have on the legality of the proposed rules during this comment period.

Request for a Hearing. In addition to submitting comments, you may also request that the Agency hold a hearing on the rules. Your request must be in writing and the Agency contact person must receive it by 4:30 p.m. on September 28, 2018. Your written request for a public hearing must include your name and address. You must identify the portion of the proposed rules that you object to or state that you oppose the entire set of rules. Any request that does not comply with these requirements is not valid and the Agency cannot count it when determining whether it must hold a public hearing. You are also encouraged to state the reason for the request and any changes you want made to the proposed rules.

Withdrawal of Requests. If 25 or more persons submit a valid written request for a hearing, the Agency will hold a public hearing unless a sufficient number withdraw their requests in writing. If enough requests for hearing are withdrawn to reduce the number below 25, the Agency must give written notice of this to all persons who requested a hearing, explain the actions the Agency took to effect the withdrawal, and ask for written comments on this action. If a public hearing is required, the Agency will follow the procedures in *Minnesota Statutes*, sections 14.131 to 14.20.

Alternative Format. Upon request, this information can be made available in an alternative format, such as large print, braille, or audio. To make such a request, please contact the Agency contact person at the address or telephone number listed above.

Modifications. The Agency may modify the proposed rules as a result of public comment. The modifications must be supported by comments and information submitted to the Agency, and the adopted rules may not be substantially different than these proposed rules, unless the Agency follows the procedure under Minnesota Rules, part 1400.2110. If the proposed rules affect you in any way, the Agency encourages you to participate in the rulemaking process.

Statement of Need and Reasonableness. The statement of need and reasonableness statement contains a summary of the justification for the proposed rules, including a description of who will be affected by the proposed rules and an estimate of the probable cost of the proposed rules. It is now available from the Agency contact person. You may review it or obtain copies for the cost of reproduction by contacting the Agency contact person.

Lobbyist Registration. *Minnesota Statutes*, chapter 10A, requires each lobbyist to register with the State Campaign Finance and Public Disclosure Board. You may direct questions regarding this requirement to the Campaign Finance and

Adoption and Review of Rules. If no hearing is required, the Agency may adopt the rules after the end of the comment period. The agency will then submit the rules and supporting documents to the Office of Administrative Hearings for review for legality. You may ask to be notified of the date the Agency submits the rules to the office. If you want to be so notified, or want to receive a copy of the adopted rules, or want to register with the Agency to receive notice of future rule proceedings, submit your request to the agency contact person listed above.

1420.1850 RESOLUTION OF CLAIMS WITH INTERVENORS; HEARINGS.

Subpart 1. Stipulations without agreement of all intervenors or potential intervenors. A stipulation for settlement that does not include the agreement of all intervenors or that seeks to preclude rights of potential intervenors must meet the requirements of this subpart.

[For text of item A, see M.R.]

B. Where other parties have reached an agreement to settle a claim but have been unable to reach agreement with an intervenor, or obtain the intervenor's signature on the stipulation, the requirements of subitem (1) or (2) must be met.

(1) If the stipulation is signed by the intervenor, the stipulation must include a statement that the parties negotiated with the intervenor in good faith but the intervenor chooses not to enter into an agreement and reserves the right to petition for hearing on the merits under subpart 3. By signing the stipulation in this manner, the intervenor is waiving the right to a Parker/Lindberg hearing under subpart 2, but not waiving the right to a hearing on the merits under subpart 3.

(2) If the stipulation, or a letter of agreement attached to the stipulation, is not signed by the intervenor, the stipulation must include a statement that the parties were unable to obtain a response from the intervenor despite good faith efforts, or were unable to reach agreement with the intervenor despite the belief that the parties negotiated with the intervenor in good faith and made a reasonable offer to settle the intervention claim. At the time the stipulation is filed for approval, a copy of the stipulation must be served on the intervenor. An affidavit of service of the stipulation must accompany the stipulation when it is filed for approval. the parties must file a partial stipulation for settlement that complies with Minnesota Statutes, section 176.521, subdivision 2b.

Subp. 2. [See repealer.]

Subp. 3. Intervenor hearing on the merits.

A. If the parties have not fully resolved the intervenor claim following the <u>procedures procedure</u> in <u>subparts</u> <u>subpart</u> 1 and 2 and there is no action pending at the office, a party must file a written petition under Minnesota Statutes, section 176.291, for a hearing on the merits of the intervening party's claim. The petition must be filed within 30 days after an award on stipulation is served and filed. If a petition is pending at the time an award on stipulation is served and filed under subpart 2, the office shall schedule the intervenor claims for a hearing on the merits for at least one-half day.

Minnesota Agricultural and Economic Development Board Notice of Public Hearing on Financing and Refinancing Projects and the Issuance of Private Activity Bonds to Finance and Refinance Health Care Facilities

NOTICE IS HEREBY GIVEN that the Minnesota Agricultural and Economic Development Board (the "Board") will meet on Friday, September 7, 2018, at 2:00 p.m., or as soon thereafter as reasonably possible, at 1st National Bank Building, 332 Minnesota Street, Suite E200, in St. Paul, Minnesota, for the purpose of conducting a public hearing on the proposal that the Duluth Economic Development Authority (the "Issuer") issue its revenue obligations, in one or more series, under Minnesota Statutes, Sections 469.152 through 469.1655, in order to undertake and finance the cost of a proposed project and refinance existing projects (together, the "Projects"). Each of the Projects are or will be owned and operated by Essentia Health, a Minnesota nonprofit corporation (the "Borrower"), or an affiliate thereof. The Borrower and each of its affiliates, including the affiliates listed below, are organizations described in, or treated as described in, Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

In conjunction with the refinanced projects, the Issuer has been requested by the Borrower to refund the following obligations: (a) the Board's \$42,635,000 Health Care Facilities Revenue Bonds, Series 2008E (Essentia Health Obligated Group) (the "2008E Bonds") which comprise a single issue for federal tax purposes with the Cass County, North Dakota \$63,700,000 Health Care Facilities Revenue Bonds, Series 2008D (Essentia Health Obligated Group) (the "2008D Bonds"), and (b) the Board's \$29,480,000 Health Care Facilities Revenue Bonds, Series 2014 (Essentia Health Obligated Group) (the "2014 Bonds"). The proposed project (the "2018 Project") consists of (i) acquiring land and constructing and equipping a new acute care hospital, clinic and outpatient surgery center; (ii) remodeling existing facilities of the Borrower and its affiliates; and (iii) demolishing obsolete facilities of the Borrower and its affiliates, the activities described in the foregoing clauses (i) through (iii) to be located within the Borrower's Medical Campus described below.

Background. Section 110(a) of the CAA requires that each state prepare and submit to the U.S. Environmental Protection Agency (EPA) SIPs to demonstrate that the state's air quality management program has the structural components in place to meet the state's responsibilities under the CAA to attain and maintain the National Ambient Air Quality Standards. Minnesota first submitted state rules and statutes to the EPA after the original promulgation of the CAA. Those rules were codified in the Code of Federal Regulations (CFR) at Title 40 Section 52.1220, which makes them federally enforceable as required by federal law. When state rules and statutes are updated by MPCA, the agency is expected to provide EPA with the edited rules and statutes for review and approval into the SIP, and subsequent re-codification into the federal code at § 52.1220.

Purpose of the SIP revision. The purpose of this SIP revision is to fulfill Minnesota's responsibility under the CAA to demonstrate our ability to implement, maintain, and enforce our air quality management program. This includes information about Minnesota's air quality programs such as monitoring, permitting, and modeling.

When states update the rules and statutes that are part of their SIP, they must submit those updates to EPA for review and approval into the SIP. Minnesota first submitted state rules and statutes to the EPA after the original promulgation of the CAA, and has since periodically submitted new and updated rules and statutes to EPA to ensure the state rules and statutes codified in the CFR align with current state rules and statutes and to demonstrate Minnesota's continued compliance with the requirements of Section 110(a) of the CAA. In recent years, Minnesota has undertaken various state-level rule revisions to modernize and streamline our air quality management program, to align with federal regulations, and to clarify rule language. This proposed SIP revision is being submitted to align the CFR with state rules and statutes and to ensure consistent enforceability at the state and federal levels.
