# Minnesota Rules: Amendments and Additions

## NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). A subject matter index is updated weekly and is available upon request from the editor. ## Expedited Emergency Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

### Adopted Expedited Emergency Game and Fish Rules: Special Hunts for Managing Chronic Wasting Disease in Deer

**Notice is hereby given** that, pursuant to the Commissioner's authority set forth in Minn. Stat. § 84.027, subdivision 13(b) to set hunting seasons and Minn. Stat. § 97A.045, subd. 11 to take action necessary to prevent or control wildlife disease, the Commissioner is adopting the following rule to prevent the spread of chronic wasting disease (CWD) among the deer population in and around Fillmore and Houston counties. This rule is adopted as an emergency rule pursuant to the authority granted to the commissioner to adopt emergency rules in Minn. Stat. § 97A.045, subds. 2(b), 11. The emergency rule is necessitated by the presence of CWD in wild deer harvested during the 2019 regular deer hunting seasons. Because of potential damage that CWD could do to the wild deer population in the time it would take to use the Chapter 14 rulemaking process to adopt this rule, the DNR is using its emergency rulemaking authority pursuant to Minn. Stat. § 97A.045, et. seq.

CWD has been detected in deer permit areas 604, 643, 646, 647 and 648. Because CWD infectious agents are extremely resistant in the environment, transmission may be both direct and indirect. Concentration of deer in certain areas likely increases the risk of transmission between individuals. Reducing the number of deer reduces the risk of transmission between individuals and likely removes some of the infected deer.

Therefore, the DNR will hold special hunts in deer permit areas where the disease has been classified as a persistent infection in accordance with Chronic Wasting Disease Response Plan. These include permit areas 643, 646, 647, and 648. All hunters will be required to present deer taken during these special hunts to the DNR for testing. By testing harvested deer, the DNR is able to track the spread of the disease and determine whether the risk to the wild deer herd is increasing and whether further action may be necessary.

To provide as much hunter access to the as possible, the DNR is opening two state parks and three Scientific Natural Areas (SNAs) that are within the hunt area, but are not normally open to hunting. The agency is impartially limiting the number of hunters in Great River Bluffs State Park, Forestville Mystery Cave State Park, Pin Oak Prairie SNA and King's and Queen's Bluffs SNAs to prevent hunter overcrowding by requiring a free Disease Hunt Surplus permit that will be available by telephone, online and at license vendors throughout the state on a first-come, first-served basis.

The number of hunters who will be allowed in these areas will be consistent with past special hunts held to reduce deer numbers for resource management. The DNR is also opening to all hunters Cherry Grove Blind Valley SNA and Rushford Sand Barrens SNA. By opening these areas to hunting, the DNR is providing as much hunter access as possible to lower overall deer numbers and deer density. This increases the likelihood of achieving the overall goal of reducing the risk of CWD transmission between deer and removing as many potentially CWD positive deer as possible.

Because the hunts occur at a time of year when public use and agency operations on the SNAs are minimized, they will not interfere with the normal function of the SNAs. Hunters must be qualified for these hunts by being legally eligible to purchase a deer hunting license and must meet any firearms safety requirements.

### **Subp. 10. Deer taken during disease management hunts.**

A. Deer taken during the disease management hunts described in part 6232.1600, subpart 8, must be presented for testing for chronic wasting disease at a department testing station within 24 hours of being harvested or no later than 10:00 a.m. the Monday after the hunt ends, whichever is sooner.

B. Except as specified in item C, carcasses from deer taken during the disease management hunts described in part 6232.1600, subpart 8, must remain in the chronic wasting disease persistent infection area described in part 6232.0400, subpart 9, as published in the State Register, volume 44, page 279, unless tagged by an authorized department representative or until results of a test for chronic wasting disease show the disease has not been detected in the harvested deer.

C. Cut and wrapped meat, quarters, or other portions of meat from a deer taken during the disease management hunts may be transported outside the hunt areas described in part 6232.1600, subpart 8, if no part of the spinal column or head is attached. Antlers, hides, teeth, finished taxidermy mounts, and antlers attached to skull caps that are cleaned of all brain tissue may be transported outside the hunt areas described in part 6232.1600, subpart 8.

### **Subp. 8. Disease management hunts.**

A. Except as specified in items C to I, the following areas are open December 20 through December 22, 2019, and December 27 through December 29, 2019, for taking an unlimited number of either-sex deer by firearms, muzzle-loader, and archery:

(1) deer permit areas 643, 646, 647, and 648, as described in part 6232.4700, subparts 99, 100, 101, and 164, published in the State Register, volume 44, page 279;

(2) portions of Cherry Grove Blind Valley Scientific and Natural Area in deer permit area 647; and

(3) portions of Rushford Sand Barrens Scientific and Natural Area in deer permit area 648.

B. To participate in the hunt authorized in item A, hunters must purchase a disease management permit according to part 6232.1980 or possess a 2019 Minnesota landowner license, youth or adult firearm license, youth or adult muzzle-loader license, youth or adult archery license, or early-season antlerless license. During the hunt authorized in item A:

(1) hunters may tag deer of either sex with disease management tags or unused tags from a 2019 landowner license, youth or adult firearm license, youth or adult muzzleloader license, or youth or adult archery license;

(2) only antlerless deer may be tagged with bonus tags or early-season antlerless tags; and

(3) firearm hunters in deer permit areas 643, 646, 647, and 648 may use only legal shotguns loaded with single-slug shotgun shells, legal muzzle-loading long guns, legal handguns, or legal crossbows for taking deer.

C. To participate in the special hunts authorized in items D to I, hunters must obtain a free disease-hunt surplus permit from an electronic license system agent, the Department of Natural Resources License Center, or other authorized agents. Permits are available on a first-come, first-served basis. Hunt participants must stay within any boundaries that are posted, that are prescribed by the hunt administrator, or that are depicted on maps provided by the hunt administrator. Hunters may select only one hunt from the special hunts described in items D to I. During the special hunts authorized in items D to I:

(1) hunters may tag deer of either sex with disease management tags or unused tags from a 2019 landowner license, youth or adult firearm license, or youth or adult muzzleloader license;

(2) only antlerless deer may be tagged with bonus tags or early-season antlerless tags; and

(3) firearm hunters may use only legal shotguns loaded with single-slug shotgun shells, legal muzzle-loading long guns, legal handguns, or legal crossbows for taking deer.

D. Portions of Forestville Mystery Cave State Park in Fillmore County are open December 20 through December 22, 2019, for taking an unlimited number of either-sex deer by firearms. This is special hunt 801.

E. Portions of Forestville Mystery Cave State Park in Fillmore County are open December 27 through December 29, 2019, for taking an unlimited number of either-sex deer by firearms. This is special hunt 802.

F. Portions of Pin Oak Prairie Scientific and Natural Area in Fillmore County are open December 20 through December 22, 2019, for taking an unlimited number of either-sex deer by firearms. This is special hunt 803.

G. Portions of Pin Oak Prairie Scientific and Natural Area in Fillmore County are open December 27 through December 29, 2019, for taking an unlimited number of either-sex deer by firearms. This is special hunt 804.

H. Portions of Great River Bluffs State Park and King's and Queen's Bluffs Scientific and Natural Area in Winona County are open December 20 through December 22, 2019, for taking an unlimited number of either-sex deer by firearms. This is special hunt 805.

## **6232.1980 TAKING DEER BY ANY WEAPON USING DISEASE MANAGEMENT PERMITS.**

Subpart 1. **Purchase.** An unlimited number of disease management permits may be purchased by a person who has purchased a valid deer license. Disease management permits may be purchased for \$1.50 from an electronic license system agents agent, the Department of Natural Resources License Center, and or other authorized agents.

# Expedited Emergency Rules

Subp. 2. **Restrictions.** Disease management permits are valid for taking either-sex deer only in deer area 101 as described in part 6232.4700, subpart 1a the hunts described in part 6232.1600, subpart 8. Outside of the hunts described in part 6232.1600, subpart 8, disease management permits are valid for taking only antlerless deer in deer permit areas 604, 643, 645, 646, 647, 648, 649, and 655, as described in part 6232.4700, subparts 98 to 102 and 163 to 165, published in the State Register, volume 44, page 279.

Subp. 3. **Disease management hunts.** Disease management permits are valid in the special hunt areas described in part 6232.1600, subpart 8. Disease management permits may be purchased without first purchasing an archery, firearms, or muzzleloader license only for the special hunts described in part 6232.1600, subpart 8. Outside of the special hunts described in part 6232.1600, subpart 8, disease management permits may not be purchased without first purchasing an archery, firearms, or muzzleloader license.

**REPEALER.** The expedited emergency amendment to Minnesota Rules, part 6232.1980, subpart 2, published in the State Register, volume 44, page 279, August 26, 2019, is repealed.

**EFFECTIVE PERIOD.** The expedited emergency amendments to Minnesota Rules, parts 6232.0400, 6232.1600, and 6232.1980, expire January 1, 2020.

## Exempt Rules

Exempt rules are excluded from the normal rulemaking procedures (*Minnesota Statutes* §§ 14.386 and 14.388). They are most often of two kinds. One kind is specifically exempted by the Legislature from rulemaking procedures, but approved for form by the Revisor of Statutes, reviewed for legality by the Office of Administrative Hearings, and then published in the State Register. These exempt rules are effective for two years only.

The second kind of exempt rule is one adopted where an agency for good cause finds that the rulemaking provisions of *Minnesota Statutes*, Chapter 14 are unnecessary, impracticable, or contrary to the public interest. This exemption can be used only where the rules:

- (1) address a serious and immediate threat to the public health, safety, or welfare, or
- (2) comply with a court order or a requirement in federal law in a manner that does not allow for compliance with *Minnesota Statutes* Sections 14.14-14.28, or
- (3) incorporate specific changes set forth in applicable statutes when no interpretation of law is required, or
- (4) make changes that do not alter the sense, meaning, or effect of the rules.

These exempt rules are also reviewed for form by the Revisor of Statutes, for legality by the Office of Administrative Hearings and then published in the *State Register*. In addition, the Office of Administrative Hearings must determine whether the agency has provided adequate justification for the use of this exemption. Rules adopted under clauses (1) or (2) above are effective for two years only. The Legislature may also exempt an agency from the normal rulemaking procedures and establish other procedural and substantive requirements unique to that exemption.

## SUMMARY OF CHANGES

The following is a brief summary of the proposed changes. The complete text of the proposed revisions follows this summary.

**Proposed update to Minnesota Rules 5208.1500 “Standard Industrial Classification List for AWAIR.”** This proposal seeks to update the AWAIR list. “A Workplace Accident and Injury Reduction Act” (AWAIR) was passed by the Minnesota Legislature during the 1990 session (Laws of Minnesota, 1990, Chapter 5208). The AWAIR Act, subdivision 8, requires that a covered employer establish a written work place accident and injury reduction program that promotes safe and healthful working conditions and is based on clearly stated goals and objectives for meeting those goals. Subdivision 9 of §182.653 requires the Commissioner of Labor and Industry to adopt a list of standard industrial classifications (SIC) or North American Industrial Classifications (NAICS) of employers who must comply with subdivision 8, and the list must be updated every five years. The list must be based on the safety record or worker’s compensation record of the industries. Employers within the NAICS classifications on the list must comply with subdivision 8 within six months following the date the NAICS classification that applies to them is placed on the adopted list.

To meet the mandate of §182.653, subdivision 9, Minnesota injury and illness statistics were reviewed. The proposed revisions to the list are based on the “Minnesota Occupational Injuries and Illnesses Survey, 2017” which was conducted by the Minnesota Department of Labor and Industry in cooperation with the Bureau of Labor Statistics (BLS). The survey results are reported as occupational injuries and illnesses incidence rates by industry (NAICS). For all industries combined, the 2017 Minnesota survey results includes industries with a case rate (per 100 full-time employees) for days away from work, days of restricted work activity or job transfer (DART) at or above 1.6, or a total case incidence rate (recordable injuries and illnesses per 100 full-time workers) at or above 3.3. These rates reflect the combined or “average” rates for all reporting industries. Those industries (NAICS) with an incidence rate higher than 3.3 or a DART rate higher than 1.6 are considered to have a higher-than-average rate of injuries and illnesses and, therefore, are required to comply with the AWAIR Act.

## 5208.1500 STANDARD INDUSTRIAL CLASSIFICATION LIST FOR AWAIR.

Employers in the North American Industry classifications listed in this part must comply with Minnesota Statutes, section 182.653, subdivision 8. The North American Industry classifications in this part are those defined by the Office of Management and Budget published in the North American Industry Classification System, 2012 edition.

## Executive Orders

The governor has the authority to issue written statements or orders, called Executive Orders, as well as Emergency Executive Orders. The governor's authority is specified in the Constitution of the State of Minnesota, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

## Office of the Governor

### Executive Order 19-38: Establishing the Governor's Council on an Age-Friendly Minnesota

I, **Tim Walz, Governor of the State of Minnesota**, by the authority vested in me by the Constitution and applicable statutes, issue the following Executive Order:

There are one million older adults in Minnesota and that figure is growing rapidly. In 2020, the number of older adults in Minnesota over age 65 will exceed the number of children under age 18. Older adults may face challenges related to financial security, housing, transportation, health care, employment, and social service needs. In addition, thousands of direct support workers and the estimated 650,000 family and friends who provide unpaid caregiving are struggling to meet the ever-increasing demand for care.

Older adults deserve to live in communities that are respectful, inclusive, and free of prejudice or discrimination based on a person's age, and to be celebrated for their accomplishments and contributions. The aging of our population impacts every community and culture, and people of all ages should feel confident that they and their families can live vibrant, purposeful lives as they grow old.

A statewide policy to promote healthy aging requires engaging with older adults as contributors to the social, economic, and civic fabric of our communities, encouraging physical and psychological health and well-being in older adults and their caregivers, and eliminating ageism. This work cannot be accomplished by any one state agency, but instead must be a collective effort that requires coordination, collaboration, innovation, and focus across state agencies.

Many older adults want to stay in the workforce, volunteer, and give back to their communities. Older adults should have the option of remaining in their communities as they age, with access to a range of public and private resources and

supports to promote healthy and purposeful aging.

Minnesota's Tribal Nations and local governments are well-positioned to respond to the needs of older adults. Many are proactively creating livable and well-designed communities that promote well-being and sustain economic growth. This leads to happier and healthier residents of all ages.

A national organization for older adults and an international health organization award "age-friendly" designations to governmental jurisdictions in recognition of coordinated, multi-agency statewide age-friendly efforts. Achieving such a designation would be beneficial for all Minnesotans. Such designations focus on eight domains of livability: outdoor spaces and buildings, housing, transportation, civic participation and employment, respect and social inclusion, social participation, communication and information, and community and health services.

The benefits of achieving an age-friendly Minnesota include coordinated public and private sector actions to address shared priorities developed with and for older adults; increased efficiency through cross-sector collaborative efforts on behalf of older adults; focused attention to improve equity and address disparities experienced by older Minnesotans; and Tribal Nations, towns, cities, and counties empowered with tools and adequate resources to make their communities more age-friendly.

For these reasons, I order that:

1. Minnesota coordinate work across sectors, including state government, non-profits, communities, businesses, and others to ensure we are an age-friendly state.
2. The Governor's Council on an Age-Friendly Minnesota ("Council") is established to coordinate state and private-sector partners.
3. Each of the following agencies and boards must designate an Age-Friendly Minnesota lead to serve as a Council member:
  - a. The Minnesota Board on Aging
  - b. Department of Commerce
  - c. Department of Employment and Economic Development
  - d. Minnesota Department of Health
  - e. Minnesota Housing Finance Agency
  - f. Department of Human Services
  - g. Minnesota Department of Transportation
  - h. Minnesota Department of Veterans Affairs
  - i. Metropolitan Council
4. Other state agencies and boards may participate on the Council in a non-voting capacity.
5. The Governor will appoint up to six additional Council members, seeking representation from older adults in communities experiencing disparities, direct service caregivers, businesses, experts on aging, local governments, and tribal communities.
6. The Governor will designate the Chair of the Council from its members.
7. The Council will:
  - a. Elevate the voice of older adults in developing the vision and action plan for an age-friendly state.
  - b. Engage with community, including older adults, caregivers, business, experts, advocacy organizations and other stakeholders, to inform recommendations and provide stakeholders with updates on the Council's recommendations.

- c. Identify opportunities for, and barriers to, collaboration and coordination among services and state agencies responsible for funding and administering programs and public-private partnerships.
  - d. Promote equity and make progress toward equitable outcomes by examining programs, policies, and practices to ensure that they address disparities experienced by older adults in Greater Minnesota, older adults of color, and indigenous older adults.
  - e. Catalyze age-friendly work at the local level, engaging with and empowering older adults, local constituents, elected officials, and other stakeholders to create change in every community.
  - f. Establish a statewide framework that allows for local flexibility to tap into the potential presented by our aging communities and elevates aging across all of Minnesota.
  - g. Assess and examine relevant programs, policies, practices, and services to make budget and policy recommendations for the 2021 legislative session to establish, in law, an Age-Friendly Board and age-friendly policies with appropriate financial support, to ensure Minnesota continues to lead on age-friendly initiatives.
8. The Minnesota Board on Aging and Department of Human Services will provide staffing and administrative support to the Council.
  9. The Council may accept technical assistance and in-kind services from outside organizations for purposes consistent with the Council's role and authority.
  10. The Council will submit a preliminary action plan and legislative recommendations to the Governor by August 15, 2020.
  11. The Council will submit a report to the Governor with its final action plan and recommendations for implementation of any enacted legislation related to age-friendly policies by December 31, 2021.

This Executive Order is effective fifteen days after publication in the State Register and filing with the Secretary of State. It will remain in effect until January 1, 2022 or until rescinded by proper authority.

**NOTICE IS HEREBY GIVEN** to recipients, providers of services, and to the public of certain statutory changes made to the Medical Assistance (MA) Program by the 2019 Minnesota Legislature.

This notice is published pursuant to 42 United States Code § 1396a(a)(13)(A) and § 1902(a)(13)(A) of the Social Security Act, which requires the Department to publish final institutional payment rates, the methodologies underlying the establishment of such rates, and the justification for such rates. It is also published pursuant to *Code of Federal Regulations*, title 42, part 447, section 205 (42 C.F.R. § 447.205), which requires publication of a notice when there is any significant proposed change in the methods and standards for setting payment rates for Medicaid services. Notice of this change was published in the *State Register* on June 24, 2019. However, the federal government has asked that we publish again in order to include additional details.

The actual text of the 2019 legislative change is contained in *Laws of Minnesota 2019*, First Special Session, Chapter 9. Effective January 1, 2020, the Commissioner is required to increase fee-for-service payment rates by 1.8 percent for payments to hospitals, surgical centers or health care items and services that are subject to the tax at Minnesota Statutes, section 295.52. This change clarifies that the MA fee-for-service payment rates should reflect the cost of the Minnesota-Care tax if the service is subject to the tax.


