

Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). A subject matter index is updated weekly and is available upon request from the editor. Exempt Rules

Exempt rules are excluded from the normal rulemaking procedures (*Minnesota Statutes* §§ 14.386 and 14.388). They are most often of two kinds. One kind is specifically exempted by the Legislature from rulemaking procedures, but approved for form by the Revisor of Statutes, reviewed for legality by the Office of Administrative Hearings, and then published in the State Register. These exempt rules are effective for two years only.

The second kind of exempt rule is one adopted where an agency for good cause finds that the rulemaking provisions of *Minnesota Statutes*, Chapter 14 are unnecessary, impracticable, or contrary to the public interest. This exemption can be used only where the rules:

(1) address a serious and immediate threat to the public health, safety, or welfare, or

(2) comply with a court order or a requirement in federal law in a manner that does not allow for compliance with *Minnesota Statutes* Sections 14.14-14.28, or

(3) incorporate specific changes set forth in applicable statutes when no interpretation of law is required, or

(4) make changes that do not alter the sense, meaning, or effect of the rules.

These exempt rules are also reviewed for form by the Revisor of Statutes, for legality by the Office of Administrative Hearings and then published in the *State Register*. In addition, the Office of Administrative Hearings must determine whether the agency has provided adequate justification for the use of this exemption. Rules adopted under clauses (1) or (2) above are effective for two years only. The Legislature may also exempt an agency from the normal rulemaking procedures and establish other procedural and substantive requirements unique to that exemption.

Department of Labor and Industry Occupational Safety and Health Division Proposed Exempt Permanent Rules Relating to Occupational Safety and Health Standards; Request for Comments

NOTICE IS HEREBY GIVEN that the Department of Labor and Industry, Occupational Safety and Health Division (Minnesota OSHA) proposes to adopt the following revisions to the Department of Labor and Industry, Occupational Safety and Health Rules, as authorized under Minnesota Statutes §182.655. This notice proposes the adoption of Occupational Safety and Health Standards already proposed and adopted by the Federal Occupational Safety and Health Administration (Federal OSHA).

All interested or affected persons have 30 days from the date this notice is published in the *State Register* to submit, in writing, data and views on the proposed amendments to the rule. Comments in support of or in opposition to the proposed amendments are encouraged. Each comment should identify the portion of the proposed amendment addressed, the reason for the comment, and any proposed change.

Any person may file with the Commissioner written objections to the proposed amendments stating the grounds for those objections and may request a public hearing. A public hearing will be held if 25 or more persons submit written requests for a public hearing on the proposed amendments within the 30-day comment period. Requests for hearing must include the name and address of the person submitting the request, define the reasons for the request, and discuss any proposed changes. If a public hearing is required, the Department will proceed according to the provisions of Minnesota Statutes §182.655 and Minnesota Rules 5210.0020 to 5210.0100.

Exempt Rules

SUMMARY OF CHANGES

The following is a brief and partial summary of the proposed amendments. To review the complete *Federal Register* notice referenced below, visit *www.osha.gov*.

(A) "Revising the Beryllium Standard for General Industry" On July 3, 2018, Federal OSHA published a Direct Final Rule in the Federal Register, amending its existing beryllium standard in general industry by adopting several clarifying amendments to address the application of the standard to materials containing trace amounts of beryllium. By this notice, Minnesota OSHA proposes to adopt the final rule as published in the *Federal Register* July 3, 2018.

(B) "Revising the Beryllium Standard for General Industry" On July 14, 2020 Federal OSHA published a Final Rule in the Federal Register, amending its existing general industry standard for occupational exposure to beryllium and beryllium compounds to clarify certain provisions and simplify or improve compliance. The revisions in this final rule are designed to maintain or enhance worker protections overall by ensuring that the rule is well understood, and compliance is more straightforward. By this notice, Minnesota OSHA proposes to adopt the final rule as published in the *Federal Register* July 14, 2020.

(C) "Occupational Exposure to Beryllium and Beryllium Compounds in Construction and Shipyard Sectors." On August 31, 2020, Federal OSHA published a final rule in the *Federal Register* that amends its existing construction and shipyard standards for occupational exposure to beryllium and beryllium compounds to clarify certain provisions and simplify or improve compliance. These changes are designed to accomplish three goals: to more appropriately tailor the requirements of the construction and shipyards standards to the particular exposures in these industries in light of partial overlap between the beryllium standards' requirements and other OSHA standards; to aid compliance and enforcement across the beryllium standards by avoiding inconsistency, where appropriate, between the shipyards and construction standards and recent revisions to the general industry standard; and to clarify certain requirements with respect to materials containing only trace amounts of beryllium. This final rule does not affect the general industry beryllium standard. By this notice, Minnesota OSHA proposes to adopt the final rule as published in the *Federal Register* August 31, 2020.

(D) "Cranes and Derricks in Construction: Railroad Roadway Work" On September 15, 2020 OSHA published a final rule in the Federal Register that amends its "Cranes and Derricks in Construction" standard. OSHA is revising the standard for cranes and derricks in construction to provide specific exemptions and clarifications with regard to the application of the standard to cranes and derricks used for railroad roadway work. These exemptions and clarifications recognize the unique equipment and circumstances in railroad roadway work and reflect the preemption of some OSHA requirements by regulations promulgated by the Federal Railroad Administration (FRA). The revised standard provides a clearer understanding of which regulatory requirements are applicable, resulting in a more effective regulatory program and ultimately improved safety. By this notice, Minnesota OSHA proposes to adopt the final rule as published in the *Federal Register* September 15, 2020.

Notice of Final Decision to Designate Clothianidin and Imidacloprid as "Surface Water Pesticides of Concern" in Minnesota

NOTICE IS HEREBY GIVEN that the Commissioner (Commissioner) of the Minnesota Department of Agriculture (MDA) has determined that the neonicotinoid insecticides clothianidin and imidacloprid are "surface water pesticides of concern" in accordance with the state *Pesticide Management Plan (PMP)*.

On February 10, 2020, a notice was published in the Minnesota State Register of the Commissioner's preliminary decision to designate three neonicotinoid insecticides, clothianidin, imidacloprid, and thiamethoxam, as "surface water pesticides of concern" (44 SR 879). Public comments on the proposed action were accepted for 60 days, until April 9, 2020. A total of 16 public comments were received and reviewed by the Commissioner. Responses to comments from the MDA are available on the MDA website: *www.mda.state.mn.us/surface-water-pesticides-concern*.

After further consideration of the surface water monitoring data, public comments, and guidance in the PMP, the Commissioner has decided to designate clothianidin and imidacloprid as "surface water pesticides of concern." The Commissioner determined that thiamethoxam does not warrant designation at this time.

Official Notices

In accordance with the PMP, the designation of clothianidin and imidacloprid as "surface water pesticides of concern" will initiate the development of preventative actions including voluntary pesticide-specific best management practices (BMPs) to protect surface waters from further contamination. The MDA previously developed *BMPs for neonicotinoids to protect pollinators* as an outcome of the *Special Registration Review on Neonicotinoids*. These BMPs address the use of all approved neonicotinoid chemicals including clothianidin and imidacloprid. While directed toward pollinator protection, many of the promoted practices also serve to protect water quality; therefore, the pollinator-focused BMPs may be reformatted to specifically address water quality.

The Commissioner has previously determined that two herbicides (acetochlor; atrazine) and one insecticide (chlorpyrifos) are "surface water pesticides of concern." The MDA developed voluntary, pesticide-specific BMPs to protect water resources from these pesticides and, with the cooperation of stakeholders, currently promotes and evaluates BMP adoption and effectiveness through a variety of methods.

Minnesota Pollution Control Agency (MPCA) Public Notice of Intent to Issue a 401 Water Quality Certification for U.S. Army Corps of Engineers Nationwide Permits (NWPs)

The Minnesota Pollution Control Agency (MPCA) Commissioner has made a preliminary determination to certify the referenced Nationwide Permits (NWPs), with conditions, and has preliminarily determined that the NWPs will satisfy the antidegradation standards in Minn. R. 7050.0270.

The U.S. Army Corps of Engineers is seeking state 401 Water Quality Certification for NWPs. MPCA is planning to certify the NWPs with conditions. However, the MPCA is also excluding certain unique waters and projects that impact 300 linear feet or more of a stream or river from general certification under the NWPs. The preliminary determination to issue this 401 Water Quality Certification is to Certify with Conditions.

A draft Section 401 Water Quality Certification is available for review on the MPCA Public Notices webpage at *http://www.pca.state.mn.us/publicnotices* or at the MPCA office address listed under the MPCA contact person. The MPCA will mail or email a copy of the draft certification upon request. Comments, petitions, and other requests must be received at the MPCA in writing on or before December 18, 2020 at 4:30 p.m.

Procedure for public participation

As stated in Minn. R. chs. 7000 and 7001, there are three formal procedures for public participation in the MPCA's consideration of this matter. Interested persons may:

- (1) Submit written comments on the draft certification and antidegradation determination.
- (2) Petition the MPCA to hold a public informational meeting.
- (3) Petition the MPCA to hold a contested case hearing.

Submitting written comments

To submit comments or petitions to the MPCA through the mail or email, you must state:

(1) Your interest in the request for 401 water quality certification or the draft 401 water quality certification.

(2) The action you wish the MPCA to take, including specific references to the section of the draft 401 water quality certification you believe should be changed.

(3) The reasons supporting your position, stated with sufficient specificity as to allow the MPCA to investigate the merits of the position.

Contested Case Hearing

A contested case hearing is a formal proceeding before an administrative law judge empowered to advise the MPCA regarding issues of fact. As described in Minn. R. 7000.1800, persons who submit petitions for a contested case hearing must also state the issues they propose to address in a contested case hearing, the specific relief requested or resolution of the matter, and the reasons (which may be in the form of proposed findings) supporting an MPCA decision to hold a contested case hearing.
