Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). A subject matter index is updated weekly and is available upon request from the editor. NOTICE IS HEREBY GIVEN that the Minnesota Department of Employment and Economic Development ("DEED") will conduct a public hearing on Friday, April 29, 2022 at 1:00 p.m., or as soon thereafter as reasonably possible at 332 Minnesota Street, Suite E200, in Saint Paul, Minnesota, on a proposal to provide funding through the Minnesota Job Creation Fund Program ("JCF") pursuant to authority granted under *Minnesota Statutes* 116J.8748 and *Minnesota Rules* Chapter 4301. This hearing is conducted in accordance with *Minnesota Statutes* 116J.994, Subd. 5.

Description of Projects and Proposed JCF Funding:

ASV Holdings, Inc. may expand in Grand Rapids (Itasca County), Minnesota. The company designs, manufactures and produces compact equipment, including Compact Track Loaders and Compact Skid Steers. The proposed project would enable the company to add the manufacturing of a new product line. ASV Holdings, Inc. was acquired in 2019 and its parent company is Yanmar America Corporation. The proposed project would add a 60,000 square foot high-bay warehouse to the existing company-owned Grand Rapids campus, which consists of a 300,000 square foot production facility and warehouse space. The total project cost is \$9,009,500 of which \$4,753,500 would be eligible for the capital investment rebate of up to 7.5% for site improvements, construction and renovation. Costs ineligible for rebate include machinery and equipment, as well as the portion of site improvements and construction being financed with public funds. The company expects to create 176 jobs within three (3) years at an average cash wage of \$21.51 per hour. The company has requested a Minnesota Investment Fund loan in the amount of \$450,000, which may be forgiven if job creation and wage goals are met. Other assistance through state and local partners is being considered. The project may be eligible for a job creation award of up to \$500,000 and a capital investment rebate of up to \$350,000, depending on final project specifications.

KAMP Automation, LLC may relocate to Owatonna (Steele County), Minnesota from Waseca. The company builds custom automated equipment that ranges in scope from small, automated inspection stations to multi-million dollar manufacturing lines. The proposed project would consist of building a new 50,000 square foot mixed use facility to house engineering and administrative staff, as well as expanded production capacity. The total project cost is \$6,840,940 of which \$6,333,866 would be eligible for the capital investment rebate of up to 7.5% for new construction. Costs ineligible for rebate include machinery and equipment, as well as property acquisition. The company expects to create 23 jobs within two (2) years at an average cash wage of \$42.17 per hour. The company has requested a Minnesota Investment Fund loan in the amount of \$140,000, which may be forgiven if job creation and wage goals are met. Other assistance through local partners is being considered. The project may be eligible for a job creation award of up to \$375,000 and a capital investment rebate of up to \$425,000, depending on final project specifications.
