Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). A subject matter index is updated weekly and is available upon request from the editor. Proposed Rules

Comments on Planned Rules or Rule Amendments. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

Rules to be Adopted After a Hearing. After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

Rules to be Adopted Without a Hearing. Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.1414.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

• Recoupment or recovery of medical assistance and MinnesotaCare benefit overpayments that were caused by an enrollee/recipient's error, Minnesota Rules, part 9505.2215, subpart 1(B), and part 9505.2200 subpart 1.

Introduction. The Department of Human Services intends to repeal obsolete rules under the rulemaking process in the Administrative Procedure Act, *Minnesota Statutes*, section 14.3895. You may submit written comments on the proposed repeal of obsolete rules until February 7, 2025.

Subject of the Repeal of Obsolete Rules and Statutory Authority.

• Monetary Recovery of Overpayments Based on Agency Finding of Recipient/Enrollee Error: Minnesota Rules, part 9505.2200, subpart 1, and part 9505.2215, subpart 1B. These rules are obsolete based on guidance from the Centers for Medicare & Medicaid Services (CMS) and Minnesota Department of Human Services (the Department) Bulletin #23-19-01 relating to "unwinding" after the end of the COVID-19 public health emergency. Medicaid (also known as medical assistance) agencies were directed to stop assessing and recovering medical assistance and MinnesotaCare overpayments based on an agency finding that the overpayments were the result of a recipient/enrollee's own error. Agencies were also directed to stop seeking voluntary repayments of overpaid benefits.

The Department identified the proposed obsolete rules to be repealed in its annual obsolete rules report December 1, 2023, under Minnesota Statutes section 14.05, subdivision 5. The statutory authority to repeal the obsolete rules is found in Minnesota Statutes, section 14.3895. The initial statutory authority under which these rules were created is found in Minnesota Statutes, section 256B.04, which gives the Commissioner of Human Services the authority to make rules to carry out and enforce the medical assistance program in Minnesota. A copy of the proposed obsolete rules to be repealed is published in the State Register and included with this notice as mailed.

Comments. You have until 4:30 p.m. on Friday, February 7, 2025, to submit written comment in support of or in opposition to the proposed repeal of obsolete rules and any part or subpart of the repeal. Your comment must be in writing and received by the agency contact person by the due date. The Department encourages comment. Your comment should identify the portion of the proposed obsolete rules to be repealed addressed and the reason for the comment. In addition, you are encouraged to object to the repeal of any part or subpart. You must also make any comments on the legality of the proposed rules during this comment period.

Request for Hearing. In addition to submitting comments, you may also request that a hearing be held on the rules. You must make your request in writing and the agency contact person must receive it by 4:30 p.m. on February 7, 2025. Your written request must include your name and address. You must identify the portion of the proposed repealed rules to which you object or state that you oppose the entire set of rules. Any request that does not comply with these requirements is not valid and the Department cannot count it for determining whether it must hold a public hearing. You are also encouraged to state the reason for the request and any changes you want made to the proposed rules.

• Effect of Requests. If 25 or more people submit a written request, the Department will have to meet the requirements of Minnesota Statutes, sections 14.131 to 14.20 for rules adopted after a hearing or the requirements of Minnesota Statutes, sections 14.22 to 14.28 for rules adopted without a hearing, including the preparation of a statement of need and reasonableness and the opportunity for a hearing.

Modifications. The Department might modify its choice of these designated rules or parts proposed for repeal (for example, fixing a typo or deciding not to repeal a rule because the rule is discovered not to be obsolete), based on comments and information submitted to the Department. If the final rules are identical to the rules originally published in the State Register, the Department will publish a notice of adopting the repealers in the State Register. If the final rules are different from the rules originally published in the State Register, the Department must publish a copy of the changes in the State Register. If the proposed repeal of obsolete rules affects you in any way, the Department encourages you to

participate in the rulemaking process.

Alternative Format. Upon request, this information can be made available in an alternative format, such as large print, braille, or audio. To make such a request, please contact the agency contact person at the address or telephone number listed above.

Lobbyist Registration. *Minnesota Statutes*, chapter 10A, requires each lobbyist to register with the State Campaign Finance and Public Disclosure Board. Repeal and Review of Obsolete Rules. If no hearing is required, the Department may repeal the obsolete rules at the end of the comment period. The Department will then submit rules and supporting documents to the Office of Administrative Hearings for review for legality. You may ask to be notified of the date that the Department submits the rules. If you want to be so notified, or want to receive a copy of the repealed obsolete rules, or want to register with the Department to receive notice of future rule proceedings, submit your request to the agency contact person listed above.

9505.2200 IDENTIFYING FRAUD, THEFT, ABUSE, OR ERROR.

Subpart 1. **Department investigation.** The department shall investigate vendors or recipients to monitor compliance with program requirements for the purposes of identifying fraud, theft, abuse, or error in the administration of the programs. The department shall also investigate recipients to monitor compliance with program requirements for the purposes of identifying fraud, theft, or abuse in the administration of the programs. [For text of subparts 2 to 5, see Minnesota Rules]

9505.2215 MONETARY RECOVERY.

Subpart 1. Authority to seek monetary recovery. The commissioner shall seek monetary recovery: [For text of item A, see Minnesota Rules]

B. from a recipient, if payment for a health service provided under a program was the result of fraud, theft, <u>or</u> abuse, or error on the part of the recipient absent a showing that recovery would, in that particular case, be unreasonable or unfair.

[For text of subparts 2 and 3, see Minnesota Rules]

Adopted Rules

NOTICE IS HEREBY GIVEN that the Minnesota Department of Employment and Economic Development ("DEED") will conduct a public hearing on Friday, December 20, 2024 at 1:00 p.m., or as soon thereafter as reasonably possible at 180 East Fifth Street, 12th Floor, St. Paul, Minnesota 55101 on one (1) proposal to provide funding through the Minnesota Forward Fund Program ("MFF") pursuant to authority granted under *Minnesota Statutes* 116J.8752. This hearing is conducted in accordance with *Minnesota Statutes* 116J.994, Subd. 5.

Description of Project and Proposed MFF Funding:

SkyWater Technology, Inc. ("SkyWater"), NAICS 334413, is looking to expand in Bloomington (Hennepin County), Minnesota. SkyWater is a U.S. based pure-play technology foundry that offers advanced semiconductor development and manufacturing services from their fabrication facility in Bloomington, Minnesota. The \$127M expansion project will be conducted in two (2) phases. The first phase will focus on the facility modernization with minimal or no physical building expansion beyond the current footprint. The second phase would include equipment modernization to upgrade their aging fleet of tools. The company expects to create 70 jobs within five (5) years at an average cash wage of \$37.52 per hour. The Skywater MFF project is projected to have a return on investment of 10.5, meaning there is estimated to be \$10.50 in wages throughout the state for every \$1.00 in MFF funding. The West Mississippi Commission works in concert with the Shingle Creek Watershed Management Commission. While working under separate operating budgets, the two Commissions share similar activities under a joint Watershed Management Plan.
