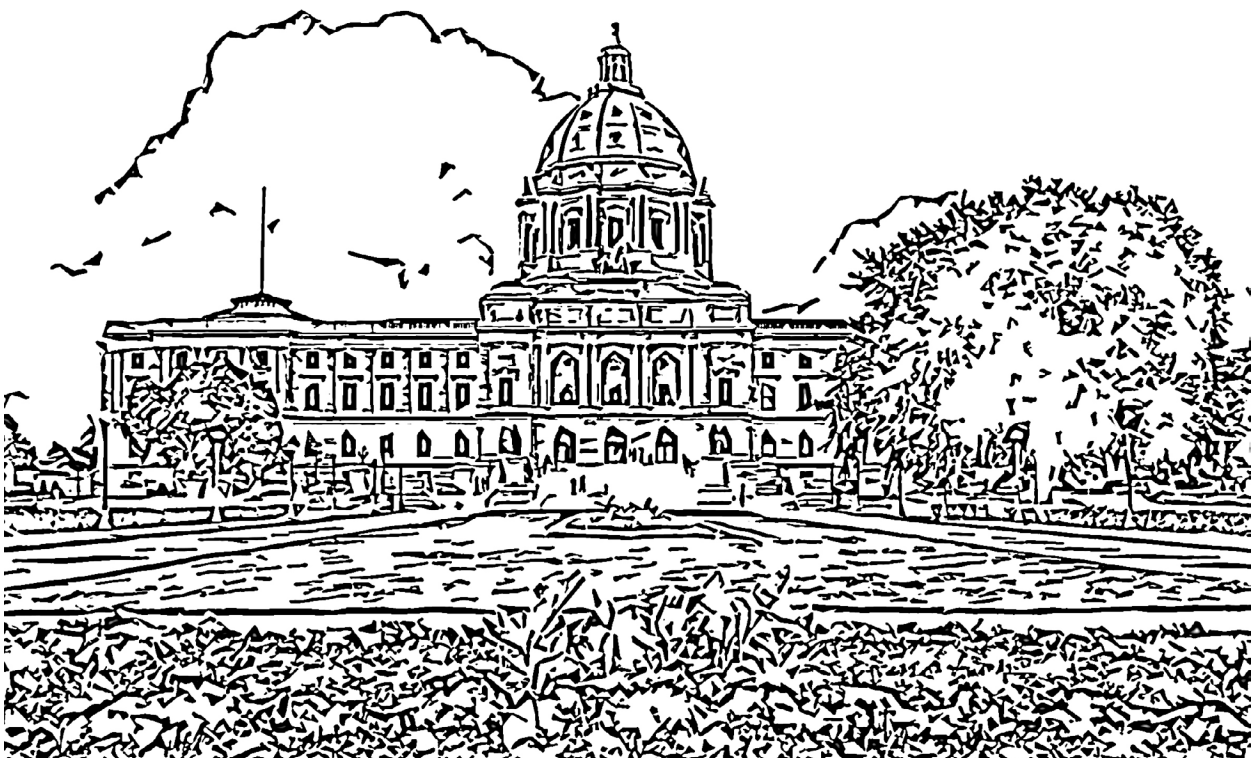

# Minnesota Rules: Amendments and Additions

## NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). A subject matter index is updated weekly and is available upon request from the editor. # Official Notices

Pursuant to *Minnesota Statutes* §§ 14.101, an agency must first solicit comments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

### Notice of Emergency Spongy Moth Quarantine for Anoka, Itasca, and Winona County

The Minnesota Department of Agriculture (MDA) is implementing an emergency quarantine for spongy moth, *Lymantria dispar* (Linnaeus), for three areas in MN. The areas are: The northeastern portion of the City of Coon Rapids in Anoka County, MN bounded by: North boundary: 121st Avenue Northwest; East boundary: University Avenue Northwest; South boundary: Dogwood Street Northwest, Northdale Boulevard Northwest, and 115th Avenue Northwest; and West boundary: Olive Street Northwest. The northwestern portion of the City of Grand Rapids in Itasca County, MN bounded by: Southern Half Section 5, Township 55, Range 25 and Northern Half Section 8, Township 55, Range 25. The northwestern portion of the City of Winona in Winona County, MN bounded by: North boundary: Mississippi River; East boundary: Southern turn of Prairie Island Road North; South boundary: 200 yards south of Prairie Island Road North, West boundary: Dam 5A Spillway Levee running perpendicular to Prairie Island Road North to be implemented May 1, 2025.

## Minnesota State Colleges and Universities (Minnesota State) System Office – Career and Technical Education (CTE) Unit, Workforce & Economic Development Division Request for Proposals (RFP) for Notice of Availability of Funds

Under the auspices of the Strengthening Career and Technical Education Act of 2018, Minnesota State is authorized to assist **institutions serving individuals with disabilities or ex-offenders for support with career-related services and activities**. This grant program serves either adults or youth who are justice-involved or youth and adults with disabilities.

Currently, Minnesota State is requesting proposals from institutions that meet the following eligibility:

1. Correctional institutions or agencies including community corrections that serve adults or youth who are incarcerated or have transitioned out of incarceration or are justice-involved (i.e. active probation)
2. Community organizations that provide direct services to individuals transitioning from correctional institutions—such as group transitional facilities, workforce centers, assistance to veterans, community-based programs, etc.—such as job or skills training and employment services.
3. State institutions or agencies and community organizations that provide direct services to youth or adults with disabilities (regardless of any affiliation with corrections) (Examples: veterans, chemical dependency recovery, etc.)
4. Other organizations that provide direct services, support, and programming for career preparation, employment training, job skill development, etc., within the disabilities.

This initiative has two primary goals to address persistent disparities among these populations: (1) Provide support that assists persons in career-related services and job preparation, which improve work-readiness and job skills leading to economic stability; (2) To assist in the development of career-related services that help improve the successful transition of individuals into employment and/or technical education. Please refer to the full document online for further details and grant description.

For FY2026, up to **\$50,000** is available for this funding. **Grants awarded may range from \$5,000 to \$50,000.** Funds made available under the Perkins Act provide **capacity-building support or new initiatives** and must **NOT supplant** any current funding for programs and services. This request for proposals does not obligate Minnesota State to award a contract. All rights are reserved to cancel the solicitation if it is in its best interest. Any contract executed under this RFP will depend on funding from the federal Office of Career, Technical and Adult Education (OCTAE).

**Informal Solicitations:** Informal solicitations for professional/technical (consultant) contracts valued at over \$5,000 through \$50,000, may either be published in the *State Register* or posted on the Department of Administration, Office of State Procurement (OSP) Website. Interested vendors are encouraged to monitor the P/T Contract Section of the OSP Website at <https://mn.gov/admin/osp> for informal solicitation announcements.

**Formal Solicitations:** Department of Administration procedures require that formal solicitations (announcements for contracts with an estimated value over \$50,000) for professional/technical contracts must be published in the *State Register*. Certain quasi-state agency and Minnesota State College and University institutions are exempt from these requirements.

**Requirements:** There are no statutes or rules requiring contracts to be advertised for any specific length of time, but the Office of State Procurement strongly recommends meeting the following requirements: \$0 - \$5000 does not need to be advertised; \$5,000 - \$25,000 should be advertised in the *State Register* for a period of at least seven calendar days; \$25,000 - \$50,000 should be advertised in the *State Register* for a period of at least 14 calendar days; and anything above \$50,000 should be advertised in the *State Register* for a minimum of at least 21 calendar days.

The State of Minnesota (State), through its Department of Administration's Real Estate and Construction Services (RECS), requests proposals and fee schedules from firms and individuals (Responder). Responder to provide under the direct supervision of a Professional in the field of building commissioning with a minimum of five (5) years' experience with the type of work requiring building commissioning. The purpose of this RFP is to create a new Master Contract program.

It is the goal of this RFP to enter into a Professional and Technical Services Master Contract (Master Contract) with Responders meeting the criteria noted under section Proposal Evaluation. Multiple Responders may be offered a Master Contract to perform work. Projects will vary in nature and scope. The Minnesota Department of Commerce ("Department") seeks proposals from qualified organizations or individuals to investigate the suitability of sites to deploy thermal energy networks ("TENS") statewide. A thermal energy network is defined as a project that provides heating and cooling to multiple buildings connected via underground piping containing fluids that, in concert with heat pumps, exchange thermal energy from the earth, underground or surface waters, wastewater, or other heat sources.

The Department expects the study to include an analysis of the opportunities for and barriers to developing TENS at suitable sites. The study should conclude with presentations to Department staff and stakeholders and a comprehensive report.
