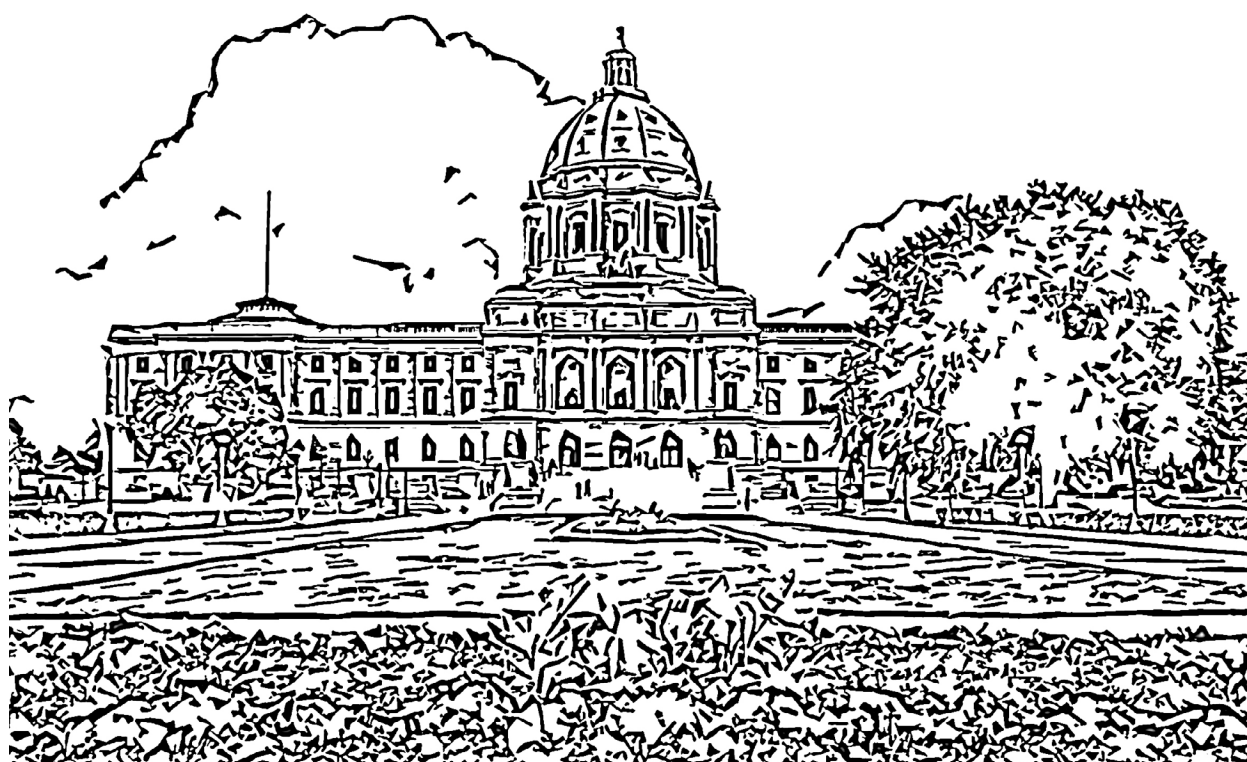

# Minnesota Rules: Amendments and Additions

## NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). A subject matter index is updated weekly and is available upon request from the editor. # Executive Orders

The governor has the authority to issue written statements or orders, called Executive Orders, as well as Emergency Executive Orders. The governor's authority is specified in the Constitution of the State of Minnesota, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

## Office of the Governor

### **Emergency Executive Order 25-07: Amending Executive Order 25-06 and Authorizing Disaster Relief Financial Assistance to Veterans under the State Soldiers Assistance Program**

I, Tim Walz, Governor of the State of Minnesota, by the authority vested in me by the Constitution and applicable statutes, issue the following executive order:

On June 27, 2025, I signed Executive Order 25-06 and declared a peacetime emergency pursuant to Minnesota Statutes 2024, section 12.31, in response to the severe storm event that took place throughout Beltrami County. The Executive Council extended that peacetime emergency at an emergency meeting on June 30, 2025.

Local governments and the Department of Public Safety's Division of Homeland Security and Emergency Management are fully utilizing their resources to help affected communities recover swiftly. Damage assessments are ongoing and additional counties and forms of assistance may be added once the assessments are completed.

While damage assessments are continuing, additional relief is needed to help affected Minnesotans, including our veterans, recover. According to Minnesota Rules 9055.0340, the Governor may issue an emergency executive order authorizing the Minnesota Department of Veterans Affairs ("MDVA") to provide benefits and assistance to veterans in the event of a declared emergency as defined in Minnesota Statutes 2024, section 12.03, subdivision 1e.

For these reasons, I order as follows:

1. Executive Order 25-06 is amended to add paragraph 3 (indicated by underlined text):

3. MDVA will activate the State Soldiers Disaster Relief Program pursuant to Minnesota Rules 9055.0340, subpart 2, to provide relief to veterans and their dependents in the counties identified herein.

2. All other provisions of Executive Order 24-05 remain in full force and effect.

This Emergency Executive Order is effective immediately under Minnesota Statutes 2024, section 4.035, subdivision 2, and remains in effect until rescinded by proper authority or until it expires.

A determination that any provision of this Executive Order is invalid will not affect the enforceability of any other provision of this Executive Order. Rather, the invalid provision will be modified to the extent necessary so that it is enforceable.

# Official Notices

Pursuant to *Minnesota Statutes* §§ 14.101, an agency must first solicit comments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

The *State Register* also publishes other official notices of state agencies and non-state agencies, including notices of meetings and matters of public interest.

## Minnesota Public Utilities Commission

### Request for Comments for Possible Amendment to Rules Relating to the Definition of “Capacity,” *Minnesota Rules*, 7835.0100, subp. 4; Revisor’s ID Number R-04926; PUC Docket No. E-999/R-25-86

**Subject of Rules.** The Minnesota Public Utilities Commission requests comments on a possible rule amendment to the definition of “capacity.”

The Commission requests comments on whether to measure capacity based on a qualifying facility’s electric energy production, rather than its nameplate capacity. Under Minn. Stat. § 216B.164, subd. 3(d), a qualifying facility with less than 40-kilowatt (kW) capacity may elect to be compensated for its net input into a utility’s system at the average retail utility energy rate.

The scope of this rulemaking proceeding is to consider amending the rule to clarify that a qualifying facility with a nameplate rating of 40 kW capacity or more may be compensated for up to 39 kW of net input into the utility’s system at the rate allowed under Minn. Stat. § 216B.164, subd. 3(d).

**Persons Affected.** The amendment to the rules would likely affect public utilities providing retail electric service, cogenerators, small power producers, municipal electric utilities, electric cooperatives, net metered customers, and persons wanting to interconnect with a public utility.

**Statutory Authority.** Minn. Stat. § 216A.05, subd. 1 and § 216B.08, give the Commission general rulemaking authority. Minn. Stat. § 216B.164, subd. 6, authorizes the Commission to adopt rules governing cogeneration and small power production.

**Public Comment.** Interested persons or groups may submit comments or information on the possible rule amendment in writing until 4:30 p.m. on August 18, 2025. **Please refer to Docket No. E-999/R-25-86 in your comments.** You may also electronically file your comments using the Commission’s electronic filing system located at: <http://www.edockets.state.mn.us/EFiling>. The Commission will not publish a notice of intent to adopt the rules until more than 60 days have elapsed from the date of this request for comments.

**Advisory Committee.** The Commission has not determined whether to appoint an advisory committee under Minn. Stat. § 14.101 to comment on the possible rules. Persons interested in this issue should address it in their comments. And persons interested in serving on an advisory committee should include a request to do so in their comments.

**Alternative Format.** Upon request, this information can be made available in an alternative format, such as large print, braille, or audio. To make such a request, please contact the agency contact person at the address or telephone number listed above.

**NOTE:** Comments received in response to this notice will not necessarily be included in the formal rulemaking record submitted to the Administrative Law Judge if and when a proceeding to adopt rules is started. The agency is required to submit to the Judge only those written comments received in response to the rules after they are proposed. If you submit comments during the development of the rules and you want to ensure that the Administrative Law Judge reviews the comments, you should resubmit the comments after the rules are formally proposed.

## 7835.0100 DEFINITIONS

### Subp. 4. Capacity.

"Capacity" means the capability to produce, transmit, or deliver electric energy, and is measured by the number of megawatts alternating current at the point of common coupling between a qualifying facility and a utility's electric system. "Capacity," as defined under Minn. Stat. § 216B.164, subd. 2a (c), for purposes of eligibility for net-metering in Minn. Stat. § 216B.164, subd. 3(d), is determined by, and measured at, the qualifying facility's inverter or a power control system or supplemental device that controls production at the qualifying facility before the net-metered customer's load.

## State Grants & Loans

In addition to requests by state agencies for technical/professional services (published in the State Contracts Section), the *State Register* also publishes notices about grants and loans available through any agency or branch of state government. Although some grant and loan programs specifically require printing in a statewide publication such as the State Register, there is no requirement for publication in the *State Register* itself. Agencies are encouraged to publish grant and loan notices, and to provide financial estimates as well as sufficient time for interested parties to respond.

## Minnesota Amateur Sports Commission (MASC)

### Request for Proposals for James Metzen Mighty Ducks Ice Arena Grant Program with Information and Guidelines

#### GENERAL INFORMATION

The State of Minnesota, acting through its agency, the Minnesota Amateur Sports Commission (MASC), is seeking proposals from interested communities to improve ice arenas. Minnesota communities will be eligible to be awarded grants for improving indoor air quality in ice arenas or eliminating R-22 refrigerant.

Grant applications must come from a local government unit (LGU), a political subdivision of the State. The LGU will be the fiscal agent for the grant funds and will execute the application form and resolution. Other entities can be the owner and/or operator of the ice arena, thus the beneficiary of the grant award. The grants are for reimbursement of costs for completed projects.

Mighty Ducks grants are end-grants, meaning the grant reimburses the grantee after the project has been fully completed. It required the grantee to provide upfront financing during development of the project, with state reimbursement after project completion and occupancy.

The MASC reserves the right to cancel or amend this solicitation if it is considered to be in its best interest.

## LEGISLATIVE AUTHORITY

Applicants should note the specific statutory authority found in *Minnesota Statutes Section 240A.09*, as amended in 2020.

## ELIGIBILITY REQUIREMENTS & EXCLUSIONS

### Requirements:

- Replacement of ice-making systems in existing public facilities that use R-22 as a refrigerant with systems that use an alternative non-ozone-depleting refrigerant; OR
- Indoor air quality improvements:
  - “Indoor air quality improvements,” is defined in Minnesota Statute 240A.09 as the renovation or replacement of heating, ventilating, and air conditioning systems in existing indoor ice arenas whose ice resurfacing and ice edging equipment are not powered by electricity in order to reduce concentrations of carbon monoxide and nitrogen dioxide. The new or renovated systems may include continuous electronic air monitoring devices to automatically activate the ventilation systems when the concentration of carbon monoxide or nitrogen dioxide reaches a predetermined level.
- Proposals must come from one local government unit (LGU).
- Required minimum 50% matching funds from non-state sources.

### Exclusions:

- Electric ice resurfacers are NOT eligible to receive funding through the 2025 grant program.
- Institutions of higher education are not eligible to receive a grant.

## GRANT TYPES

There are three types of grants to assist Minnesota communities in:

1. Eliminating R-22 refrigerant for direct systems;
2. Eliminating R-22 refrigerant for indirect systems; and
3. Improving indoor air quality.

1. Application Form
2. Resolution of LGU
3. Source and Use of Funds Worksheet
4. Responses addressing the following tasks presented for the grant type you are seeking (see Grant Types listed above).

## 1. Description of Project.

- a. **For R-22 Related Grants** Indicate whether the project will replace a direct or indirect refrigeration system and what the new refrigerant will be.
- b. **For Air-Quality Grants** Describe the project and how it will improve indoor air quality, and by how much it will improve. If the project includes adding electronic control/monitoring systems, describe the anticipated energy savings in addition to the improvement to air quality.

## 2. Describe Project Timeline.

- a. Include estimated groundbreaking and completion dates.

## 3. Local Financial Commitment.

The LGU is required to provide documentation of funds secured. All awards must be matched by non-state funds equal to or greater than the award amount.

## 4. Project Budget.

Submit a complete budget for the project.

## 5. Operating Budget.

Describe the annual operating costs of the current refrigeration system and compare it to the annual operating cost for the new system.

## 6. Describe Partnerships

between and among local government units and/or private non-profit groups.

## 7. Describe Gained Efficiencies.

Explain increases in operating efficiency, both monetary and environmental.

**(Optional).** Respondent may submit additional information and documentation if they enhance the goals of the project.

### GRANT AMOUNT

The MASC is authorized by the 2025 Legislature to appropriate up to \$1,000,000 for this program, with limitations on each individual grant amount listed below.

1. Direct R-22 Refrigerant Elimination. Communities may apply for up to \$500,000 per ice center to replace an existing R-22 direct refrigeration system.
2. Indirect R-22 Refrigerant Elimination. Communities may apply for up to \$250,000 ice center to replace an existing R-22 indirect refrigeration system.
3. Indoor Air Quality Improvement. Communities may apply for up to \$25,000 per ice center for the replacement, renovation, or addition of automated systems controls for HVAC systems to improve indoor air quality and reduce energy costs.

### EVALUATION & DISTRIBUTION OF AWARDS

The Mighty Ducks Committee, a sub-committee of MASC, and individuals assigned by MASC Commissioners will evaluate the submitted evaluations.

To the extent possible, the MASC will attempt to balance awards between the Minneapolis-St. Paul metro area and greater Minnesota.

The MASC will make final determinations for grant awards. The MASC will prioritize the grant awards based on the eligibility criteria, responses to tasks, and project timeline.

### STATE CONTRACT RULES

State of Minnesota contract rules will apply to this project.

This project will be subject to the requirements set forth by the Capital Project Checklist set forth in the State of Minnesota Capital Grants Manual found at <https://mn.gov/mmb/debt-management/capital-projects/capital-grants-manual/>

Prevailing Wage Minnesota Statutes 177.42-44 require that for any construction project funded in whole or in part by state funds, contractors must pay prevailing wages and hours of labor. Prevailing wage is the minimum hourly wage employers must pay certain workers who work on construction projects where state dollars are used to fund the
