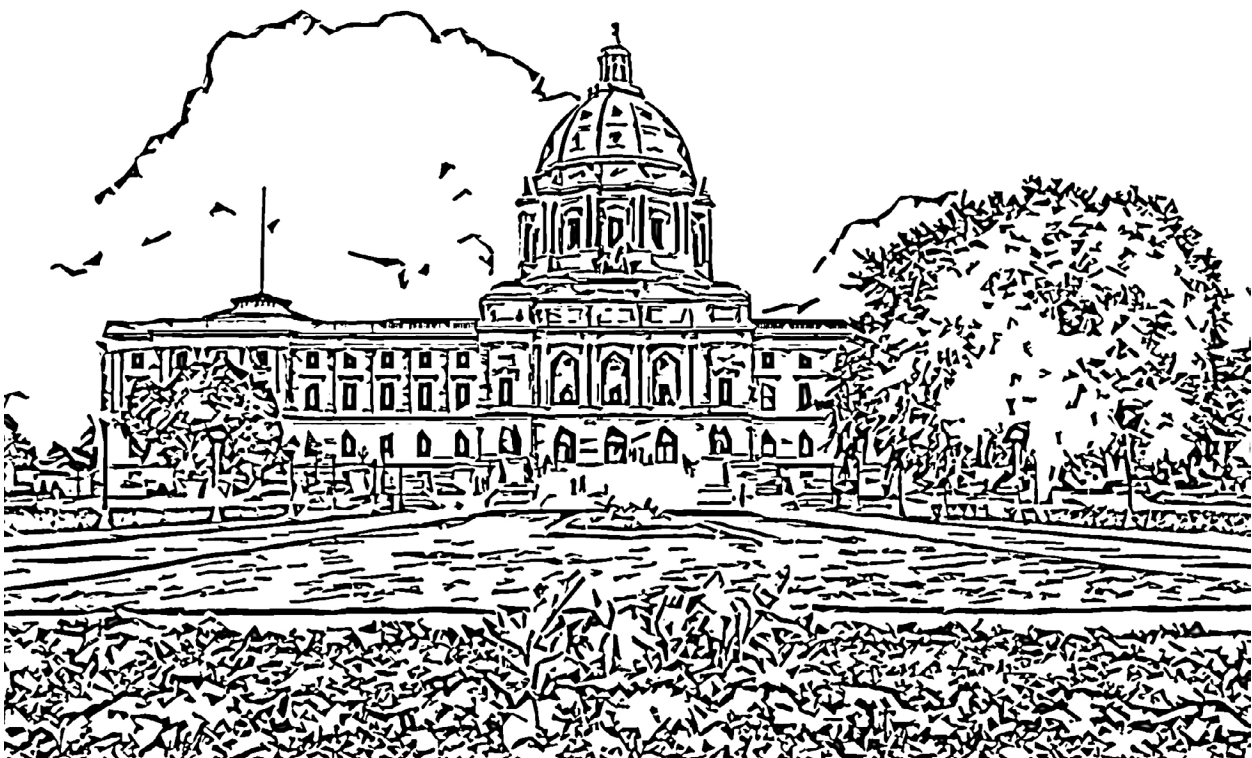

# Minnesota Rules: Amendments and Additions

## NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). A subject matter index is updated weekly and is available upon request from the editor. # Proposed Rules

**Comments on Planned Rules or Rule Amendments.** An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

**Rules to be Adopted After a Hearing.** After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

**Rules to be Adopted Without a Hearing.** Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.1414.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

### Proposed Permanent Rules Relating to Residential Treatment Programs; Notice of Intent to Adopt Rules Without a Public Hearing

**In the Matter of the Proposed Permanent Rules Relating to Residential Treatment Programs; Revisor’s ID No. R-4447; CAH Docket No. 22-9051-40735**

**Introduction.** The Department of Corrections intends to adopt rules without a public hearing under Minnesota Rules, parts 1400.2300 to 1400.2310, and Minnesota Statutes, sections 14.22 to 14.28. By 4:30 p.m. Thursday, August 21, 2025, you may submit written comments on the proposed rules and may also submit a written request that a hearing be held on the rules.

**Subject of rules and statutory authority.** The proposed rules are on department-certified residential treatment programs for individuals who have engaged or attempt to engage in sexually abusive or harmful behavior. The department oversees two rulemaking chapters for these individuals on their sex-offense-specific treatment: one for juveniles and one for adults. Both chapters were separately adopted in 1999 and have remained unamended since. The rule requirements are now obsolete and in need of revision to conform to new research and best practices for sex-offense-

specific treatment.

The department's rule amendments will incorporate updated research-based best practices to help clients participating in sex-offense-specific treatment reduce their likelihood of reoffending. Other proposed amendments seek to:

1. establish well-defined, consistent standards to promote the most effective treatment for clients;
2. update definitions and ensure that they are consistently used and understandable; and
3. remove jargon and legalese and conform to plain-language standards for more-effective regulatory compliance.

The statutory authority to adopt the rule is under Minnesota Statutes, section 241.67, subdivision 2, paragraph (a). A free copy of the proposed rule is available on the department's rulemaking web page (<https://mn.gov/doc/about/rulemaking/>) or upon request to Ian Lewenstein.

You may also review the proposed rule and submit written comments via the Court of Administrative Hearings' eComments website (<https://minnesotaoah.granicusideas.com/>).

**Comments.** You have until 4:30 p.m. Thursday, August 21, 2025, to comment—supporting or opposing—on the proposed rules, including any specific rule part. **Comments on the rule or requests for a public hearing must be submitted via the eComments website (<https://minnesotaoah.granicusideas.com/>).** If you cannot use the eComments website, you may submit comments in person, via US mail, or by facsimile addressed to Judge Moseng at the Court of Administrative Hearings, 600 Robert Street North, PO Box 64620, St. Paul, Minnesota 55164-0620, or fax (651) 539-0310.

The department strongly encourages public comment—especially if the proposed rules affect you—and your comments should identify which rule part you are commenting on, the reason for the comment, and any proposed change. Any comments that you have about the legality of the proposed rules must also be made during the comment period.

**Requesting a public hearing.** In addition to submitting comments, you may also request that the department hold a hearing on the rules. You must make your request for a public hearing by 4:30 p.m. Thursday, August 21, 2025. You must include your name and address in your request and identify the portion of the proposed rules that you object to or state that you oppose the entire rule. Any request that does not comply with these requirements is invalid and does not count as a request for hearing.

You are also encouraged to state why you are requesting a hearing and any changes that you want made to the proposed rules.

**Holding a public hearing.** If 25 or more people submit a written request for a public hearing before the comment period ends, the department must hold a public hearing. The department will then proceed according to Minnesota Statutes, sections 14.131 to 14.20, and must publish a notice of the public hearing in the *State Register* and notify people who submitted a written request for the public hearing.

**Withdrawing requests for a public hearing.** If enough requests for a hearing are withdrawn to reduce the number of hearing requests below 25, the department must give written notice to all persons who requested a hearing and explain that enough persons have withdrawn their hearing requests. The department's notice on withdrawing requests must comply with additional requirements under Minnesota Statutes, section 14.25, subdivision 2.

**Modifications.** The department may modify the proposed rules because of public comment or as otherwise needed to comply with the Administrative Procedure Act. The department must support modifications with information or evidence, including public comments sent to the department. Unless the department follows the procedure under Minnesota Rules, part 1400.2110, the adopted rules may not be substantially different than the proposed rules.

# Proposed Rules

**Statement of Need and Reasonableness.** In the Statement of Need and Reasonableness (SONAR), the department justifies why the proposed rules are needed to adopt updated research-based best practices for residential treatment programs and why the department's proposed rules are reasonable.

The department also describes who the rules will affect and estimates the rules' probable cost. The SONAR is now available upon request to Ian Lewenstein and is also available on the department's rulemaking web page (<https://mn.gov/doc/about/rulemaking/>). You may review the SONAR or get a copy by contacting Ian Lewenstein.

**Lobbyist registration.** A lobbyist must register with the Minnesota Campaign Finance and Public Disclosure Board (see Minnesota Statutes, chapter 10A). You may ask questions about this requirement by contacting the Campaign Finance and Public Disclosure Board at 190 Centennial Office Building, 658 Cedar Street, St. Paul, Minnesota 55155, telephone (651) 539-1180 or 1-800-657-3889.

**Adopting and reviewing rules.** If no hearing is required, the department may adopt the rules after the comment period ends. The department will then submit the rules and supporting documents to the Court of Administrative Hearings to review for legality. Please contact Ian Lewenstein if you want to:

1. be notified when the department submits the rules to the court;
2. receive a copy of the adopted rules; or
3. register with the department to receive notice of future rule proceedings.

## Expedited Emergency Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

### Adopted Expedited Emergency Game and Fish Rules: Furbearers, Wildlife Management Areas, State Game Refuges, and Small Game

Notice is hereby given that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13(b). The statutory authority for the content of the rules is *Minnesota Statutes*, sections 84.027, subdivision 13; 84.15, subdivision 1; 97A.091, subdivision 2; 97A.137, subdivisions 1 and 2; 97A.401, subdivision 4; 97B.111; 97B.112; 97B.605; and 97B.721.

The following conditions do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459. Changes to rules for wildlife management areas correspond to changing habitat conditions and changes in use based on staff encounters with users, opinion surveys, harvest data and field data. Hunting restrictions on the Wesley E. Olson and Perched Valley Wildlife Management Areas are being lifted to align with current land management practices. Wild rice (manoomin) harvest is being restricted on Swamp Lake Wildlife Management Area and the adjoining water body to protect ongoing restoration efforts. Ending pheasant and goose hunting two weeks early on Vermillion Highlands WMA supports co-management goals for shared trail use during peak winter recreation.

Changes to game refuges allow recreational activities that include bird watching, ricing, fishing, waterfowl, archery, and firearms hunting and trapping where these activities are compatible with the purpose of the refuge and where a harvestable population of species exists, based upon current biological and harvest data. These changes generally provide for public hunting and recreation opportunities where those activities are sustainable and safe. The changes to rules for taking jackrabbits, weasels, fishers, pine martens, bobcats, and otters for the fall hunting season are all based on the need to adjust season variables on an annual basis based upon current biological and harvest data. This rule continues a change first implemented in 2024 that allows increased harvest opportunity while ensuring sustainable management of fisher, pine marten, and bobcat.

Subp. 4. **Areas with hunting, trapping, and firearms restrictions.** The Bayport Wildlife Management Area in Washington County, the Hastings Wildlife Management Area in Dakota County, and the Raguet Wildlife Management Area in Scott and Carver Counties are:

B. closed to the possession of firearms unless unloaded and contained in a case, except that shotguns with only ~~No. 4 buckshot~~ BBB-sized shot or smaller diameter shot may be used during the small game season in posted areas; and

### Subp. 5. **Areas closed to hunting and trapping.**

A. The following wildlife management areas are closed to hunting and trapping all species:

(1) Boerner Wildlife Management Area in Sibley County, ~~the~~;

(2) Buelow Wildlife Management Area in Steele County, ~~the~~;

(3) Bryson Wildlife Management Area in Freeborn County, ~~the~~;

(4) Chapa-Kak-Say-Za Wildlife Management Area in Steele County; ~~and the~~

(5) Hutchinson Wildlife Management Area in McLeod County ~~are closed to the hunting and trapping of all species.~~

B. The Sand Prairie Wildlife Management Area in Sherburne County is closed to the hunting and trapping of all species, except ~~for~~:

(1) hunting by individuals with disabilities participating in a special hunt;

(2) youth ages ten to 17 who are participating in the regular archery season. Youth may take one deer under this subitem but may not hunt during events for individuals with disabilities; and

Individuals required by Minnesota Statutes, section 326A.14, subdivision 1, paragraph (b), to obtain a verification that their individual qualifications are substantially equivalent to the licensure requirements of Minnesota Statutes, section 326A.03, subdivisions 3, 4, and 6, shall obtain the verification from the NASBA National Qualification Appraisal Service prior to rendering professional services in this state. Documentation supporting this verification must be maintained by the individual for a minimum period of six years and must be submitted to the board upon request.

In accordance with the law, the plan addresses the prevention, evaluation, and mitigation of occurrences of pesticides or pesticide breakdown products in groundwaters and surface waters of the state. Many of the steps outlined in the PMP are directly linked to the statutory requirements and guidance in the Pesticide Control Law (Minn. Stat. Chapter 18B) and the Groundwater Protection Act (Minn. Stat. Chapter 103H). The PMP was first published in 1996 and last revised in 2007. In December 2019, the MDA announced its intent to revise and update the PMP (*44 SR 773*).

- the Minnesota Association of Community Corrections Act Counties;
- the Minnesota Association of County Probation Agents;
- the federal Bureau of Prisons;
- state and federal courts; and
- local government entities such as cities, counties, and townships and their respective associations: the League of Minnesota Cities, the Association of Minnesota Counties, and the Minnesota Association of Townships.

**Statutory authority.** The department has the statutory authority to amend and adopt rules on adult community-based residential correctional facilities under Minnesota Statutes, section 241.021, subdivision 1, paragraph (a).

**Public comment.** Interested individuals or groups may email or mail comments or information on the possible rules until the department publishes a notice of intent to adopt the rules. The department will not publish a notice of intent to adopt the rules until more than 60 days have elapsed from this notice's publication date.

At the authorization by the legislature of additional medical assistance expenditures for exceptions to the moratorium on nursing homes, the commissioner shall publish in the State Register a request for proposals for nursing home and certified boarding care home projects for conversion, relocation, renovation, replacement, upgrading, or addition.

During each biennium, including any carryover of previous appropriations, and for the period from **July 1, 2025**, to **June 30, 2026**, the legislative appropriation available to fund additional costs to the medical assistance program associated with projects approved under Minnesota Statutes, section 144A.073, is **\$8,121,912**.

### Consideration for Approval

To be considered for approval, a proposal must include the following information:

1. Whether the request is for renovation, replacement, upgrading, conversion, addition, or relocation.
2. A description of the problems the project is designed to address.
3. A description of the proposed project.
4. An analysis of projected costs of the nursing facility proposed project, including:
  - I. Initial construction and remodeling costs.
  - II. Site preparation costs.
  - III. Equipment and technology costs.
  - IV. Financing costs, the current estimated long-term financing costs of the proposal, which is to include details of any proposed funding mechanism already arranged or being considered including estimates of the amount and sources of money, reserves if required, annual payments schedule, interest rates, length of term, closing costs and fees, insurance costs, any completed marketing study or underwriting review.
  - V. Estimated operating costs during the first two years after completion of the project.
5. For proposals involving replacement of all or part of a facility, the proposed location of the replacement facility and an estimate of the cost of addressing the problem through renovation.

6. For proposals involving renovation, an estimate of the cost of addressing the problem through replacement.
7. The proposed timetable for commencing construction and completing the project.
8. A statement of any licensure or certification issues, such as certification survey deficiencies.
9. The proposed relocation plan for current residents if beds are to be closed according to section **144.161**.
10. Other information required by permanent rule of the commissioner of health in accordance with subdivisions 4 and 8.

## **Review and Approval of Proposals**

Proposals will be reviewed by the Advisory Review Panel composed of representatives from organizations serving nursing home consumers and providers, professionals in engineering, building construction, or design services, and relevant state agencies involved in long-term care, housing, and finance.

Applicants will have the opportunity to present their proposals during a virtual public meeting held prior to the panel's submission of comments and recommendations to the Commissioner of Health. Meeting details, including the date and time, will be provided to the contact person identified in each moratorium exception proposal.

The Commissioner of Health will approve or disapprove proposals based on criteria established in state law and rule. A final decision will be issued no later than **March 31, 2026**.

## **Criteria for Review**

The commissioner of health is accepting written proposals from nursing homes and certified boarding care homes requesting funding under the moratorium exception process, in accordance with Minnesota Statutes, section 144A.073. The commissioner of health, in coordination with the commissioner of human services, may recommend proposals for such requests under the criteria for review set forth in Minnesota Statutes, section 144A.073, subd. 4a.

1. The extent to which the proposed nursing home project is integrated with other health and long-term care services for older adults.
2. The extent to which the project provides for the complete replacement of an outdated physical plant.
3. The extent to which the project results in a reduction of nursing facility beds in an area that has relatively high number of beds per thousand occupied by persons age 85 and over.
4. The extent to which the project produces improvements in health; safety, including life safety code corrections; quality of life; and privacy of residents.
5. The extent to which, under the current facility ownership and management, the provider has shown the ability to provide good quality of care based on health-related findings on certification surveys, quality indicator scores, and quality-of-life scores, including those from the Minnesota nursing home report card.
6. The extent to which the project integrates the latest technology and design features in a way that improves the resident experience and improves the working environment for employees.
7. The extent to which the sustainability of the nursing facility can be demonstrated based on the need for services in the area and the proposed financing of the project.
8. The extent to which the project provides or maintain access to nursing facility services needed in the community.

## **Method for Estimating Proposal Costs**

The method the commissioner will use to evaluate and determine the approval or disapproval of a proposal's cost estimate is outlined in the application.

## Projects Not Meeting the Exceptions to the Moratorium Criteria

Projects that do not meet the criteria for the exceptions to the moratorium process may still qualify as “threshold” projects under *Minnesota Statutes, section 256B.434, subd. 4f*. Unlike projects approved through the competitive exceptions to the moratorium process, threshold projects are not required to demonstrate that capitalized expenses are related to improvements to the physical plant beyond the replacement of existing components.

**Note: Effective October 1, 2025, Minnesota Statutes, section 256B.434, subd. 4f permits threshold projects with costs under \$2,421,908 to proceed without applying for an exception to the moratorium process.**
