

# Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

## **Department of Natural Resources**

Adopted Expedited Emergency Game and Fish Rules: Upland Bird and Wild Turkey Seasons, Wildlife Management Areas, State Game Refuges, and Common Crow Season

Notice is hereby given that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13(b). The statutory authority for the content of the rules is *Minnesota Statutes*, sections 84.027, subdivision 13(a); 97A.091, subdivisions 1 and 2; section 97A.045, subdivisions 3 and 5; section 97A.137, subdivisions 1 and 2; 97A.434, subdivisions 1 through 4; section 97A.435, subdivisions 1 and 2; section 97B.111; 97B.605;97B.716 subdivisions 1 through 3; section 97B.721; section 97B.723 and section 97B.731, subdivision 3.

The following conditions do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459: i) upland bird hunting seasons are subject to adjustment on an annual basis based upon current biological and harvest data; ii) distribution of permits for access to major wildlife management units is subject to modification on an annual basis as the Department of Natural Resources refines the manner by which the season is conducted to provide high-quality hunting opportunities and assure equitable distribution of harvest; iii) turkey population and harvest data is gathered annually and analyzed in the winter; and iv) adjustments to season variables, including permit area boundaries, are based on annual and long-term population data as well as input from the public.

Changes to wildlife management areas are compatible with their intended purpose. Where harvestable populations of species exist, rule changes have expanded public hunting opportunity safely and sustainably.

The crow season is being amended to continue to meet the maximum federal crow season specified in *Minnesota Statutes*, section 97B.73 l, subdivision 3.

E. The St. Michael Meadows Wildlife Management Area in Wright County is closed to all hunting and trapping except archery deer hunting.

#### 6230.0290 BECKLIN HOMESTEAD PARK WILDLIFE MANAGEMENT AREA.

- <u>Subpart 1.</u> <u>Open hunting.</u> The Becklin Homestead Park Wildlife Management Area is open to hunting and trapping during the established seasons only to <u>disabled</u> hunters and trappers <u>who meet the requirements of with disabilities and their able-bodied partners during:</u>
- A. the established seasons according to Minnesota Statutes, section 97B.055, subdivision 3, paragraphs (a) and (b):; and
  - B. the special hunt described under subpart 2.

#### Subp. 2. Special hunt.

- A. The Becklin Homestead Park Wildlife Management Area is open April 16 to May 31 for taking wild turkey according to this subpart. An unlimited number of permits shall be issued to hunters with disabilities. Capable Partners is the sponsor. Hunters with disabilities and able-bodied partners must meet any hunt requirements of the sponsoring organization.
- B. Hunters with disabilities must be accompanied by an able-bodied partner each time they hunt. Hunters with disabilities must purchase and possess a spring turkey-hunting license. The bag limit is one bearded turkey per season.
- C. Able-bodied partners must stay within 100 yards of the hunter with disabilities and may take only legal bearded turkeys. Able-bodied partners must purchase and possess a spring turkey-hunting license. The bag limit for able-bodied partners is one bearded turkey per season.

Subp. 64. <u>Camp Ripley Military Reservation Game Refuge</u>, <u>Morrison County</u>. The Camp Ripley Military Reservation Game Refuge is open April 21 to 23 for spring turkey hunting to individuals with disabilities participating in a special hunt sponsored by Veterans Outdoor Programs. The refuge is open May 6 to 8 for spring turkey hunting to members of the military and their children participating in a special hunt sponsored by the Camp Ripley Environmental Office.

#### 6234.0200 TAKING RUFFED GROUSE AND SPRUCE GROUSE.

Subp. 2. **Bag limit.** A person may not take more than an aggregate of five ruffed grouse and spruce grouse per day, of which no more than two may be spruce grouse, or possess an aggregate of more than ten ruffed grouse and spruce grouse at a time, of which no more than four may be spruce grouse.

#### 6234.0300 TAKING SHARP-TAILED GROUSE.

Subpart 1. **Bag limits.** A person may not take more than three sharp-tailed grouse <u>or their hybrids</u> per day or possess more than six sharp-tailed grouse <u>or their hybrids</u> at a time.

Subp. 2a. Northwest Zone. The Northwest Zone for taking sharp-tailed grouse is that portion of the state's open area lying west of the following described boundary line:

Beginning at the intersection of Voyageurs National Park and the northern boundary of the state; thence along the western boundary of the park to the public access to Lake Kabetogama at Gappa's Landing; thence along County Road 523, St. Louis County, to County State-Aid Highway (CSAH) 123, St. Louis County; thence along CSAH 123 to CSAH 122, St. Louis County; thence along CSAH 122 to U.S. Highway (US) 53; thence along US 53 to State Trunk Highway (STH) 73; thence along STH 73 to the intersection of STH 73 and STH 1.

- Subp. 2b. <u>East-Central Zone</u>. The East-Central Zone for taking sharp-tailed grouse is that portion of the state's open area that is not included in the Northwest Zone.
- Subp. 3. **Open season.** Sharp-tailed grouse may be taken by firearm or bow and arrow from the Saturday on or nearest September 16 to November 30 in the Northwest Zone. Sharp-tailed grouse may not be taken in the East-Central Zone.

## 6236.0300 TURKEY HUNT DRAWING.

#### Subpart 1. Spring license application drawings Special turkey hunts.

- A. Applications for spring hunts to hunt the Carlos Avery or Whitewater Wildlife Management Area must be made according to this part and according to application instructions provided by the commissioner. Each person must apply at an through the electronic license system agent or, the Department of Natural Resources License Center, or other authorized agents.
- <u>B.</u> Drawings will be conducted by the department to determine persons who will be eligible to <del>purchase licenses for each season</del> <u>hunt the Carlos Avery or Whitewater Wildlife Management Area during period A</u>. The drawings will be subject to the quotas established by the commissioner.
- <u>C.</u> Preference in the respective drawings is given to applicants based upon the number of times they have correctly applied for a license for that hunt to hunt one of the specified wildlife management areas but have been unsuccessful. A person selected by the drawings is <u>Successful applicants are</u> eligible to <u>purchase a license to</u> hunt turkey in the wildlife management area they selected during the period indicated on their turkey-hunting license. Successful applicants may also hunt in areas that are otherwise open to spring turkey hunting. Upon issuance of a turkey license for the spring season permit to hunt one of the specified wildlife management areas, all accumulated preference for that season is lost, except as provided in subpart 6.
  - B. D. No lottery application is needed to purchase a spring or fall turkey license.
  - E. Only successful applicants will be notified.
- Subp. 2. **Participation in application drawings.** A person may not apply more than once for a hunt, whether as an individual or as a member of a group. <del>Qualifying individuals may apply for the resident landowner-tenant turkey drawing.</del> All <del>of</del> the information in items A to <u>G</u>F must be supplied on the application forms.

- C. Up to four persons desiring to hunt together as a group may apply as a group. Group applications shall either all be selected or none selected. All group members must apply for the same wild turkey permit areas and time periods area and period. The preference rating of applicants who apply as a group shall be is determined by the individual in the group with the lowest preference. Group applications may be made up of all general or all landowner-tenant applications, but not both.
- D. A person who applies as a landowner or tenant but does not meet the definition as provided by this part will be ineligible for that season's drawings.
  - E. D. The application deadline for the spring season is the second Friday in January, February 13.
- F. E. Youth age 17 and younger may purchase a wild turkey hunting license to hunt all eight spring turkey time periods. A wild turkey hunting license under this item is separate from the normal lottery process and is valid for hunting in any wild turkey permit area. Hunters with a valid permit to hunt from a standing vehicle issued under Minnesota Statutes, section 97B.055, subdivision 3, may purchase a spring turkey license for any firearm season period and may hunt all spring turkey periods.

- G. F. A person who has not applied for a wild turkey license through the lottery or who applied for a license and was unsuccessful in the lottery may purchase a wild turkey hunting license to hunt the spring turkey season during the fourth, fifth, sixth, seventh, or eighth time period. A wild turkey hunting license under this item is separate from the normal lottery process. Firearms hunters who purchase a license under this item age 18 and older must choose and hunt in one time period. Archery During the selected period and the sixth period, firearms hunters may use legal firearms, a legal bow and arrow, or a crossbow. A firearms hunter who has not harvested a turkey during their selected period may also hunt during the sixth period. Archery-only hunters who purchase a license under this item may hunt throughout the fourth, fifth, sixth, seventh, and eighth time all periods.
  - (1) Turkey lottery preference points shall not be reduced for a person purchasing a license under this item.
- <u>G.</u> (2) A person may take only one bearded turkey during the entire spring turkey season regardless of whether the hunter purchased a license through the lottery system or as provided in this item.

#### 6236.0400 OBTAINING LICENSE.

The following provisions apply to persons who have applied for a turkey license:

- A. Only successful applicants will be notified.
- B. Successful applicants will receive a license application with instructions for obtaining their licenses. Persons who do not return the license application and the fee according to the provisions specified on the license application or who do not provide all the requested information will be disqualified.
- C. A person may purchase a fall <u>or spring</u> turkey license without an application. A turkey permit area must be selected, but hunters are not required to hunt in that area.

### 6236.0600 SPRING TURKEY SEASON.

- Subpart 1. **Open dates.** The spring turkey season opens the Wednesday nearest April 15 and consists of six five consecutive five-day seven-day periods followed by two consecutive seven-day periods one final period that ends May 31.

- Subp. 4. **Open areas.** Wild turkey permit areas are open for the spring turkey season as prescribed by the commissioner. Turkey licenses are valid for taking turkeys only in the wild turkey permit area in any open area during the period specified on the license, except for archery-only licenses issued under Minnesota Statutes, section 97A.435, subdivision 5, paragraph (a). Archery-only licenses and youth licenses are valid for any period and in any open area.

#### 6236.0700 FALL TURKEY SEASON.

Subp. 4. **Open areas.** Wild turkey permit areas are open for the fall turkey season as prescribed by the commissioner. Turkey licenses are valid for taking turkeys only in the wild turkey permit area specified on the license statewide.

The following wild turkey permit areas are open for the 2025 fall season: 501, 502, 503, 504, 505, 506, 507, 508, 509, 510, 511, and 512.

The MPCA is considering amendments to the listed rule chapters and requests comments on the proposed amendments from interested or affected parties. Comments should be submitted in writing as described in the *Comments* section below.

This second request for comments (RFC) is the MPCA's legal notice of its intent to continue the rulemaking initially announced on October 1, 2018 (43 SR 417), which had no preliminary draft rule language to consider and resulted in no formal comments at that time. This second RFC is one of several opportunities for public comment and input on this rulemaking. At this stage, the MPCA has a preliminary draft rule to share. The MPCA is seeking comments on the preliminary draft rule and the ideas described under the Subject of Rules section before proceeding to the next phase of rulemaking – public noticing a draft rule.

If you have ideas related to this rulemaking that the MPCA needs to consider, please submit them in writing. For example, the MPCA recognizes that costs to regulated parties can be a concern with rulemaking. If you have cost information or data related to this rulemaking that you wish to share with MPCA to inform our decisions, please submit that information. Submitting your ideas and information at this stage in rulemaking allows us more time to address issues and helps to ensure informed decision-making by MPCA. If the proposed rules affect you in any way, the MPCA encourages you to participate in the rulemaking process.

Since 2018, the Agency has at various stages solicited input via a rules advisory committee, known as the Rules Advisory Panel (RAP), and various public meetings. See the rule webpage for more information at: *https://www.pca.state.mn.us/get-engaged/construction-and-demolition-debris-landfills*. The MPCA has completed RAP activities and is now seeking comments on the possible rules from a broader audience.

**Statutory Authority.** The Minnesota Legislature may provide agencies with either specific or general statutory rulemaking authorities. The MPCA did not seek specific authority for this rulemaking as it intends to use its existing general solid waste rulemaking authority under *Minnesota Statutes* section, section 116.07, subdivisions 2 and 4 (www. revisor.mn.gov/statutes/?id=116.07) to undertake this rulemaking.

**Subject of Rules.** The MPCA requests comments on its plans to amend rules governing construction and demolition debris land disposal facilities found in chapters 7001 (Permits) and 7035 (Solid Waste). Since the October 1, 2018, RFC, the Agency published a groundwater study that found a major deficiency in the Agency's existing CDL Rules and guidance based on an improper assumption that CDL waste and leachate were safe (inert) and that CDL leachate would not contaminate groundwater. The study shows that CDL leachate poses risks to human health and the environment and has been contaminating groundwater.

The Agency's goal is to update its Rules and guidance to incorporate lessons it has learned about the potential for groundwater impacts resulting from unlined CDLs that were not required to capture, manage and treat CDL leachate. Since its promulgation of the existing rules in 1988 and its development and implementation of 2005 CDL guidance, the Agency has found pollutants in groundwater monitored around unlined CDLs. These pollutants have exceeded

Minnesota Department of Health (MDH) Human Health-Based Water Guidance values. These values include Health Risk Limits (HRLs), Health-Based Values (HBVs), Risk Assessment Advice (RAA), and U.S. Environmental Protection Agency's Maximum Concentration Limits (MCLs).

At this time, the Agency does not foresee any likely disproportionate negative impacts to environmental justice (EJ) communities related to amending these possible Rules (discussed further in the persons affected section). The technology to capture and manage landfill leachate is standard and is employed by municipal solid waste landfills throughout Minnesota and the country. Most of the states in our region also require collection and management of leachate from CDL landfills.

The Agency intends to limit the scope of this rulemaking to issues described for CDLs with the understanding that it may choose to address related issues found in this process. At its discretion, the Agency may address a priority related item, but only as the Agency believes resources would allow and that the action would not hinder its primary goals for addressing CDL issues. The Agency considers all input to be advisory in nature with the Agency deciding how it must focus its resources.

Anticipated amendments governing CDLs will address new and growing concerns about protecting groundwater from pollution/contamination. The MPCA intends to revise existing CDL Rules to assure that untreated CDL leachate is contained and managed and not released into groundwater.

**Persons Affected.** The amendments to the rules would affect owners and operators of construction and demolition waste land disposal facilities, owners and operators of industrial waste and mixed municipal solid waste land disposal facilities, owners of companies or contractors that offer construction and demolition services, businesses or homeowners that self-haul construction and demolition debris to a land disposal facility, and property owners near the landfills.

There are about 90 active unlined CDLs distributed across Minnesota. Because most unlined CDLs are located outside of the Minneapolis/St. Paul metropolitan area, the impacts or changes will be experienced primarily in Greater Minnesota. The MPCA expects that the benefits of mitigated or reduced groundwater contamination and the cost of compliance will also be experienced more in Greater Minnesota.

Approximately 1/3 of the unlined CDLs are within 1 mile of an identified EJ community of concern according to preliminary data. The MPCA believes that more protective rules would benefit these and other nearby communities by protecting area groundwater for drinking water use and reducing exposure to pollutants. The Agency welcomes any additional information or questions regarding potential issues of concern for EJ communities associated with this potential rulemaking.

A recent review of the TMDL for the Root River Watershed—*Root River Total Maximum Daily Load Report*, which was approved in February 2017, discovered errors in total suspended solids (TSS) and *Escherichia coli* (*E. coli*) wasteload allocations (WLAs). These errors were largely due to inconsistencies in rounding or wastewater treatment facility (WWTF) design flows. In addition, two National Pollutant Discharge Elimination System (NPDES) permits have been terminated and their WLAs eliminated (MnDOT High Forest Rest Area [MN0044377] and Milestone Materials – Panhandle Quarry [MN0062804]). One NPDES permit (Great River Energy–Pleasant Valley [MN0067717]) has been determined to be an industrial stormwater discharge only and does not need a wastewater WLA because its WLA need is addressed by the categorical Industrial solid waste WLA. This Revision for the Root River 2017 TMDLs is open for written comments during the public comment period:
