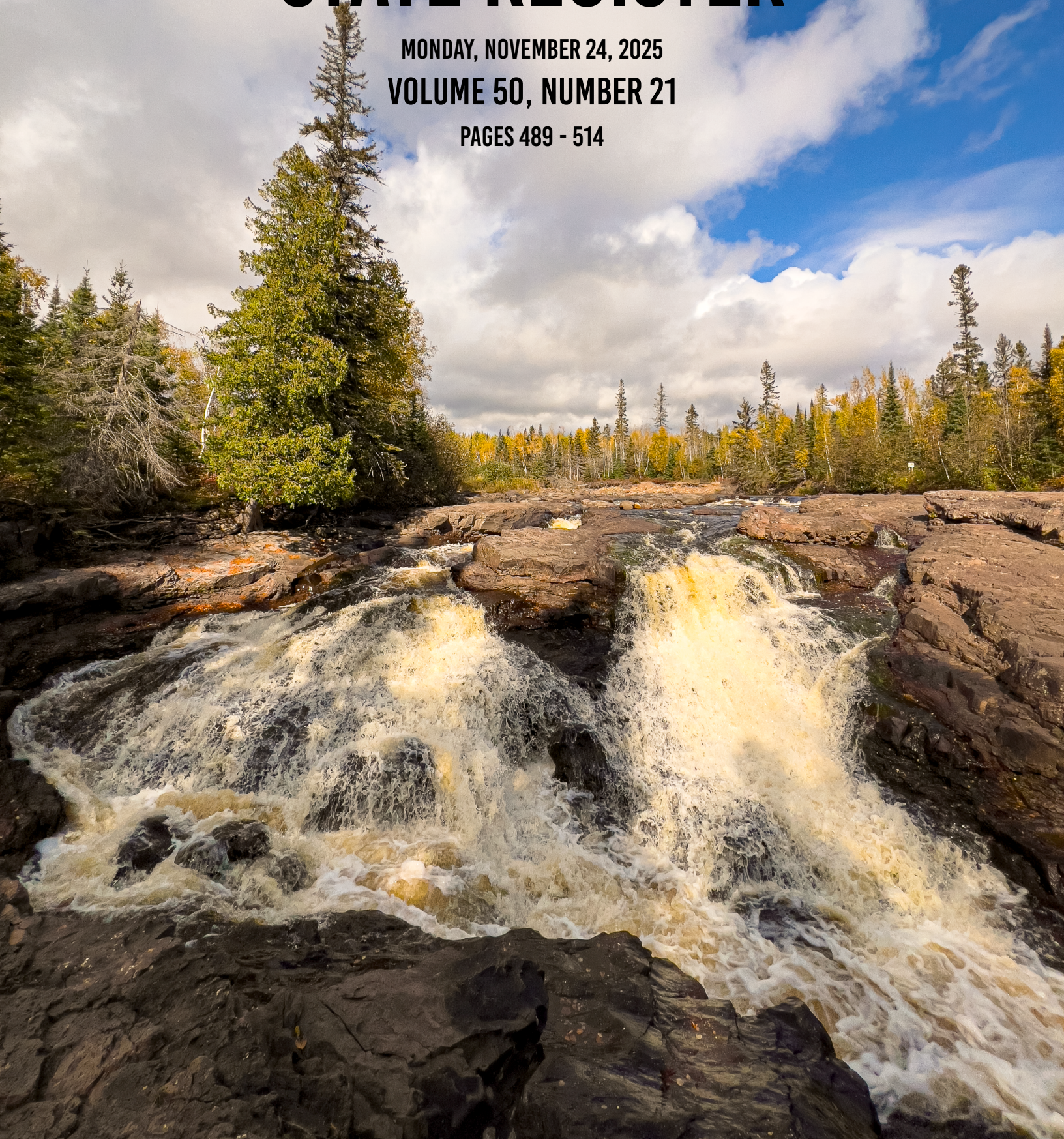

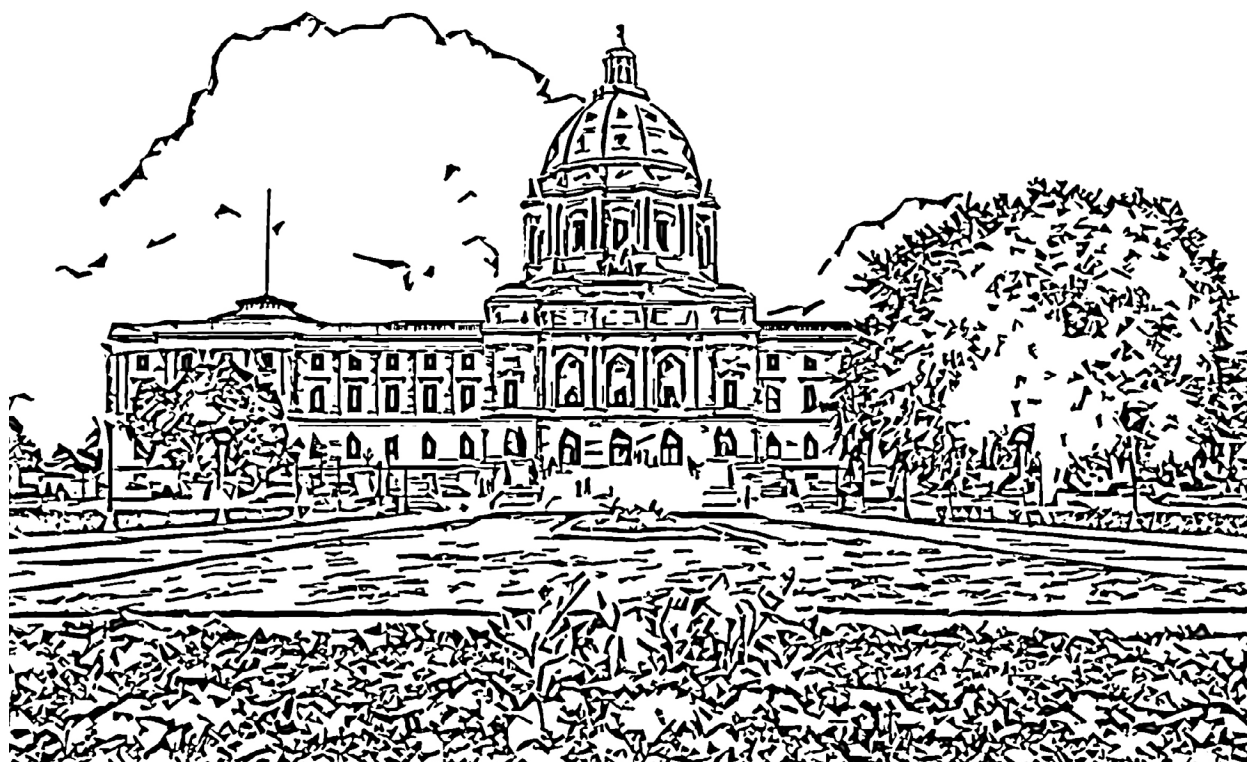

Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). A subject matter index is updated weekly and is available upon request from the editor. Expedited Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for normal rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the conditions. Expedited rules are effective upon publication in the State Register, and may be effective up to seven days before publication under certain conditions.

Expedited rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited rules detail the agency's rulemaking authority.

Proposed Expedited Permanent Rules Relating to Waste Management Capital Assistance Program; Notice of Intent to Adopt Expedited Rules without a Public Hearing

Proposed Expedited Amendment to Rules Relating to the Waste Management Capital Assistance Program, *Minnesota Rules*, Chapter 9210; Revisor's ID Number R-04815

Introduction. The Minnesota Pollution Control Agency (MPCA) intends to adopt rules under the expedited rulemaking process following the rules of the Court of Administrative Hearings (CAH), *Minnesota Rules*, part 1400.2410, and the Administrative Procedure Act, *Minnesota Statutes*, section 14.389. You may submit written comments on the proposed expedited rules until **4:30 p.m. on Tuesday, December 30, 2025**.

Subject of the Expedited Rules and Statutory Authority. The proposed expedited rules implement legislative changes to the Solid Waste Capital Assistance Program in 2023 Laws of Minnesota, chapter 60, article 3, sections 9 to 13, to update the existing Rules to be consistent with the cited Session Law. The statutory authority to adopt the rules is *Minnesota Statutes*, § 116.07, subdivisions 2 and 4. The statutory authority to adopt the rules under the expedited rulemaking process is Minnesota Laws 2024, chapter 116, article 2, section 1, subsection 32. A copy of the proposed rules is published in the *State Register*.

Comments. You have until **4:30 p.m. on Tuesday, December 30, 2025**, to submit written comment in support of or in opposition to the proposed expedited rules and any part or subpart of the rules. Your comment must be in writing and received by the Agency contact person by the due date. Your comment should identify the portion of the proposed expedited rules addressed and the reason for the comment. In addition, you are encouraged to propose any change desired. You must also make any comments that you have on the legality of the proposed rules during this comment period. If the proposed expedited rules affect you in any way, the MPCA encourages you to participate in the rulemaking process.

Modifications. The MPCA may modify the proposed expedited rules using either of two avenues: 1) The Agency may modify the rules directly so long as the modifications do not make them substantially different as defined in *Minnesota Statutes*, section 14.05, subdivision 2, paragraphs (b) and (c). Or 2) the Agency may adopt substantially different rules if it follows the procedure under *Minnesota Rules*, part 1400.2110. If the final rules are identical to the rules originally published in the *State Register*, the Agency will publish a Notice of Adoption in the *State Register*. If the final rules are different from the rules originally published in the *State Register*, the Agency must publish a copy of the changes in the *State Register*.

Alternative Format. Upon request, this information can be made available in an alternative format, such as large print, braille, or audio. To make such a request, please contact the Agency Contact Person at the address or telephone number listed above.

Lobbyist Registration. *Minnesota Statutes*, chapter 10A, requires each lobbyist to register with the State Campaign Finance and Public Disclosure Board. Adoption and Review of Expedited Rules. The MPCA may adopt the rules at the end of the comment period. The Agency will then submit the rules and supporting documents to the CAH for review for legality. You may ask to be notified of the date that the MPCA submits the rules. If you want to be so notified, to receive a copy of the adopted rules, or to register with the MPCA to receive notice of future rule proceedings, submit your request to the Agency Contact Person listed above.

9210.0100 DEFINITIONS.

Subpart 1. **Scope.** For the purposes of parts 9210.0100 to 9210.0180, the following terms used have the meanings given them in this part and Minnesota Statutes, section 115A.03, unless the context requires otherwise.

Subp. 5. **Comprehensive solid waste management plan.** “Comprehensive solid waste management plan” means a written plan prepared under Minnesota Statutes, section 115A.46, or, in the metropolitan area, under Minnesota Statutes, section 473.149.

Subp. 7a. **Household hazardous waste.** “Household hazardous waste” has the meaning given in Minnesota Statutes, section 115A.96.

Subp. 10. **On-site utilities.** “On-site utilities” means gas, electrical, water, and sewer facilities within the geographic boundaries of the waste processing facility site; that are used for facility operations, excluding transmission of energy to markets.

Subp. 13. [See repealer.]

[For text of subparts 14 and 15, see Minnesota Rules]

Subp. 16. **Recipient.** “Recipient” means an applicant who has received a grant under the solid waste ~~processing facilities~~ capital assistance program.

9210.0110 ~~SOLID WASTE PROCESSING FACILITIES~~ MANAGEMENT CAPITAL ASSISTANCE PROGRAM.

Parts 9210.0100 to 9210.0180 implement the ~~solid waste processing facilities~~ waste management capital assistance program created and described in Minnesota Statutes, sections 115A.49 to 115A.54, by establishing the substantive criteria and procedural conditions under which the commissioner may award grants for capital costs of ~~solid waste processing~~ facilities.

9210.0130 ELIGIBILITY CRITERIA.

[For text of subpart 1, see Minnesota Rules]

Subp. 2. **Eligible project.** For purposes of parts 9210.0100 to 9210.0180, “eligible project” means acquiring, establishing, or improving a waste processing facility that includes resource recovery, together with conducts waste reduction, reuse, recycling, composting source-separated compostable materials or yard waste, resource recovery, or waste processing and any transfer stations, transmission facilities, or other related and appurtenant facilities primarily serving the waste processing facility. A transfer station that will initially transfer waste to a landfill is an eligible project if the transfer station is part of a resource recovery project proposed in an approved comprehensive solid waste management plan. Examples of eligible projects include waste to energy; materials recovery; chemical, physical, or biological modifications; processing of special waste streams including household hazardous waste; and waste incineration with resource recovery. Eligible projects are limited to those in which the land, buildings, and equipment are publicly owned.

Subp. 4. **Ineligible costs.** Ineligible costs include costs related to:

- A. solid waste disposal facilities and disposal equipment;
- B. structures for housing and maintenance of rolling stock;
- C. collection equipment including drop boxes not located on the ~~waste processing~~ facility site;
- D. ~~costs related to~~ resource recovery studies, feasibility analyses, or preliminary design and engineering/architectural plans; and
- E. ~~costs of~~ leasing equipment.

9210.0131 PRELIMINARY GRANT APPLICATION.

Subpart 1. **Preliminary grant application.** A preliminary grant application must include the following information:

A. the name of each applicant and the name and qualifications of the project manager, a description of the proposed ~~waste processing~~ facility, a description of the institutional arrangements necessary for project implementation and operation, a description of the method of facility procurement, and a description of the waste and materials stream for the facility;

D. a preliminary financial plan that includes:

- (1) estimated total capital costs and total ~~grant-eligible~~ grant-eligible costs for the project;

E. a resolution from each political subdivision participating in the project that demonstrates that, if a grant is awarded, ~~it~~ the political subdivision will implement the project, provide necessary local financing, and accept and exercise the governmental powers necessary to develop and operate the project;

G. an implementation plan for the proposed project that specifies the anticipated completion dates for environmental review, Pollution Control Agency permitting, and facility construction; and the anticipated date of operation.

Subp. 2. **Completeness.** ~~The commissioner must notify applicants~~ shall be notified by the commissioner if their preliminary grant applications are not complete and ~~shall be given~~ must give applicants 30 days ~~from~~ after the notification in which to complete their applications. Extensions ~~shall~~ must be granted if requested in a timely manner and good cause exists for the extension. Applications that are not completed and received by the commissioner within the time allowed ~~shall be considered~~ are ineligible for funding.

9210.0140 FINAL GRANT APPLICATION.

Subpart 1. **Final grant applications.** Final grant applications must include the following information as required in the application forms supplied by the commissioner:

J. the type of ~~waste processing~~ facility for which the grant application is being submitted: ~~waste to energy; materials recovery; chemical, physical, or biological modification; transfer stations; processing of special waste stream including household hazardous waste; or waste incineration with resource recovery.~~

9210.0150 SUPPORTING DOCUMENTATION REQUIRED TO BE SUBMITTED WITH FINAL GRANT APPLICATION.

Applicants ~~shall~~ must submit the following supporting documentation with their final grant application:

A. a copy of the original preliminary grant application submitted under part 9210.0131;

B. a financial plan that contains:

[For text of subitems (1) to (3), see Minnesota Rules]

(4) total capital costs per ton of installed daily capacity; if applicable;

C. a report demonstrating that the project is not financially prudent without state assistance, due to the applicant's financial capacity and the problems inherent in waste management in the area. The report ~~shall~~ must include the following documentation:

(9) other characteristics of waste management in the area that render agency assistance important to the financial feasibility of the project;

D. for each county affected by the project, a comprehensive solid waste management plan, developed under Minnesota Statutes, section 115A.46, and approved by the commissioner;

E. preliminary design and engineering/architectural plans and equipment specifications of the proposed ~~waste~~

~~processing~~ facility; and a description of the management and staffing plans for the proposed project;

F. documentation explaining how ~~waste material~~ supplies will be committed to the project for the life of the project and that the applicant has mechanisms to commit the ~~wastes materials~~;

G. a market analysis of recovered materials/energy, including documentation of market commitments such as letters of intent or contracts;

H. ~~a report on~~ the status of required permits from permitting agencies;

I. ~~a report on~~ time frames of project development;

J. the project's environmental impact on climate change, including greenhouse gas emissions;

K. the project's impact on environmental justice areas, a summary of stakeholder engagement activities, and community input received; and

J. L. resolutions that comply with Minnesota Statutes, section 115A.54, subdivision 3.

9210.0170 LIMITATIONS.

Subpart 1. Maximum grant award.

A. The maximum grant award is 25 percent of the eligible capital costs of the project or ~~\$2,000,000~~ \$5,000,000, whichever is less, ~~unless the project is a recycling project or a project to compost or cocompost waste except as provided in items B and C.~~

B. A recycling project ~~or, a project to compost or cocompost~~ source-separated compostable material or yard waste, or a project to manage household hazardous waste may receive grant assistance up to 50 percent of the capital cost of the project or ~~\$2,000,000~~ \$5,000,000, whichever is less.

C. A waste reduction project or a reuse project may receive grant assistance up to 75 percent of the capital cost of the project or \$5,000,000, whichever is less.

9210.0200 ENVIRONMENTAL TESTING GRANTS.

Subp. 4. **Information on grant application.** Applications for environmental testing grants ~~shall~~ must include the following information as required in the application forms supplied by the agency:

Official Notices

Pursuant to *Minnesota Statutes* §§ 14.101, an agency must first solicit comments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.
