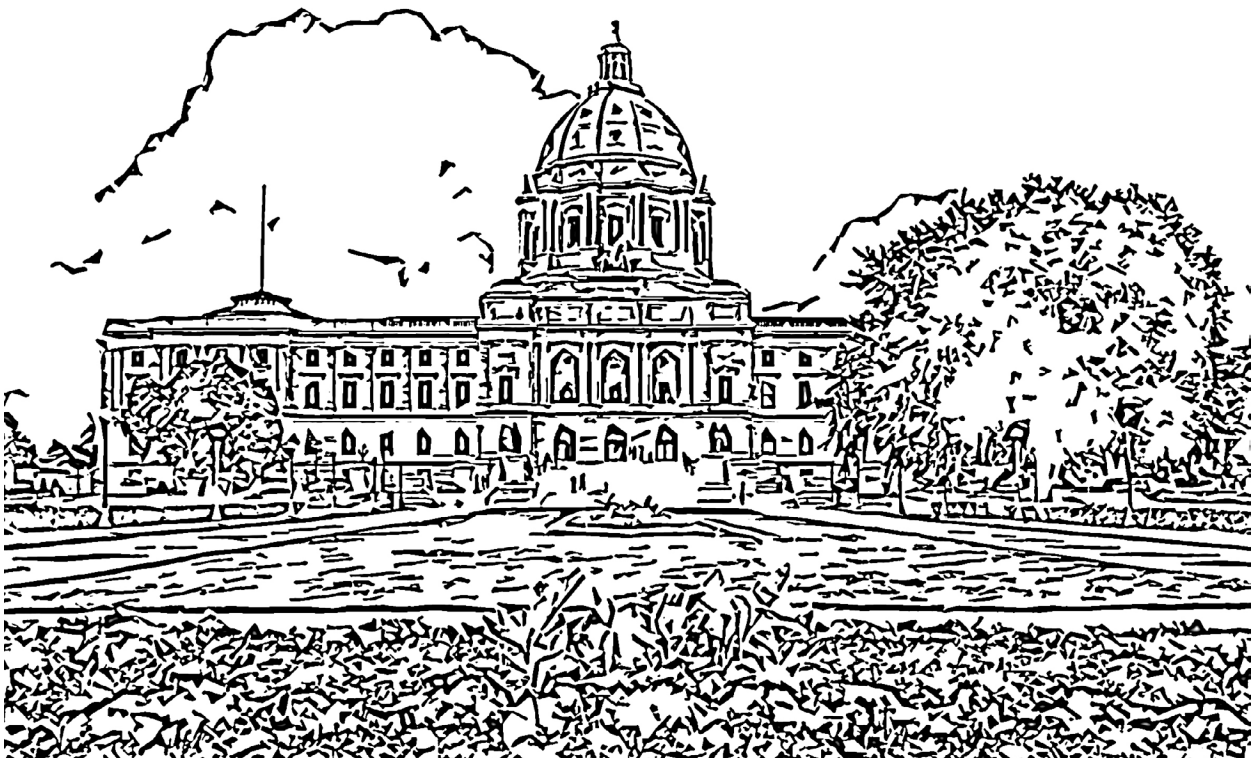

# Minnesota Rules: Amendments and Additions

## NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). A subject matter index is updated weekly and is available upon request from the editor. # Proposed Rules

**Comments on Planned Rules or Rule Amendments.** An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

**Rules to be Adopted After a Hearing.** After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

**Rules to be Adopted Without a Hearing.** Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.1414.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

**Introduction.** The Department of Education (Department) intends to adopt rules without a public hearing following the procedures in the rules of the Court of Administrative Hearings, *Minnesota Rules*, parts 1400.2300 to 1400.2310, and the Administrative Procedure Act, *Minnesota Statutes*, sections 14.22 to 14.28. However, if 25 or more persons submit a written request for a hearing on the rules by **4:30 p.m. on February 9, 2026**, the Department will hold a public hearing via WebEx video conferencing technology. The Honorable Ann O'Reilly, Administrative Law Judge, will preside.

**Hearing.** If 25 or more persons submit a written request for hearing by 4:30 p.m. on February 9, 2026, the Administrative Law Judge will conduct the virtual hearing **on March 16 and 17, 2026**. The details for joining the hearings are set forth below.

The hearing on **March 16, 2026**, will commence at **9 a.m.** and will end at 4 p.m., or when the last person present has

the opportunity to be heard, whichever comes first.

The hearing on **March 17, 2026**, will commence at **2 p.m.** and will end at 6 p.m., or when the last person present has the opportunity to be heard, whichever comes first.

NOTE: The hearings will begin promptly at the start time and will continue until the stated end time or last person present has had an opportunity to be heard, whichever comes first. Therefore, it is important to arrive at the start of the hearing.

To find out whether the Department will adopt the rules without a hearing or if it will hold the hearing, you should contact the agency contact person **after February 9, 2026, but before March 16, 2026**.

**Subject of Rules and Statutory Authority.** The proposed rules are about adding K-12 Academic Standards in Health to *Minnesota Rules Chapter 3501*. Minnesota Statutes, section 120B.021 and ***Laws of Minnesota 2024, chapter 115, article 2, section 21*** authorize the Department to adopt rules for statewide K-12 academic standards in Health Education.

Minnesota has K-12 academic standards in several legislative-required content areas, including Health. Academic standards are essential because they help identify the student learning requirements for graduation and they serve as a guide for local curriculum adoption, development, and improvement. Student mastery of the academic standards is generally measured through local assessments.

In 2024, the Minnesota Legislature directed the Department to initiate rulemaking for statewide Academic Standards in Health Education. The proposed standards are based on extensive national research, committee experience, expert guidance, discussion, and stakeholder feedback. The proposed standards were developed in consultation with the Health Standards Committee, a committee of more than 30 members, which included parents of school-age children; members of the public from across the state; licensed health teachers; licensed elementary and secondary school principals; current members of local school boards and charter school boards; postsecondary faculty teaching core subjects; representatives from the Minnesota business community; representatives from Tribal Nations, the Tribal Nations Education Committee, and communities in Minnesota, including Anishinaabe and Dakota; and current students, with input from the Minnesota Youth Council. The proposed K-12 academic standards in Health Education form the foundation of skills-based health

education by combining functional health knowledge with the development of essential health skills.

**Comments.** You have until **4:30 p.m. on February 9, 2026**, to submit written comments in support of or in opposition to the proposed rules. Your comment must be in writing and received by the due date. Commenting is encouraged. Your comments should identify the portion of the proposed rules addressed, the reason for the comment, and any change proposed. You are encouraged to propose changes to the rule. Any comments that you have about the legality of the proposed rules must also be made during this comment period.

Comments can be submitted electronically through the *Court of Administrative Hearings Rulemaking eComments website* at <https://minnesota.oh.granicusideas.com/discussions> or by U.S. Mail delivered to the agency contact person at the address set forth above. **It is strongly recommended that all comments be submitted electronically using the eComments website.** All comments submitted directly to the agency contact person will be filed on the eComments website by the agency contact person as the comments are received. You may review the proposed rules, the Statement of Need and Reasonableness (SONAR), and all comments received on the eComments website by using the link above.

**Request for a Hearing.** In addition to submitting comments, you may also request that the Department hold a public hearing on the proposed rules. You must request a public hearing in writing to the agency contact person, Catherine Rogers, at the contact information set forth above. Your request must be received by **4:30 p.m. on February 9, 2026**. You must include your name and address in your written request. In addition, you must identify the portion of the proposed rules you object to or state that you oppose the entire set of rules. Any request that does not comply with these requirements is invalid and the Department cannot count it when determining whether it must hold a public hearing. You are also encouraged to state the reason for the request and any changes you want to be made to the proposed rules. Requests for hearing received by the Department on or before February 9, 2026, will be available for review at the Department's office or on the *Department's website* at <https://education.mn.gov/MDE/dse/stds/hpe/>.

**Withdrawal of Requests.** If 25 or more persons submit a valid written request for a hearing, the Department will hold a public hearing unless a sufficient number of persons withdraw their requests in writing. If enough requests for a hearing are withdrawn to reduce the number below 25, the Department must give written notice to all persons who requested a hearing, explain the actions the Department took to cause the withdrawal and ask for written comments on this action. If a public hearing is required, the Department will follow the procedures in *Minnesota Statutes*, sections 14.131 to 14.20.

**Alternative Format/Accommodation.** Upon request, this information can be made available in an alternative format, such as large print, braille, or audio. To make such a request or if you need an accommodation to make this hearing accessible, please contact the agency contact person at the address or telephone number listed above.

**Modifications.** The Department might modify the proposed rules due to public comment or the rule hearing process. The Department must support modifications by data and views submitted to the Department or presented at the hearing. The adopted rules may not differ substantially from those proposed rules unless the Department follows the procedure under *Minnesota Rules*, part 1400.2110. If the proposed rules affect you in any way, the Department encourages you to participate in the rulemaking process.

**Cancellation of Hearing.** The Department will cancel the hearing scheduled for March 16 and 17, 2026, if the Department does not receive requests for a hearing from 25 or more persons. If you request a public hearing, the Department will notify you whether the hearing will be held before the scheduled hearing date. You may also contact the agency contact person at [catherine.rogers@state.mn.us](mailto:catherine.rogers@state.mn.us) after February 9, 2026, to determine whether the hearing will be held.

**Notice of Hearing.** If 25 or more persons submit valid written requests for a public hearing on the rules, the Department will hold a hearing following the procedures in *Minnesota Statutes*, sections 14.131 to 14.20. The Department will hold the hearing on the above date, time, and place. Administrative Law Judge Ann O'Reilly is assigned to conduct the hearing. **Hearing Procedure.** If the Department holds a hearing, you and all interested or affected persons, including representatives of associations or other interested groups, will have an opportunity to participate. You may present your views orally at the hearing or in writing at any time before the hearing record closes. All evidence presented should relate to the proposed rules. You may also submit written material to the Administrative Law Judge to be recorded in the hearing record for five working days after the public hearing ends. At the hearing, the Administrative Law Judge may order that this five-day comment period be extended for a longer period, not more than 20 calendar days. Following the comment period, there is a five-working-day rebuttal period when the Department and any interested person may respond in writing to any new information submitted. No one may submit new evidence during the five-day rebuttal period.

All post-hearing comments and responses must be submitted to the Administrative Law Judge before 4:30 p.m. on the due date. The Court of Administrative Hearings strongly encourages all persons submitting comments and responses to do so using the *Court of Administrative Hearings Rulemaking eComments website* at <https://minnesotaoah.granicusideas.com/discussions>. If using the eComments website is not possible, you may submit post-hearing comments in person, via United States mail, or by facsimile to the agency contact person identified above.

All comments or responses received will be available for public review on the eComments website and at the Department of Education. This rule hearing procedure is governed by *Minnesota Rules*, parts 1400.2000 to 1400.2240, and *Minnesota Statutes*, sections 14.131 to 14.20. You may direct questions about the procedure to the Administrative Law Judge, through William Moore, the Rules Coordinator listed above.

**Statement of Need and Reasonableness.** The Statement of Need and Reasonableness (SONAR) summarizes the justification for the proposed rules, including a description of who will be affected by the proposed rules and an estimate of the probable costs of the proposed rules. The SONAR is now available from the agency contact person. You may review or obtain copies for the cost of reproduction by contacting the agency contact person. It is available at no cost on the *Department's website* at <https://education.mn.gov/MDE/about/rule/rule/health>.

**Lobbyist Registration.** *Minnesota Statutes*, chapter 10A, requires each lobbyist to register with the State Campaign Finance and Public Disclosure Board. **Adoption Procedure if No Hearing.** If no hearing is required, the Department may adopt the rules after the end of the comment period. The Department will submit the rules and supporting documents to the Court of Administrative Hearings for a legal review. You may ask to be notified of the date the rules are submitted. If you want to receive notice of this, a copy of the adopted rules, or to register with the Department to receive notice of future rule proceedings, submit your request to the agency contact person listed above.

**Adoption Procedure after a Hearing.** If a hearing is held, the Administrative Law Judge will issue a report on the proposed rules after the close of the hearing record. You may ask to be notified of the date that the Administrative Law Judge's report will become available, and you can make this request at the hearing or in writing to the Administrative Law Judge. You may also ask to be notified of the date the Department adopts the rules, and the rules are filed with the Secretary of State by requesting this at the hearing or by writing to the agency contact person stated above.

## **3501.1500 HEALTH EDUCATION STANDARDS.**

Subpart 1. **Purpose and application.** The purpose of these standards is to establish statewide standards for health that govern instruction of students in kindergarten through grade 12.

Subp. 2. **Functional health.** The student will use functional health knowledge to enhance health and well-being.

Subp. 3. **Analyze influences.** The student will analyze influences that affect health and well-being.

Subp. 4. **Access valid and reliable information.** The student will access valid and reliable information, products, and services to enhance health and well-being.

Subp. 5. **Communication skills.** The student will demonstrate interpersonal communication skills to enhance health and well-being.

Subp. 6. **Decision making.** The student will demonstrate decision-making skills to enhance health and well-being.

Subp. 7. **Goal setting.** The student will demonstrate goal-setting skills to enhance health and well-being.

Subp. 8. **Practices and behaviors.** The student will demonstrate practices and behaviors to enhance health and well-being.

Subp. 9. **Promote health, safety, and well-being.** The student will promote health, safety, and well-being of self and others.

Subp. 10. **Apply knowledge and skills.** The student will combine content knowledge with practical skill development, as indicated by subpart 2, and apply what they learn to real-world health situations, as indicated in subparts 3 to 9, on various health-related topics, including but not limited to:

A. cardiopulmonary resuscitation and automatic external defibrillator education that allows districts to provide instruction to students in grades 7 through 12 in accordance with Minnesota Statutes, section 120B.236;

B. vaping awareness and prevention education that allows districts to provide instruction to students in grades 6 through 8 in accordance with Minnesota Statutes, section 120B.238, subdivision 3;

C. cannabis use and substance use education that allows districts to provide instruction to students in grades 6 through 12 in accordance with Minnesota Statutes, section 120B.215;

D. sexually transmitted infections and diseases education that meets the requirements of Minnesota Statutes, section 121A.23; and

E. mental health education for students in grades 4 through 12 that includes prevention of suicide or self-harm and mental health components of the National Education Association standards for students in grades 4 through 12 in accordance with Minnesota Statutes, section 120B.21.

Subp. 11. **Implementation.** These standards must be implemented by school districts by the beginning of the 2028-2029 school year.

Before any update of the PLP is adopted by the MPCA, it must be published in the State Register and a 30-day public comment period must be provided. This notice is, therefore, published to inform the public that the MPCA is proposing to update the PLP and to solicit public comment on the proposed additions.
