

Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). A subject matter index is updated weekly and is available upon request from the editor. Expedited Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for normal rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the conditions. Expedited rules are effective upon publication in the State Register, and may be effective up to seven days before publication under certain conditions.

Expedited rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited rules detail the agency's rulemaking authority.

Proposed Expedited Permanent Rule: Fishing Regulations for Inland Waters; Notice of Intent to Adopt Expedited Rules Without a Public Hearing

Proposed Amendment to Rules Governing Fishing Regulations for Inland Waters, *Minnesota Rules*, part 6262.0200; Revisor's File Number R-4929

Introduction. The Department of Natural Resources (DNR) intends to adopt rules under the expedited rulemaking process following the rules of the Court of Administrative Hearings, *Minnesota Rules*, part 1400.2410, and the Administrative Procedure Act, *Minnesota Statutes*, section 14.389. You may submit written comments on the proposed expedited rules until Thursday, March 5, 2026.

Agency Contact Person. Submit comments, questions, or a request for hearing on the rules to John Dunn, Fisheries Rules and Regulations Coordinator, Minnesota Department of Natural Resources, 500 Lafayette Road, St. Paul, Minnesota 55155, telephone 651-259-5235, or email john.dunn@state.mn.us.

Subject of the Expedited Rules. The proposed expedited rules adjust Minnesota's fishing regulations for inland waters relating to daily and possession limits for walleye and sauger.

Minnesota Rules, part 6262.0200, subpart 1, item D. The proposed change would adjust the inland waters daily and possession limit for walleye and sauger from six in aggregate to four in aggregate. With increased stressors on walleye and sauger populations, the Department of Natural Resources has concluded it would be prudent to reduce the daily and possession limits to maintain sustainable populations of these species. Minnesota Statutes, section 97C.401, subdivision 2, states "a person may have no more than one walleye larger than 20 inches in possession. This subdivision does not apply to boundary waters." The proposed rulemaking would add this provision to the rule regarding walleye possession to make it consistent with statute.

Minnesota Rules, part 6262.0200, subpart 3. The inclusion of a new subpart 3 would clarify that when Minnesota Rules, part 6262.0200, differs from rules listed in other parts, the controlling rules that take priority will be those listed in the other rule chapters (including 6262, 6264, and 6266). This change would apply to all species, not just walleye and sauger.

Statutory Authority. The statutory authorities to adopt these rules are:

- **Minnesota Statutes, section 97A.045, subdivision 1**, directs the commissioner to do all things the commissioner determines necessary to preserve, protect, and propagate desirable species of wild animals, and

- to make special provisions for the management of fish and wildlife to ensure recreational opportunities for anglers and hunters.
- **Minnesota Statutes, section 97A.045, subdivision 4**, provides that the commissioner may regulate the taking, possession, and transportation of wild animals from state and international boundary waters.
- **Minnesota Statutes, section 97C.401**, requires the commissioner to, by rule, prescribe the limits on the number of each species of fish that may be taken in one day and the number that may be possessed.

The statutory authority to adopt the rules under the expedited rulemaking process is Minnesota Statutes, section 84.027, subdivision 13a (b). The DNR is using the expedited permanent rulemaking procedure to complete the rule changes for inclusion in the 2027 fishing regulations booklet. If approved, the rule changes would go into effect March 1, 2027.

Publication of proposed rules. A copy of the proposed rules is published in the State Register and attached to this notice as mailed. A free copy of the rules is available upon request from the Agency Contact Person listed above. The proposed expedited rules may be viewed on the **DNR rulemaking webpage** at mndnr.gov/input/rules.

Comments. You have until 4:30 p.m. on Thursday, March 5, 2026, to submit written comment in support of or in opposition to the proposed expedited rules and any part or subpart of the rules. Your comment must be in writing and received by the Agency Contact Person by the due date. The DNR encourages comment. Your comment should identify the portion of the proposed expedited rules addressed and the reason for the comment. In addition, you are encouraged to propose any change desired. You must also make any comments that you have on the legality of the proposed rules during this comment period. If the proposed expedited rules affect you in any way, the DNR encourages you to participate in the rulemaking process.

Request for Hearing. In addition to submitting comments, you may also request that a hearing be held on the rules. You must make your request in writing and the Agency Contact Person must receive it by 4:30 p.m. on Thursday, March 5, 2026. Your written request must include your name and address. You must identify the portion of the proposed rules to which you object or state that you oppose the entire set of rules. Any request that does not comply with these requirements is not valid and the DNR cannot count it for determining whether it must hold a public hearing. You are also encouraged to state the reason for the request and any changes you want made to the proposed rules.

Withdrawal of Requests. If 50 or more persons submit a valid written request for a hearing, a public hearing will be held unless a sufficient number withdraw their requests in writing. If enough requests for hearing are withdrawn to reduce the number below 50, the DNR must give written notice of this to all persons who requested a hearing, explain the action the DNR took to effect the withdrawal, and ask for written comments on this action. If the DNR is required to hold a public hearing, it will follow the procedures in *Minnesota Statutes*, section 14.131 to 14.20.

Modifications. The DNR may modify the proposed expedited rules using either of two avenues: The DNR may modify the rules directly so long as the modifications do not make them substantially different as defined in *Minnesota Statutes*, section 14.05, subd. 2, paragraphs (b) and (c). Or the DNR may adopt substantially different rules if it follows the procedure under *Minnesota Rules*, part 1400.2110. If the final rules are identical to the rules originally published in the State Register, the DNR will publish a notice of adoption in the State Register. If the final rules are different from the rules originally published in the State Register, the DNR must publish a copy of the changes in the State Register.

Alternative Format. Upon request, this information can be made available in an alternative format, such as large print, braille, or audio. To make such a request, please contact the Agency Contact Person at the address or telephone number listed above.

Lobbyist Registration. *Minnesota Statutes*, chapter 10A, requires each lobbyist to register with the State Campaign Finance and Public Disclosure Board. Expedited Rules

Adoption and Review of Expedited Rules. If no hearing is required, the DNR may adopt the rules at the end of the comment period. The DNR will then submit rules and supporting documents to the Court of Administrative Hearings for review for legality. You may ask to be notified of the date that the DNR submits the rules. If you want to be so notified or want to receive a copy of the adopted rules or want to register with the DNR to receive notice of future rule proceedings, submit your request to the Agency Contact Person listed above.

6262.0200 FISHING REGULATIONS FOR INLAND WATERS.

Subpart 1. **General inland fishing regulations.** Fish may be taken in inland waters by angling during the time specified for each of the following species; however, certain waters of the state are subject to experimental or special regulations or boundary waters regulations or are closed for taking and possessing fish. When the closing date of a season falls on a Saturday, the season extends through the following Sunday.

Daily and Possession Limits

D. Walleye and sauger.

6 4 in aggregate. No more than one walleye may be over 20 inches in length.

Saturday two weeks before the Saturday of Memorial Day weekend through 11:59 p.m. the last Sunday in February.

Subp. 3. **Superseding law.** To the extent that this part is inconsistent with part 6262.0300, 6262.0500, or 6262.0575 or chapter 6264 or 6266, the provisions of part 6262.0300, 6262.0500, or 6262.0575 or chapter 6264 or 6266 supersede this part.

EFFECTIVE DATE. The expedited amendments to Minnesota Rules, part 6262.0200, are effective March 1, 2027.

Executive Orders

The governor has the authority to issue written statements or orders, called Executive Orders, as well as Emergency Executive Orders. The governor's authority is specified in the Constitution of the State of Minnesota, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

Executive Order 26-01: Preparing Resources to Provide Public Safety Assistance

I, Tim Walz, Governor of the State of Minnesota, by the authority vested in me by the Constitution and applicable statutes, issue the following executive order:

On January 7, 2026, federal immigration agents shot and killed Renee Nicole Good in south Minneapolis. This shooting immediately follows the federal government's surge of masked immigration officials in Minnesota. These agents have indiscriminately arrested people off the street, intimidated our friends and neighbors, and have now caused the loss of life. Minnesotans are feeling scared, angry, and disillusioned.

Minnesotans are exercising their Constitutional rights to express their disagreement with federal immigration enforcement policies and tactics. Federal immigration officials have increased tensions, caused chaos, and left our state less safe.

As part of ongoing planning activities, and in response to potential capacity concerns from local leaders, it is important to ensure optimal readiness in the case of changes to the public safety environment. That preparedness includes state assistance from the Minnesota National Guard. The National Guard can assist with preparation and planning activities in support of local and state law enforcement and emergency management agencies. The National Guard can also support local law enforcement efforts to protect life and property, ensure public safety, and protect freedom of speech by allowing for peaceful demonstrations.

The National Guard should undertake such public safety activities only where local law enforcement resources have been exhausted. Bringing personnel, equipment, and facilities to state active duty will allow the National Guard to continue to assist with preparation and planning work with state and local partners. It will also allow the National Guard to quickly be ready to support law enforcement activities as needed to prevent threats to public safety.

For these reasons, and to protect peace and safety, I order as follows:

1. The Adjutant General will order to state active duty the personnel, equipment, and facilities required to coordinate and support public safety and security services in communities across the State of Minnesota, at a time deemed appropriate by the Adjutant General in consultation with the Governor and for such period of time as necessary to coordinate and support public safety, security services, and law enforcement activities.
2. The Adjutant General is authorized to procure the goods and services needed to accomplish the mission.
3. The costs of this assistance will be paid from the general fund as allowed by Minnesota Statutes 2025, section 192.52.

This Executive Order is effective immediately under Minnesota Statutes 2025, section 4.035, subdivision 2, and it will remain in effect until it is rescinded by proper authority or December 31, 2026, whichever occurs first.

A determination that any provision of this Executive Order is invalid will not affect the enforceability of any other

provision of this Executive Order. Rather, the invalid provision will be modified to the extent necessary so that it is enforceable.

REQUEST FOR COMMENTS for Groundwater Protection Rule, Minnesota Rules, Chapter 1573

The Minnesota Department of Agriculture (MDA) is seeking public comments to assist the department in determining whether the *Groundwater Protection Rule, Minnesota Rules Chapter 1573*, hereinafter referred to as "Groundwater Protection Rule" is inadequate to protect the air, water, land, or other natural resources located within the state from pollution.

On September 5, 2025, the Ramsey County Second Judicial District Court judge ordered the MDA to initiate the appropriate administrative proceedings to consider and make findings whether the Groundwater Protection Rule is inadequate to protect the air, water, land, or other natural resources located within the state from pollution.

Through this public notice, the MDA is requesting the affected or interested parties to submit written public comments to assist the MDA in making its decision whether the Groundwater Protection Rule is adequate or inadequate

to protect the air, water, land, or other natural resources located within the state from pollution.

Interested parties may submit written comments within 60 days of this notice, ending on Thursday, March 12, 2026.

If you submit comments via email, you will receive a reply indicating that your comments were received. It is the responsibility of the commentator to verify that their comments were received by the closing date. The MDA is not responsible for any technical issues.

While submitting public comments, please focus on the following question.

1. Whether the rules the MDA has promulgated (chapter 1573) are adequate to protect the air, water, land or other natural resources within the state from pollution, impairment, or destruction from nitrate contamination resulting from practices regulated by the MDA or should further restrictions be extended to the karst area of Southeastern Minnesota and the coarse-textured soil area of the Central Sands to protect groundwater resources?

It is important that commenters provide substantive information on why the existing rule should or should not be changed. Comments that only focus on support for or opposition to Groundwater Protection Rule, without providing further information for the MDA to consider, will not assist the MDA in its decision making.

Groundwater Protection Rule

Implemented in June 2019, the Groundwater Protection Rule minimizes potential sources of nitrate pollution to the state's groundwater and protects our drinking water. The rule restricts the application of nitrogen fertilizer in the fall and on frozen soils in areas vulnerable to contamination, and it outlines steps to reduce the severity of the problem in areas where nitrate in public water supply wells is already elevated. The rule is intended to promote appropriate nitrogen fertilizer best management practices and to involve local farmers and agronomists in adopting the most current science-based and economically viable practices that can reduce nitrate in groundwater. Notice of Completion of Annual Health Care Quality Measures Rule Review

NOTICE: The Commissioner of Health announces that the Department of Health has completed its annual review required under *Minnesota Rules*, chapter 4654. The Department affirms that its existing quality measures will continue as the 2026 set of quality measures with no added measures.

Subject of the Rules and Statutory Authority. The Minnesota Department of Health adopted *Minnesota Rules*, chapter 4654, in December 2009 to implement part of the comprehensive 2008 state health reform law. Consistent with *Minnesota Statutes*, section 62U.02, these rules established a standardized set of quality measures that the Department uses to assess the quality of services offered by health care providers. These measures include the specific details for the data that physician clinics and hospitals must submit annually to the Minnesota Department of Health or to the commissioner's designee for public reporting. The rules also specify:

- Requirements that physician clinics and hospitals submit quality data to the Minnesota Department of Health or its designee,
- Obligations for physician clinics and hospitals to cooperate with data validation procedures,
- A restriction on health plans prohibiting them from requiring providers to use and report quality measures not included in the standardized set, and
- Annual review by the Minnesota Department of Health of existing quality measures and evaluation and adoption of new measures into the standardized set.

The commissioner is required to review the adopted quality measures annually.

Results. From 2009 until 2018, the Minnesota Department of Health updated and adopted rules governing the standardized set of quality measures through expedited rulemaking. From 2018 through early 2020, the Department developed a quality measurement framework as directed by the legislature. To do this, the Department gathered comments from a broad range of stakeholders about measurement priorities and processes, essentially mirroring the review the Department has customarily performed for its annual reviews. Additionally, the Department invited public input on the standardized set of quality measures in 2023. Through these ongoing efforts the Department decided not to add new measures for the 2019 through 2025 report years, making adopting expedited rules unnecessary. Instead, the Department issued technical guidance about the changes.

To continue to ease administrative burden, the Department did not undertake expedited rulemaking during 2025 and determined that it need only make minor modifications to existing measures to maintain alignment with local and federal measurement initiatives. In its place, the Department is issuing technical guidance for the 2026 report year that include requirements consistent with those for 2025. The Department has posted updated technical guidance for the 2026 report year on its website at <https://www.health.state.mn.us/data/hcquality/measures>.
