



Parking and Transit Options For Capitol Complex State Employees Updated July 28, 2023

General Parking Contract

Contract to park in an assigned facility up to 5 days/week, Monday through Friday at a fixed cost. Parking assignments are made on a first come, first served basis. Check the Availability tab on the [Parking webpage](#) to see which facilities currently have contracts immediately available and which facilities have waiting lists.

Monthly Cost:

Lot – \$47

Ramp – \$82

Garage – \$165

Flexible Daily Parking Contract

Contract to park in an assigned facility up to 5 days/week, Monday through Friday. This option is available to state employees on the SEMA4 payroll system. The payroll deduction for parking is based on the number of days the employee parked during the two-week service period.

Bi-Weekly Cost:

0 days parked – \$10

1 day parked – \$16

2 days parked – \$22

3 days parked – \$28

4 days parked – \$31

5 days parked – \$34

6 days parked – \$37

7 days parked – \$45

8 days parked – \$53

9 days parked – \$61

10 days parked – \$70

Flexible Daily Parking is available in Centennial Ramp Red Level and Ramp F Upper.

Note: In November, 2023, Ramp F Upper will become general parking, and Ramp F Lower will become flexible daily parking.

Parking Meters

- Parking meters to provide short-term parking. Pay stations accept debit/credit cards, bills, and coins.
- There are no in and out privileges at metered stalls. If you leave during the day, you would need to pay for parking again upon return.

Cost

\$2/hour

\$8/day

Monday/Friday Only Options

- Monday or Friday Only parking – Contract for parking one day a week, either Mondays or Fridays in select facilities.
- Monday and Friday Only parking – Contract for parking two days a week: Mondays and Fridays in select facilities.
- Monday/Friday options are available in the following facilities: 14th Street Ramp, Andersen Ramp, and Lots C, G, J, and Q.

Monthly Cost:

Monday Only or Friday Only (one day per week):

Lot – \$11

Ramp – \$19

Monday AND Friday only (two days per week):

Lot – \$20

Ramp – \$35

Metropass

Program that allows contract holders to get unlimited access to regional buses and trains.

Monthly Cost:

Subsidized for employees without a general parking contract – \$35

Unsubsidized for employees with a general parking contract – \$83

Bicycle Parking

Bike racks are located throughout the complex.

Bike lockers are located throughout the complex and are available for rental through an annual contract effective April 1 through March 30.

Bike cages are located in Ramp F and are available for rental through an annual contract effective April 1 through March 30.

Annual Cost

Bicycle Racks – No cost

Bicycle Lockers – \$50/year

Bike Cage – \$50/year

Motorcycle Parking

- Motorcycle Only contracts in these select facilities: 14th Street Ramp, Administration Ramp Level D, Andersen Ramp, Centennial Ramp Blue Level, Centennial Ramp Purple Level, Lot G, and Lot J.
- There are a limited number of motorcycle only contracts available in each facility.
- Motorcycle stickers are provided free-of-charge for General Parking Contract holders.
- Motorcycle parking is also allowed for Flexible Daily Parking contract holders.

Monthly Cost:

Lot – \$22

Ramp – \$33
