#### 1. Pertinent Procurement Information



Contract Release C-1005(5) Multi-function Device (Copiers) Equipment Rental, Purchase & Maintenance – Awards Issued to Manufacturers

Contracts on Contract Release C-1005(5) are solely with Multi-Function Device (MFD) **manufacturers**. Currently, these are Canon, HP, Kyocera, Ricoh, and Toshiba. Canon, Kyocera, and Ricoh use authorized **resellers**; HP and Toshiba do not. The C-1005(5) contract release document contains links for resellers if the manufacturer uses them.

No MFD reseller was directly awarded a contract under C-1005(5). While the State considers the resellers to be extensions of the manufacturer, the contract itself is with the manufacturer, not the reseller. A few resellers work with more than one of our contracted manufacturers. Resellers must meet all terms, conditions, and prices as manufacturers. If a reseller does not meet the contract terms in any way, that concern can be raised to OSP, the reseller, and to the manufacturer.

Contract Release C-432(5) Carpet and Resilient Flooring – 87 Counties – New Contracts Now Available Contract Release C-432(5) is available with additional contractor options and a variety of products for ordering entities. The contract's initial term is two years - January 1, 2024, through December 31, 2025. New contractors are certified TG/ED/VO and service all 87 counties. Ordering entities should note the pricing structure has changed from previous contracts. The new contracts utilize a Percentage Discount Off List Price for flooring products. Ordering entities should review quotes from contractors for accuracy in percentage application. State agencies should make every effort to use the Contractors listed, but the contract does not prohibit State agencies from using their delegated local purchasing authority to procure similar products and services from other contractors.

#### **Statewide Systems Maintenance**

To stay up to date with our statewide systems, Minnesota Management and Budget along with the Department of Administration and Minnesota IT Services are working to upgrade all statewide systems to be supported by latest version of PeopleTools. PeopleTools provides the underlying technology for all statewide applications (PeopleSoft applications).

The anticipated launch date for this project is Tuesday, February 20, 2024. We anticipate that all statewide systems will be unavailable due to the system-wide upgrade **Thursday**, **February 15**, **2024**, **starting at 6 p.m.**, **through Tuesday**, **February 20 at 6 a.m.** Please plan around this time to minimize the interruption of critical business functions. We apologize for the inconvenience.



**Important note for Buyers:** Please ensure that your events are not scheduled to start or end during this time as the Supplier Portal will also be unavailable.

**Note for Daily Interface Uploads:** The daily interfaces will only be loaded up until Thursday evening, 2/15/24, at 6:00 PM. They will resume loading to SWIFT on Tuesday

morning, 2/20/24, at 8:00 AM. All files sent in between these dates will sit in pending status on the mainframe FTP site. Agencies that send files with static filenames will need to be mindful of overwriting files that they have already sent to the mainframe FTP site but that haven't been loaded between these dates due to the upgrade.

Users must clear their internet browsing history and cache before they log into these systems on Tuesday, February 20.

If you experience difficulties trying to log in, view data, or access data in any of the statewide systems mentioned above, clearing your browsing history and cache may help resolve these issues.

#### **Procurement Fiscal Year 2024 End Cutoff Dates**

The fiscal year-end 2024 deadline established for the submission of requisitions and procurement requests for the following items is March 8, 2024:

- Request for Proposals (RFP) If the intended procurement method is to make the acquisition through a Request for Proposal (RFP), please contact the Office of State Procurement (OSP) as soon as possible to discuss the procurement and appropriate timelines.
- Agency Single Sources related to Software Licensing and/or Software Maintenance Agreements Agency Single Sources related to Software Licensing and/or Software Maintenance Agreements processed through the Office of State Procurement (OSP).
- **Construction** Construction and construction-related requisitions processed through the Real Estate and Construction Office or the Office of State Procurement. (SWIFT Policy 0901-02).
- Sealed Bids Requisitions requiring sealed bids (over \$50k) processed through Office of State Procurement.
- **Fiscal Year Close/Requisitions** Requisitions over the purchasing Agency's authority processed through Office of State Procurement (under \$50,000).

OSP encourages agencies to submit projects prior to the March 8, 2024 deadline. The 2024 Agency Annual Schedule is now available on Minnesota Management Budget's <u>Budget and Accounting Instructions webpage</u>.

## Reminder: DON'T BECOME A VICTIM: Phishing and Spoofing Emails Targeting Public Procurement – Staying vigilant and aware and is vital.

The communications look official and often contain the name of a current/past state or government employee. The communications may incorporate fake purchase orders or quotes using what appears to be State employee email addresses to cause the vendor to ship product that was never legitimately ordered.

Please be vigilant and remember to never click on questionable links within an email, even if it appears to be coming from a state employee. #### **OEP Diverse Spend Reports Using the EPM Data Warehouse**


Did you know that the EPM Data Warehouse can help your agency track supplier diversity spending to meet the Governor's Equity Procurement Goal?


Please register for it in Learning Management. It is considered an Open Lab for the EPM Data Warehouse. In Find Learning, search for it using "SWIFT Open Lab."



#### **SWIFT UPDATE REMINDER: Late Payments on Purchasing Card Statements**

US Bank charges late fees on past due purchasing card (PCard) accounts. Agencies are invoiced in the amount of up to one percent (1%) per month on the amount overdue, or a minimum of \$2.00. Late fees are included on your monthly statement from US Bank and available to view in SWIFT. However, the Late Payment transaction cannot be reconciled the same way other transactions are reconciled.

To pay a late fee associated with a PCard statement, agencies must manually add this fee to their monthly PCard voucher by adding a line and entering the information. Make sure to enter Late Payment Charge in the Description field. In the Account field use Expense code 430008 (Interest Pd To Vend Late Pymt). After the line has been added, provide the voucher number to Angie Brandt, and she will remove the transaction from the PCard pages.



As a reminder, pay PCard statements on time to avoid potential late fees, take advantage of available rebates, and avoid potential violations of Minn. Stat. § 16A. Purchasing Policy 1b requires that Purchasing Card Coordinators use Access Online to review statements and monitor account activity.

## Still in effect - Contract Coordinators - State divestment and prohibition on new acquisitions from Russian and Belarusian entities - Bill HF 4165

<u>This bill</u> passed both the Minnesota House of Representatives and Senate and was signed by Governor Walz. If you currently have Russian or Belarusian vendor contracts (according to the law, they must be headquartered or have their principal place of business in Russia or Belarus) the bill requires that all state agencies promptly terminate existing

contracts and must refrain from entering into new contracts (RFP/RFB proposals/bids from Russian and Belarusian entities should be rejected) unless the head of the state agency determines that there is no suitable alternative. Agencies are encouraged to consult with the Department of Administration's Office of State Procurement, their agency general counsel, or the Attorney General's Office about any legal compliance questions.
