ORDER TO RESCIND  
REVOCATION OF ARCHITECT'S LICENSE AND  
CID CERTIFICATE

1. On December 15, 2006, the Board of Architecture, Engineering, Land Surveying, Landscape Architecture, Geoscience and Interior Design ("Board") revoked the Architecture License and Certified Interior Design Certificate of Ronald L. Hernandez ("Respondent"), based upon the Board's receipt of notification from the Minnesota Department of Revenue ("Department") that Respondent owed delinquent taxes, penalties or interest.

2. On December 3, 2008, the Board received a notice from the Department that Respondent had been issued a clearance certificate under the authority of Minnesota Statutes section 270C.72 (2008). The Department informed the Board that Respondent does not owe the State of Minnesota any uncontested delinquent taxes, penalties or interest and has filed all required forms.

Based on the evidence presented, the Board issues the following:

**ORDER**

1. IT IS HEREBY ORDERED that the Architecture License and Certified Interior Design Certificate Revocation Order issued to Respondent on December 15, 2006 is hereby RESCINDED and shall have no further force and effect.
