FEE SCHEDULE

1. Per Diem Fee:

A basic per diem fee is charged at the rate of \$1800.00 for each day of hearing, study, or writing. The full per diem fee is charged for all hearing days. More than one day's per diem may be charged and prorated where the day of hearing and travel extends beyond 9:00 A.M. to 5:00 P.M. Study and writing which do not take a full day are pro-rated accordingly.

2. Docketing Fee:

A \$900.00 docketing fee will be charged if the case is cancelled at any time after docketing. If an additional day of hearing is needed, a second \$900.00 docketing fee will be charged for the additional day of hearing.

3. Expenses:

All travel expenses involving airline, hotel, meals, cabs, etc., will be billed from 3010 Minnehaha Parkway, Minneapolis, Minnesota 55406. Car mileage for personal car is billed at the IRS rate.

4. Travel Time:

Travel which occurs outside the actual day of hearing is pro-rated at the per diem rate.

5. Cancellation Fee:

A cancellation fee of \$1800.00 (plus docketing fee(s)) will be charged for any cases cancelled thirty-five (35) calendar days or less before the hearing.
