The per diem fee applies per day for hearing, study and preparation of the opinion and award. There is no charge for travel time. A hearing day is any portion of a day up to eight hours. Study and preparation time is prorated based on an eight-hour day. This fee schedule applies equally to grievance arbitration, interest arbitration, fact-finding and mediation.

Cancellation Policy: One per diem fee is charged for each scheduled hearing day cancelled on advance notice of less than 21 calendar days.

Expenses: Charges are in addition to my per diem fee for reasonable actual expenses associated with air and ground transportation, lodging and meals, if any, from St. Paul, MN. Mileage is charged at the applicable IRS rate for use of a personal automobile on trips outside of a 25 mile radius from St. Paul, MN. (10/29/13)
