#### **EXECUTIVE SESSION**

On the recommendation of the Complaint Resolution Committee, the Board adopted an Order of Unconditional License in the matter of David Andros, MS, LP.

#### **PUBLIC SESSION**

Board Chair, J. Hovland, called the public session to order at 9:40 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

# 1. Minutes of the Meeting of December 13, 2002.

M. Farinacci moved, seconded by S. Hayes, that the minutes of the meeting of December 13, 2002 be approved as amended. Voting "aye": M. Farinacci, S. Hayes, R. Maves, J. Peterson, N. Ruiz, J. Schaffer, M. Seibold, and S. Terhune. Voting "nay": none. Abstaining: J. Romano. There being eight ayes and no nays, motion carried unanimously.

#### 2. Administrative Matters.

# a. Rules Committee Update.

J. Schaffer reported that the Rules Committee had not met since the special Board meeting on January 10, 2003, therefore there was no update to report.

# b. Legislative Committee Update.

- N. Ruiz updated the Board on the progress of the Legislative Committee:
- 1. **All Bills.** Dr. Ruiz reported that Senator Linda Higgins will be authoring the Board's bills in the Senate. N. Ruiz and L. Sherry are still working on obtaining a House sponsor.

- 2. **Emeritus Registration Bill.** MPA Past President Myra Barrett contacted Dr. Ruiz to clarify whether a licensee who has been the subject of an Agreement for Corrective Action (ACA) could register emeritus under the Board's proposed bill. The Board agreed by consensus that licensees who successfully complete an Agreement for Corrective Action could be granted emeritus status, but that licensees who have had a disciplinary action taken against their license would not be eligible.
- 3. Crimes Against Providers Bill. As a result of contacts he had received, Dr. Ruiz initiated a discussion of the language of the proposed bill, which would add a provision to the Psychology Practice Act allowing providers to disclose their relationship with a client and other limited private information about a client who committed or is suspected of committing a crime against a provider. The bill allows such limited disclosure to law enforcement in order to allow that agency to investigate the alleged crime. Dr. Ruiz reported that the Minnesota Psychological Association (MPA) and the legislators he had spoken to did not have concerns about the bill, although Representative Fran Bradley suggested that he check with other mental health organizations to determine whether they had any concerns.
- J. Hovland suggested that the term "crime" may be too broad and J. Schaffer questioned whether providers would be able to report incidences that were not actually crimes, thus violating client privacy unnecessarily. N. Hart clarified that when reviewing breach of privacy complaints, Complaint Resolution Committees (CRC) would use the "good faith" standard to consider the appropriateness of any reports under this law. J. Romano proposed that Mr. Hart go through any written correspondence received point-by-point to determine whether there are concerns that the Board should investigate more thoroughly. Mr. Hart said that he had reviewed the correspondence received and had not discovered any such concerns, but would review it again if the Board wished. N. Ruiz and S. Terhune suggested that the language regarding the types of crimes should be more limited.
- R. Maves moved and J. Peterson seconded that the Board withdraw the proposed bill to add Minn. Stat. 148.977 Crimes Against Providers. Voting "aye": M. Farinacci, S. Hayes, R. Maves, J. Peterson, N. Ruiz, M. Seibold, S. Terhune. Voting "nay": J. Romano. There being seven ayes and one nay, motion carried.
- 4. Bill to Amend the Definition of the Practice of Psychology. J. Romano moved and S. Hayes seconded the removal of the phrase "including the academic evaluation of students" from Subdivision 5, paragraph (1) of the proposed bill. J. Romano believes that the phrase allows for regulation of the grading of students. J. Schaffer explained that that is not the intent; rather, the phrase would prevent teachers from taking advantage of students they evaluate but do not teach, such as sitting on a student's dissertation committee. Voting "aye": S. Hayes, R. Maves, J. Peterson, J. Romano, N. Ruiz, J. Schaffer, M. Seibold, S. Terhune. Voting "nay": M. Farinacci. Abstaining: J. Hovland. There being eight ayes and one nay, motion carried.
- J. Romano suggested that the word "counseling" be removed from Subdivision 5, paragraph (4) of the proposed bill. J. Romano moved and J. Hovland seconded that the

word "counseling" be stricken from the definition. Voting "aye": J. Hovland, M. Seibold, S. Terhune, and J. Romano. Voting "nay": N. Ruiz, S. Hayes, M. Farinacci, and J. Schaffer. Abstaining: J. Peterson and R. Maves. There being four ayes and four nays, motion failed for lack of a majority.

The Board agreed by consensus to remove the comma following the word "services" from Subdivision 5, paragraph (5).

5. Examination/Evaluation of Impaired Psychologists Bill. N. Ruiz reported that Senator Yvonne Prettner Solon asked whether the Board has a definition of "just cause". N. Hart reported that in order to determine just cause, a CRC would use a reasonable person's standard, which is defined by judicial interpretation. The "just cause" language is used in the language of similar laws in the practice acts of other health licensing Boards.

# c. Board Member Resignation.

P. Walker-Singleton reported that Jane Schneeweis submitted her resignation from the Board of Psychology.

# d. Selection of an Alternate Representative to HPSP's Program Committee.

J. Hovland volunteered to be the Board's alternate representative to HPSP's Program Committee once the current alternate's, R. Maves' Board term expires.

# e. Licensed Psychological Practitioner (LPP) Licensure for Independent Practice.

W. Robiner, on behalf of Minnesota APA-Accredited Psychology Internship Centers (MAAPIC), presented concerns about the Board's efforts to change the statute allowing for the independent practice of psychology by LPP's after 3000 hours of supervised post-licensure practice and endorsements by supervisors. Dr. Robiner stated that the group believes:

- That the psychological community will not support the independent practice of Licensed Psychological Practitioners.
- That the Board exists to regulate the practice of psychology, not to be an advocate for any one group.
- That this is not an issue of preventing master's level practitioners; they just believe that persons licensed at that level should be supervised.
- That competency and quality of practice is lesser in master's versus doctoral-trained practitioners. He pointed out the difference in the training of master's and doctoral level practitioners.
- That the entry level educational requirement for the independent practice of psychology should be a doctoral degree.

Dr. Robiner suggested that the Board reconsider the proposal and not lower the quality of psychological services offered in Minnesota.

J. Hovland called for a straw vote on whether the Board should move forward with the proposed legislation to create an independent level of licensure for Licensed Psychological Practitioners. Voting "aye": M. Farinacci, S. Hayes, J. Hovland, R.

Maves, J. Peterson, J. Romano, N. Ruiz, M. Seibold. Voting "nay": J. Schaffer, S. Terhune. J. Peterson moved and N. Ruiz seconded that the straw vote be made official. Voting "aye": M. Farinacci, S. Hayes, J. Hovland, R. Maves, J. Peterson, J. Romano, N. Ruiz, M. Seibold, J. Schaffer, S. Terhune. There being ten ayes and no nays, motion carried unanimously.

# f. Communication Committee Update

S. Hayes reported that the Board's website is published and the staff has reported a noticeable benefit. Ms. Hayes suggested that the staff start to track the usage of the site and start advertising the website to the public. J. Schaffer reported that he notified ASPPB of the Board's website.

- J. Romano moved, seconded by J. Peterson, to approve the six-month time-limited variance to complete continuing education requirements on the basis that Licensees have met the rationale for the rule, adherence to the rule would impose an undue burden on Licensees, and that granting the variances is unlikely to adversely affect the public welfare. Voting "aye": M. Farinacci, S. Hayes, R. Maves, J. Peterson, J. Romano, N. Ruiz, J. Schaffer, M. Seibold, and S. Terhune. Voting "nay": none. There being nine ayes and no nays, motion carried unanimously.
- **b.** Thomas D. Patenaude, PsyD, LP (LP4261) requested a waiver of the Special Assessment Late Fee. Dr. Patenaude states that he requested and received a waiver on August 10, 2001. After researching the Board Meeting Minutes, of August through December 2001, there was no evidence of a Request for Waiver from Dr.

Patenaude on the agenda. Dr. Patenaude states that he did not received the initial invoice and submitted his envelopes for the 2<sup>nd</sup> invoice and the waiver request. The addresses on these envelopes, what the board has on file, and what he is using as a return address now are the same, there has been no change of address since he was licensed on November 3, 2000. M. Farinacci moved and J. Schaffer seconded denial of the waiver request from Thomas Patenaude, PsyD, LP on the basis that Licensee did not meet his burden to prove that adherence to the rule would impose an undue burden on Licensee and that granting the waiver is unlikely to affect the public welfare. His address is correct in both the LM (current) and LMS (old) computer systems. J. Schaffer moved and M. Farinacci seconded denial of the waiver request from John P. Robertson, Ph.D, LP on the basis that Licensee did not meet his burden to prove that adherence to the rule would impose an undue burden on Licensee and that granting the waiver is unlikely to affect the public welfare. Voting "aye": M. Farinacci, R. Maves, J. Peterson, J. Romano, N. Ruiz, J. Schaffer, M. Seibold, and S. Terhune. Voting "nay": none. There being nine ayes and no nays, motion carried unanimously.
- d. Karen J. Black, MS, LP (LP1191) requested a waiver of the late renewal fee. The Board office received the application for her December 2002 license renewal from Ms. Black on January 2, 2003. It was postmarked on 12/31/02. Attached to her application was a check in the amount of \$250.00 instead of the required fee of \$500.00. On January 2, 2003, her completed form and check were mailed back to her with instructions that the total amount due is \$750.00, which includes the \$500 renewal fee and the late renewal fee of \$250. M. Farinacci moved and N. Ruiz seconded denial of the waiver request from Karen J. Black, MS, LP on the basis that Licensee did not meet her burden to prove that adherence to the rule would impose an undue burden on Licensee and that granting the waiver is unlikely to affect the public welfare. - e. Sandra M. Proehl, MS, LP (LP0477) requested a waiver of the late renewal fee. Licensee states that she has moved, however, the Board's records show that the address in our system is the same as the designated address Ms. Proehl provided on her November 2000 renewal form. There is no change of address on file and her renewal form was not sent back to us as undeliverable. In addition, Ms. Proehl states that she suffered a decrease in income for seven weeks due to being assaulted and that she is still under treatment. J. Schaffer moved, seconded by M. # **PUBLIC SESSION**

Board Vice Chair, N. Ruiz, called the public session to order at 9:45 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minnesota, and a quorum was declared present.

### 1) Approval of Minutes

- a) Minutes of the Special Board Meeting of January 10, 2003.
  - J. Romano moved, seconded by J. Peterson that the minutes of the Special Board meeting of January 10, 2003 be approved. Voting "aye": M. Farinacci, S. Hayes, R. Maves, J. Peterson, J. Romano, J. Schaffer, M. Seibold, and S. Terhune. Voting "nay": none. There being eight ayes and no nays, motion carried unanimously.

# b) Minutes of the Board Meeting of January 24, 2003.

J. Romano moved, seconded by M. Seibold that the minutes of the meeting of January 24, 2003 be approved. Voting "aye": M. Farinacci, S. Hayes, R. Maves, J. Peterson, J. Romano, J. Schaffer, M. Seibold, and S. Terhune. Voting "nay": none. There being eight ayes and no nays, motion carried unanimously.

# c) Minutes of the Special Board Meeting of February 14, 2003.

J. Romano moved, seconded by S. Hayes, that the minutes of the Special Board meeting of February 14, 2003 be approved. Voting "aye": M. Farinacci, S. Hayes, R. Maves, J. Peterson, J. Romano, M. Seibold, and S. Terhune. Voting "nay": none. Abstaining: J. Schaffer. There being seven ayes and no nays, motion carried unanimously.

# 2) Administrative Matters.

# a) Rules Committee Update.

J. Schaffer provided an update on the progress of the Rules Committee. He reported that there has been one Rules Committee meeting since the last Board meeting and that a meeting is scheduled for March 7, 2003, following this Board meeting. Generally, the Committee has been trying to react to the Board's comments about the rules and making the necessary changes. At its last meeting, the Rules Committee discussed the requirements for the supervisor of an individual obtaining post-degree supervised employment leading to licensure as a licensed psychologist. The question under discussion was whether the supervisor should be required to be discipline-free. Dr. Schaffer also reported that there is to be a "Summit Meeting", about the appropriateness of therapists doing forensic evaluations for their therapy clients. The meeting will include discussion between the Public Advisory Committee (PAC), Rules Committee, and some invited guests, including Gerald Kaplan and Scott Terhune.

# b) Legislative Committee Update.

L. Sherry provided the update on the Legislative Committee. She reported that all four bills have been introduced in the Senate and have passed the Health and Family Security Committee. The bills on the definition of the practice of psychology and supervision were referred to the floor of the Senate. The bill allowing the Board to require mental, physical, and chemical dependency examinations and evaluations passed the Judiciary Committee and was referred to the Senate floor. The bill allowing the Board to grant emeritus status still needs to be heard by the Finance Committee in the Senate, and as of yet, no date has been set for a hearing before that Committee. She also reported that the Board has found authors and co-authors in the House and that all of the bills will be combined and introduced as one bill in the House. Representative Duke Powell, a newly elected member, will serve as chief author in the House.

P. Walker-Singleton reported that the bill to license Professional Counselors had a hearing in the Senate Health and Family Security Committee. At the hearing author, Senator Sheila Kiscaden, offered an amendment to combine into one Board the Board of Psychology and the Board of Licensed Professional Counselors. However, she later withdrew the amendment.

# c) Report on ASPPB's 2003 Mid Winter Meeting.

J. Schaffer reported that there were two large issues at the meeting. The first was ASPPB's Code of Conduct. There were two questions posed regarding this issue:

1) Is the ASPPB code out of date? and 2) Should ASPPB drop the code or try to revise it if it is out of date? The presentation at the meeting concluded that ASPPB's code is outdated; APA's code now meets ASPPB's satisfaction.

The other main issue was competence. Dr. Schaffer reported that Saturday's discussions centered on what is competence and how should Boards regulate competence. In addition, there were discussions on e-therapy and emerging trends in litigation. That session focused on obtaining informed consent for e-therapy; in regard to e-therapy across jurisdictional lines, where should the provider be licensed; who has jurisdiction, the provider's state/province or the client's state/province; confidentiality concerns; how to charge for psychological services.

- J. Peterson reported on a session that made a comparison between APA's ASPPB's and the Canadian Code of Conduct. Mr. Peterson observed that the Canadian Code stresses negotiation and interpersonal relationships in the process of settling disciplinary cases. He also stated that the conference offered information about HIPAA, which goes into effect in April. If state codes are more restrictive and allows greater access to records, state codes prevail. Mr. Peterson reminded the Board that New Mexico allows psychologists to prescribe medication; the Wyoming House of Representatives has passed prescribing privileges for psychologists, but the Senate had not at the time of the conference. He reported that at the conference, J. Hovland described the Minnesota Board's legislative agenda.
- S. Terhune reported that the consensus at the conference was that APA accreditation addresses competence, but not necessarily specific coursework.

# d) Analysis of FY 04-05 Budget.

P. Walker Singleton provided an analysis of how the Governor's proposed budget, which is designed to reduce the state's \$4.5 billion shortfall, affects this state agency. She reported that because of the state's General Fund shortfall, Governor Pawlenty has proposed a plan to balance the state's budget by the end of the 2004-05 biennium. The health licensing Boards submitted three budget proposals during the budget planning phase last fall, with the full knowledge that the Governor's plan would use one of them, or reject all of them and substitute one of his own. The plan he chose keeps the Board of Psychology's spending authority in line with the FY 2003 budget.

However, the Governor's plan depletes the health licensing Boards' reserves, which are held in the State Government Special Revenue Fund by transferring our reserves to the General Fund to help balance that deficit. The State Government Special Revenue Fund is the account into which the Boards' revenue is deposited and is made up of licensure and other fees we collect for the services that we provide.

This Board has developed a plan to significantly under spend during the balance of FY03, which ends on June 30, 2003, and to cut spending during FY04-05. The projected net effect is to stretch out the time before the Board of Psychology will have to raise fees to replace our portion of the reserves transferred to the General Fund. This cut in spending should also have the effect of decreasing the amount of any eventual fee increase.

Board members instructed staff to inform licensees of this situation by posting information on the website.

# A) Minutes of the Board Meeting of March 7, 2003.

# III) Administrative Matters.

# A) Rules Committee Update.

- ◆ J. Hovland reported that S. Albert has resigned as chair of the Rules Committee and J. Schaffer will assume the role of chair. She also reported that J. Romano and S. Terhune will now join as members of the Rules Committee.
- ◆ J. Schaffer reported that there had not been a Rules Committee meeting since the last Board Meeting, but there is one scheduled to follow this Board meeting.

# B) Legislative Committee Update.

P. Walker-Singleton made the following report on behalf of the Legislative Committee:

### **Board of Psychology Bills**

◆ HF865 (Exams), HF866 (Emeritus), HF867 (Supervision), HF868 (Definition-Practice of Psychology) was combined in the House into HF865 by author, Representative Duke Powell. It met committee deadline and was referred to the floor of the House.

SF215 (Definition-Practice of Psychology), SF217 (Supervision), and SF328 (Exams) met committee deadline and has passed on the floor of the Senate. SF216 (Emeritus) was referred to Health and Human Services & Corrections Budget Sub-Committee and was heard by the Committee on Wednesday, 09 April 03. The Sub-Committee passed SF216 and re-referred it to the full Finance Committee. Our author in the Senate is Senator Yvonne Prettner Solon.

The House has now renumbered the package as SF217 and will await floor action in the House until the Chief Clerk's office compares the language in the House and Senate versions. When the comparison is done, and the combined bill passes on the House floor, it will be sent back to the Senate to be passed as one bill. At that point, the bill will be sent to the Governor for his signature.

#### **Bill to License Professional Counselors**

- ♦ HF230 is authored by Representative Jim Abeler; SF304 is authored by Senator Sheila Kiscaden.
- Both bills have passed all policy committees in both Houses by the final deadline.
- ◆ HF230 has been referred to the House Ways and Means Committee and SF304 has been referred to the Senate Finance Committee because each version of the bills contains an appropriation. Both of these finance-related Committees can hear the bills after the deadline (11 April 2003) without killing the bills.

#### **Other Related Bills**

- ♦ SF844/HF871 was handed out for Board members' information. This bill provides for certification of eligibility for disability benefits by a licensed psychologist. It amends three state retirement acts to add psychological evidence as a reason to support retirees' claims for disability benefits. The acts that are amended are: Minnesota State Retirement, Teachers retirement, and the Teachers Retirement-Certain Cities Acts. As of the date of the Board meeting, the bill was still in policy committees in both Houses.
- ♦ SF1106/HF1210 provides for reorganization of state government establishing the positions of governor's secretaries, (instead of commissioners), assigns their powers, and assigns state agencies to each secretary. The health licensing Boards (HLBs) had been assigned to the Secretary of Health and Human Services. The author in the Senate (Ranum) offered an amendment removing the HLBs from the bill and the amendment passed that Committee in the Senate. So for the time being, the HLBs are out of the Senate version of the bill. However, as of the date of the Board meeting, the bill had not been heard in all of the policy committees in either House.

- ♦ The Executive Directors of the Boards of Marriage and Family Therapy, Social Work and Psychology met with Representative Linda Boudreau in response to a report that Representative Boudreau was interested in a bill that would combine the three Boards. Representative Boudreau stated that she has not nor does she plan to introduce such a bill during this legislative session.
- ♦ N. Hart reported that there were proposed amendments to MN Statute 144.335, Access to Health Records that could affect the Board. One amendment specifies that parents do have access to the health records of their minor children. The other amendment says that when a family member is involved in a patient's mental health care that they can access the patient's records without written authorization.

# C) ASPPB's Call for Nominations.

• P. Walker-Singleton reported that the Association of State and Provincial Psychology Boards (ASPPB) sent their annual Call for Nominations for ASPPB Board of Director membership and officers, for their various awards, and for ASPPB fellow. M. Farinacci moved, seconded by S. Hayes, that Jack Schaffer be nominated for one of the ASPPB Board of Director's Member-at-Large position. Voting "aye": M. Farinacci, S. Hayes, R. Maves, J. Peterson, J. Romano, J. Schaffer, M. Seibold, and S. Terhune. Voting "nay": none. There being eight ayes and no nays, motion carried unanimously.

# B) Variance Request.

These forms, completed by the applicant's primary supervisors demonstrate the applicant meets the post-degree supervisory experience requirements of MN Rule 7200.0600 D. and 7200.0800. Applicant requested that the Board accept the supervisory verification forms from the other states since the supervisor is unavailable to complete Minnesota's forms.   - The *third* subject is the issue of forensic treatment in conjunction with forensic assessments.
  - The *fourth* subject is psychologists using psychometricians to administer tests. This is a topic for discussion by the Rules Committee because of recent events in

other jurisdictions, in which actions were brought against neuropsychologists alleging aiding and abetting unlicensed practice of psychology because of the psychologists' use of psychometricians. The committee will consult on this issue with a Minnesota neuropsychologist, David Tupper, PhD, LP. Dr. Tupper will attend the Rules Committee meeting that immediately follows the Board meeting.

◆ The Board requested that they have a final review of the licensure rules at the June meeting, provided that the Committee finishes the mobility rule language.

# B) Legislative Committee Update.

- ◆ L. Sherry reported to the Board on the following legislative issue: All four of the Board's bills (definitions, supervision requirements, exams, and emeritus status) passed the House on May 12, 2003 as HF328. They will proceed to the Senate as a package.
- ◆ P. Walker-Singleton provided an update on the Counselor Bill. Language was added to the bill that would have combined Licensed Professional Counselors with Alcohol and Drug Counselors and Marriage and Family Therapists under one Board. At a hearing before the House Ways and Means Committee, the Board of Marriage and Family Therapists objected to their inclusion and that Board was taken out of the amendment. The Board of Psychology was asked to write a new fiscal note to describe the fiscal impact on this Board sharing administrative duties with a combined Licensed Professional Counselor and Alcohol and Drug Counselor Board. (The original fiscal note anticipated shared administrative services by the Board of Psychology and the Board of Licensed Professional Counselors without the addition of Alcohol and Drug Counselors.)
- ♦ P. Walker-Singleton asked the Board of Psychology to determine whether it is willing to continue a collaboration with the Licensed Professional Counselor Board, since the bill language has been changed from the original form the Board of Psychology reviewed, to language including responsibility for the licensure and regulation of Alcohol and Drug Counselors. The Alcohol and Drug Counselors are currently regulated by the Minnesota Department of Health.
- ♦ J. Peterson moved, seconded by J. Romano that the Board compose a letter to the Minnesota Association of Counseling and Development (MACD) that emphasizes the Board's continued willingness to support mid-level mental health licensing in the State of Minnesota, but opposes adding additional groups for regulation by the Counselor Board, if it is to receive administrative support by this Board. The letter should reaffirm the Board of Psychology's original position to support counselor licensure in this state and to share administrative support with the Board of Licensed Professional Counselors if regulating that profession only. The Board of Psychology has not anticipated nor has it considered the fiscal or administrative impact of administering other professions. The letter was to ask the MACD to remove the clause requiring that the newly formed Board share administrative services with the Board of Psychology, if other regulated group(s) remained in the bill. The letter was to remind the MACD that the Board of Psychology cooperated fully with its efforts to pass the counselor bill in the form originally presented when MACD asked the Board of Psychology for its support; that is, without the addition of other groups to regulate. The Board also determined that the letter should state that and the Board of

Psychology would have considered forming an advisory counsel to participate in the regulation of Licensed Professional Counselors, but was not asked to do so.

#### B) Rules Committee Update.

The Committee members reported that there was no update to provide at this time. A six-hour meeting is scheduled for August 18, 2003.

#### C) Legislative Committee Update.

• P. Walker-Singleton reported that there was a planning meeting between individuals working on the formation of the Board of Behavioral Health and Therapy (BBHT), staff of the Administrative Services Unit, and staff from other health licensing Boards.

♦ She also reported that the Governor's office is still accepting applications for Board members for the BBHT.

# D) Communications Committee Update.

- S. Hayes reported that the first focus of the Communications Committee, the website, is up and running and is being updated, as needed.
- ◆ The Committee is moving into its second phase which will be a short newsletter. The newsletter will be published twice per year at first and later move to a quarterly publication. The plan is that it will consist of an overview of what has happened in the past year, statistics and graphs with information about licensees, and possibly a short self-test about the Board and its work.

P. Walker-Singleton asked the Board to consider authorizing the staff to request whether providers would like to make a designation of another professional to coordinate continuity of care on a volunteer basis at this time.
- ◆ J. Romano moved, seconded by S. Terhune, to authorize staff to begin collecting the names of designees from licensees to coordinate continuity of care in the event that a provider's services to clients are interrupted. (N. # B) Rules Committee Update.

- ◆ J. Schaffer provided the update from the Rules Committee. Since the last Board meeting, the Committee held a 5-hour meeting. Dr. Schaffer reported that the Rules Committee finalized the following: rules for volunteer licensure and registration of individuals completing their post doctoral supervised experience. He reported that the Rules Committee has discussed the issue of informed consent for forensic assessments, but that it still needs some changes before it is finalized.
- N. Hart reported that the proposed rule requiring licensees to provide the name of a person to continue the care of their clients may need to be changed because of data privacy.
- J. Romano led a discussion of ways the rule writing process can be expedited so that the new rules can be implemented; specifically, the proposed rule on accepting APA approved programs as meeting the educational requirements for licensure. N. Hart

will look into ways to take a portion of the educational rules to hearing before the main part of the rules is completed as a way to speed the process. He will report on his findings at the October Board meeting.

# C) Legislative Committee Update.

- ◆ J. Peterson reported that there is no update, but that he will meet with N. Ruiz and L. Sherry before the next meeting to determine the current status of legislative issues. He also wants to meet with the Rules Committee to see what legislation it wishes to propose for the 2004 session.

He reported that the Rules Committee continues to discuss and write language regarding the issue of informed consent for forensic assessments.

# B) Legislative Committee Update.

• Because Legislative Committee Chair J. Peterson will be unavailable for a time, he requested that staff find out from the Rules Committee what laws need to be changed in preparation for the proposed new rules.

# C) APA Accreditation for Educational Requirements for Licensure.

♦ At an earlier meeting, the Board had approved the Rules Committee's proposed change to the licensure rules which would allow the Board to accept an applicant's degree from an APA-approved educational institution as meeting the educational requirements for licensure. The Board requested that N. Hart research the question of whether it may begin to accept such degrees prior to the adoption of the proposed rules.

- ♦ N. Hart reported that the Board may not accept the degrees until a rule is adopted allowing it to do so. He stated that there is not a modified rule writing procedure available to the Board to expedite the process of adopting the rule, other than to isolate the proposed APA rule and take it through the full rule writing process before the rest of the rules. He advised that if the Board gets 25 or more requests for a hearing on the rule, it can reevaluate whether it wants to continue the process at that time or abort the rule making process at that time and add the APA rule back into the larger body of proposed rules.
- ◆ J. Romano moved, seconded by G. Jensen to move ahead with all of the educational rules for licensure that the Board has already approved. P. Walker-Singleton cautioned that the drawbacks to this approach include the additional expense of bringing the rules forward separately, the educational rules for licensure have been periodically revisited during the course of writing other rules, therefore, additional changes may become necessary as the Committee continues its work, and initiating such an extensive rule making process at this time will take staff and Committee members' time from the rest of the rule writing process. - **B)** BraVada Garrett Akinsanya, Ph.D, LP presented a proposal for a joint project to be created through a partnership between the Minnesota Psychological Association, Minnesota Association of Black Psychologists, the Multicultural Specialty Providers Mental Health

Network, and the Minnesota Board of Psychology. The project would be designed to create a directory that will inform the public of the availability of psychologists who provide services for underserved populations in the state. Dr. Garrett Akinsanya stated that there are two main purposes for this project: 1) to facilitate growth for providers, 2) to maximize information available to the public, thus facilitating communication about the availability of psychological services to populations, within the state of Minnesota, who may be having difficulty accessing such services. She defined underserved populations to include, but not be limited to, people of color and people who live in non-metro regions of the state. Her requests for Board assistance included help in fulfilling the following tasks:

- Gathering information on license renewal forms and licensure applications about providers who are competent to work with underserved populations.
- Putting information about this project on the Board's website.
- Working with volunteers from the other organizations to implement the project.
- ◆ Assisting in creating a hard copy of the directory of psychologists who can work with underserved populations.
- J. Schaffer moved, seconded by J. Romano, to support this project. Voting "aye": G. Jensen, J. Romano, J. Schaffer, M. Seibold, S. Terhune, and T. Thompson. Voting "nay": none. There being six ayes and no nays, motion carried unanimously.

The following members volunteered to work on the project, along with P. Walker-Singleton: J. Schaffer, T. Thompson and J. Hovland.

The Board requested that the directory clarify that its participation in the project does not represent an endorsement of the services or practices of any of the providers listed.

# I) Public Session.

**A)** Board Chair, J. Hovland, called the public session to order at 9:13 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

### II) Approval of Minutes.

# A) Minutes of the Board Meeting of August 1, 2003.

◆ J. Schaffer moved, seconded by S. Hayes, that the minutes of the Board Meeting of October 10, 2003 be approved. Voting "aye": S. Hayes, G. Jensen, J. Romano, J. Schaffer, M. Seibold, and S. Terhune. Voting "nay": none. There being six ayes and no nays, motion carried unanimously.

# B) Minutes of the Board Meeting of January 10, 2003.

♦ M. Seibold moved, seconded by S. Hayes that the minutes be amended to correct the record to show that M. Farinacci was not present. Voting "aye": S. Hayes, J. Romano, J. Schaffer, M. Seibold, and S. Terhune. Voting "nay": none. Abstaining: G. Jensen. There being six ayes and no nays, motion carried unanimously.

#### III) Administrative Matters.

# A) Rules Committee Update.

- ◆ J. Schaffer provided the update from the Rules Committee. Dr. Schaffer reported that the Rules Committee has begun to review the rules, revisiting left over issues and making corrections, as needed. Following this process, the Committee will go through the entire body of rules and make necessary corrections. J. Schaffer reported that the process may take approximately three to five additional months.
- ♦ P. Walker-Singleton explained the process for adopting rules and roughly estimated that the process should take approximately six to nine months. N. Hart speculated that the hearings will last approximately one week.
- ◆ J. Schaffer presented updated language revising the proposed rules for Informed Consent. J. Hovland asked whether the informed consent rule could incorporate the client bill of rights. J. Schaffer reported that the Rules Committee will discuss the suggestion at its next meeting.

# **B)** Communications Update.

- ♦ S. Hayes reported that the Communications Committee has not met since the last Board meeting. Ms. Hayes also requested that the staff present another website use report to the Board by the end of the calendar year.
- ♦ P. Walker-Singleton reported that L. Sherry is out indefinitely. While some of her duties will be covered by M. Elliott, the newsletter will be delayed and there is no legislative agenda being prepared for 2004.

#### C) Proposed 2004 Board Calendar.

- P. Walker-Singleton presented that proposed schedule of Board meeting dates for 2004. The proposed dates for the Board meetings for 2004 are unchanged from the October 10, 2003 Board meeting agenda, except that the September meeting date was changed from the third to the tenth.
- J. Peterson moved, seconded by J. Schaffer to approve the 2004 Board calendar. Voting "aye": S. Hayes, G. Jensen, J. Petersen, J. Romano, J. Schaffer, M. Seibold, and S. Terhune. Voting "nay": none. There being seven ayes and no nays, motion carried unanimously.

# D) 2004 Board Officer Elections next month.

- P. Walker-Singleton requested a change in the procedure for electing Board officers for year 2004. The Board agreed to nominate officers by secret ballot at the November meeting and to vote for the nominees at the December meeting, also by secret ballot. Nomination forms were completed by the members present.
- ♦ J. Hovland reported that her second term on the Board officially ends when the Governor names her replacement in 2004 and that her position on the Board is that of a representative of a Master's level training program.

# E) Presentation from Health Professionals Services Program (HPSP) next month.

♦ J. Hovland reported that M. Feider, HPSP Program Manager, will be making a brief presentation at the December board meeting.

# F) Report on 2003 Association of State and Provincial Psychology Boards (ASPPB) Annual Meeting.

- ♦ S. Hayes reported that the ASPPB annual meeting was a valuable and worthwhile experience. The organization's orientation meeting was informative and helpful, and new board members will really benefit from the educational experience. Ms. Hayes reported that there was discussion at the conference about developing a Spanish version of the EPPP. She found a summary table of parliamentary motions to be particularly helpful.
- J. Schaffer reported that Gary Schoener was the keynote speaker at the meeting. Dr. Schoener outlined points about supervision:
  - Research on supervision has indicated that competence does not support level of experience as a qualifier for providing supervision, training and supervision are better indicators of competence.
  - There is some question about whether supervision or consultation is the most appropriate term to describe what should be required when a provider is developing a

new competency. The definitions of supervision and competence vary over different jurisdictions.

- It is really important to be explicit in Orders and Agreements for Corrective Action about exactly what is required or expected by supervision ordered or agreed upon by the Board or a Committee.
- In addition to supervision it may also be appropriate to have a practice monitor to oversee the overall practice. In most other professions, it is common to require a chaperone. However, some people suggested that if a chaperone is necessary the practitioner ought not be practicing.
- J. Schaffer recommended to ASPPB that Boards should have some training requirements to gain competence in supervision.
- ♦ S. Hayes reported that there were questions that were raised about why Boards require supervision, what they are trying to accomplish and what is the best way to measure the effectiveness of the supervision. Another consideration for the Board is training, tools, expectations and guidelines that could be provided by the Board for supervisors to use in providing supervision. In some regions, Boards meet together to discuss procedures and policies and this may be a good consideration for this Board.
- ♦ J. Romano raised the issue of the Board issuing an Order for a person to get supervision, pay for the supervision and then requiring the supervisor to provide a report. J. Schaffer reported that some agencies require that a licensee or applicant be supervised by someone within their agency and that may be a conflict of interest. J. Hovland pointed out that educational institutions may be able to assist with providing education to supervisors, but the Board's role is protection of the public.

#### **G)** Authorizing Resolution.

At its meeting on October 10, 2003, the Board voted to proceed with the adoption of the proposed rule to accept as meeting the educational requirements, the applications of applicants who received the degree upon which licensure is based from an educational institution accredited by the American Psychological Association. The Board's first official step in the process is to adopt a resolution authorizing the Executive Director to begin the rule making process. P. Walker-Singleton asked that the Board adopt the authorizing resolution. J. Peterson moved, seconded by J. Romano to approve the authorizing resolution. Voting "aye": S. Hayes, G. Jensen, J. Petersen, J. Romano, J. Schaffer, M. Seibold, S. and S. Terhune. Voting "nay": none. There being seven ayes and no nays, motion carried unanimously.

# IV) Waivers/Variances.

#### I) Public Session.

**A)** Board Chair, J. Hovland, called the public session to order at 9:10 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

# II) Approval of Minutes.

# A) Minutes of the Board Meeting of November 7, 2003.

- J. Schaffer moved, seconded by S. Hayes, that the minutes of the Board Meeting of November
- 7, 2003 be approved as amended. Voting "aye": M. Farinacci, S. Hayes, J. Hovland, G. Jensen,
- J. Lee, J. Romano, J. Schaffer, M. Seibold, S. Terhune, and T. Thompson. Voting "nay": none. There being ten ayes and no nays, motion carried unanimously.

#### III) Administrative Matters.

#### A) New Board Member

◆ P. Walker-Singleton reported that Governor Tim Pawlenty appointed Joseph Lee, MA, LP to the Board of Psychology. Mr. Lee replaces J. White Schneeweis and brings the current number of members to a full compliment of eleven. Mr. Lee's first term on the Board expires January 5, 2004.

# B) Rules Committee Update.

- ◆ J. Schaffer provided the update from the Rules Committee. The Rules Committee has completed revisions on all of the agency rules that needed changes. The work that is left consists mainly of a review of the rules in their totality to ensure consistency and cohesiveness.
- ◆ The Rules Committee will bring the proposed rules back to the Board, in parts, for its periodic review.

#### C) Year-to-Date Website Usage.

• P. LaBrocca reported that she has updated parts of the Board's website. She presented updated website usage statistics.

#### D) Council of Health Boards (CHB).

♦ The CHB is charged by the Legislature with reviewing legislative proposals that would create new health licensing Boards or make certain changes to current laws regulating

health occupations. The CHB uses subcommittees made up of volunteer Executive Directors and the corresponding Board member representative from the Council to review the proposed new legislation and give feedback to the Legislature designed to assist it with its decision on whether to support the change.

The Psychology Board representatives, J. Peterson and P. Walker-Singleton, sat on the subcommittee that reviewed a proposed bill to license dental assistants. The proposal came from the American Association of Dental Assistants (AADA). Currently, dental assistants are regulated by the Minnesota Board of Dentistry, but are registered, not licensed.

The subcommittee met on November 13, 2003 and a report to the legislature will be reviewed by the CHB at its next meeting. If approved, the report will be sent to the legislature and will convey whether in the opinion of the subcommittee, the AADA made a case for switching from registration to licensure as their form of regulation.

# E) Psychometrists.

- ♦ P. Walker-Singleton reported that she was contacted by Duane Youngwirth, a psychometrists working at the Mayo Clinic. He was calling to discuss the fact that psychometrists are organizing in Minnesota, with the hopes of becoming licensed. He said that the National Association of Psychometrists met in Dallas, Texas, with the National Association of Neuropsychologists. The psychometrists planned to meet locally on December 3, 2003 to begin talks about licensure.
- Mr. Youngwirth wanted to know if the Board had anything official to say about the prospect of psychometrists becoming licensed or any advice. He was told that the Board had not formulated any opinion on the subject and has not discussed licensure for the group.
- Mr. Youngwirth explained that there are bachelor's and master's degreed psychometrists, with little, if any, discernable differences in responsibilities. He said that if they decide to seek licensure, the group is likely to make the entry level educational requirement become a master's degree and grandparent existing bachelor's level practitioners.
- Mr. Youngwirth was told that he could address the Board about the issue and that the Board could make a decision about support of their efforts towards licensure.
- This informational item was presented for the Board's discussion.
- ♦ J. Hovland outlined the current status of testing in Minnesota and stated that testing has not been carved out as a separate branch of the practice of psychology. J. Schaffer commented that the Psychology Practice Act does not have any regulation for testing by psychometrists, however, the proposed Rules will include a provision allowing psychometrists to practice under the supervision of a psychologist. J. Romano reported that he is not aware of a program that specifically trains psychometrists. M. Seibold added that there is no national standard regarding this issue.
- ◆ J. Peterson suggested that the Board contact Mr. Youngwirth to request that he make a presentation to the Board. P. Walker-Singleton reported that Duane Youngworth seemed very interested in presenting to the Board. J. Romano recommended that the Board wait until the group is more organized before requesting a presentation. J. Schaffer suggested that the Board wait to develop a position on psychometrists before entertaining a presentation. J. Hovland commented that it might be better to wait until

they are more organized and have a plan before inviting them to present at a Board meeting.

# F) Presentation from Health Professionals Services Program (HPSP).

♦ Kurt Roberts, a case manager at HPSP, presented an annual update to the Board members. Mr. Roberts reported that HPSP addresses a two part problem for impaired professionals: the first one is addressing the illness that a professional may have, the second is addressing the fact that people may be unaware of how to seek help or are unable to seek help for their illness. HPSP provides an alternative to Board action allowing professionals to report their impaired colleagues or for impaired licensees to seek help from HPSP. HPSP coordinates care for the impaired professional without directly providing the care. They monitor an impaired professional's progress towards recovery.

# G) ASPPB Informational Item.

♦ A copy of the minutes from the ASPPB Board of Directors Meeting on June 22, 2003 was presented as an informational item. In response to a question by M. Seibold, J. Romano explained that combined and integrated doctoral training in psychology is a program which allows training during a doctoral program to be consistent while allowing specialization to occur after the degree is earned.

# H) Representing the Board to the Public.

- ♦ J. Hovland presented a reminder to Board members on appropriate representation of the Board to the public.
- ◆ Dr. Hovland made a distinction between official representation of the Board and representing oneself. As an official representative, a member has been asked to speak for the Board. In such a case, the member should represent *the Board's* already established positions on a subject, if any, regardless of the member's own personal opinion on the subject. Members should make it clear when they are representing the Board's opinion on a specific issue.
- On occasions where a member, who happens to be on the Board, participates in a public engagement, the member should be clear that opinions expressed are their own. Individual points of view that conflict with Board positions need to be very clearly represented as individual opinions.
- ♦ When Board members are asked to speak because they are a Board member, they should notify the Executive Director.

#### I) Committee Interest.

♦ Each January, the newly elected Board chair evaluates Board Committee appointments and makes changes, as necessary. In preparation for the upcoming year, Board chair, J. Hovland asked that a form be given to Board members for completion. This was designed to assist the new chair with the evaluation process. Board members turned in the completed forms.

#### J) Election of 2004 Board Officers.

- ◆ J. Peterson moved, seconded by J. Romano that J. Schaffer be elected Board Chair. Voting "aye": M. Farinacci, S. Hayes, J. Hovland, G. Jensen, J. Lee, J. Peterson, J. Romano, J. Schaffer, M. Seibold, S. Terhune, and T. Thompson. Voting "nay": none. There being eleven ayes and no nays, motion carried unanimously.
- ◆ The Board members voted for the positions of Board Vice Chair (from these nominees: J. Schaffer, S. Terhune, J. Romano) and Board Secretary (from these nominees: J. Romano, M. Seibold, S. Hayes).
- ◆ There was a tie for Board Vice Chair and the Board members conducted a second vote.

  J. Romano was elected Board Vice Chair.
- ♦ M. Seibold was elected Board Secretary.

# K) MPA Legislative Agenda.

- ♦ D. Ollendick reported on MPA's legislative agenda for the upcoming year. D. Ollendick reported that MPA wants to support the following legislative issues:
  - Changing the name of the Board of Behavioral Health and Therapy to the Board of Professional Counseling. Psychologists, Social Workers, and Marriage and Family Therapists find the current name more confusing rather than more clarifying.
  - Requiring peer review of all levels of managed care. Current statute requires that a physician issue final denials of requests for authorization of covered services.
  - Amend existing statute to allow psychologist to perform disability determinations for early retirement of state employees. Current statute allows only physicians to make these determinations.
  - Introduce legislation mandating that psychologists not be excluded from hospital privileges. The current statute is silent on that issue.
  - Oppose legislation having to do with people now covered by Minnesota health care programs. This legislation requires a co-pay for participants in the programs, lowers the threshold of eligibility for benefits, and provides that behavioral health services can not be provided unless by medical doctors. Thus, the legislation eliminates all psychologists from the Medicare programs, the general assistance medical care programs, and the Medica state public programs.
