January 30, 2004

I) Executive Session.

A) The Board considered and approved the Stipulation and Consent Order for Voluntary Relinquishment of the license of William Fournier, MA, LP.

II) Public Session.

A) Board Chair, J. Schaffer, called the public session to order at 9:14 AM, in Conference Room A, 4th Floor at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present

III) Approval of Minutes.

A) Minutes of the Board Meeting of December 12, 2003.

M. Farinacci moved, seconded by S. Terhune, that the minutes of the Board Meeting of December 12, 2003 be approved. Voting "aye": M. Farinacci, G. Jensen, J. Lee, J. Romano, M. Seibold, S. Terhune, and T. Thompson. Voting "nay": none. There being seven ayes and no nays, motion carried unanimously.

IV) Administrative Matters.

A) Rules Committee Update.

♦ J. Schaffer provided the update from the Rules Committee. The Rules Committee has revised all the rules, is reviewing the rules for cohesiveness, and is about three-quarters of the way through the definitions.

B) Board Committee Assignment.

- J. Schaffer announced the following changes to the composition of Board committees:
 - ♦ ARC
 - J. Lee replaces S. Terhune.
 - **♦** Legislative
 - S. Terhune was appointed Chair.
 - ◆ CE Consultant
 - M. Seibold replaces J. Hovland.
 - Directory of Underserved Populations
 - J. Lee was appointed.

 - J. Schaffer, Chair
 - J. Romano
 - M. Seibold

C) Americans with Disabilities Act (ADA) Accommodation Costs.

- Until recently, applicants for the EPPP requested from the Board admitting them to the examination, reasonable accommodations under the ADA if the applicants needed such accommodations to allow them to sit for the examination. The Minnesota Board's process allows for consideration of the requests after the applicants submit a letter from Most medical request are granted. their medical care giver. Examples of accommodations that this Board's applicants have received in the past are extra time (usually up to three extra hours), readers, sign language interpreters, and a private room (for the pencil and paper version of the examination). However, this Board has traditionally granted accommodations, such as, extra time for examinees for which English was their second language. For the pencil and paper versions, the Minnesota Board bore the costs, such as hiring a proctor for an examinee who needed a private room or paying the costs for a sign language interpreter. When the Board switched to offering the computerized version of the EPPP, the costs of providing reasonable accommodations shifted to ASPPB.
- ♦ Effective March 31, 2004, the Association of State and Provincial Psychology Boards (ASPPB) will no longer assume the responsibility for paying for reasonable accommodations requested by EPPP applicants under the ADA or the Canadian Human Rights Act. ASPPB's costs of providing the accommodations, which have been approved by Boards have more than tripled. As a result, Boards will have to again cover the costs.
- ♦ This issue will be updated as more information becomes available.

D) Appointment to ASPPB Committee.

- ◆ ASPPB Board President, Barbara A. Van Horne, MBA, PhD appointed J. Schaffer to a one-year term on ASPPB's Committee on Education, Training and Oral Examinations (CETOE).
- J. Schaffer reported he will be working on setting up guidelines for supervision.

E) Information from the National Register of Health Service Providers in Psychology.

The National Register's Mobility Coordinator, Andrew Boucher, sent information for the Board's review about mobility. The information included an article in the Fall 2003 issue of *The Register Report*, the magazine for Health service providers in psychology, about choices and opportunities available for psychologists who move their licensure from one jurisdiction to another. To help facilitate mobility, the organization created the National Register's Online Searchable Database (OSD) located at www.nationalregister.org so that jurisdictions can verify credentials of individuals listed in the National Register.

F) Meeting with Senator Sheila Kiscaden.

♦ In mid-December 2003, Senator Sheila Kiscaden requested a meeting with the Executive Directors and the Board Chairs of the Boards of Social Work, Marriage and Family Therapy, Behavioral Health and Therapy, and Psychology; in addition, she invited to the

- meeting representatives from the Department of Health and the Office of the Attorney General, as well as Senator Becky Lourey. The meeting took place on Tuesday, January 6, 2004. J. Schaffer and P. Walker-Singleton represented the Board of Psychology. N. Hart and S. Gunn represented the Office of the Attorney General.
- ♦ There were two issues on the agenda. The first issue is how to rectify the problem that licensees of a health licensing Board can lose their license to practice and still work in the field by calling the work that they do psychotherapy, coaching, etc. This practice was brought to the Senators' attention through the actions of a former health licensing Board licensee whose license to practice was revoked for sexual misconduct, but continues to practice as a life coach.
- ♦ In order to address the first issue, Senator Kiscaden asked N. Hart to draft legislation prohibiting unlicensed practice by individuals who were formerly licensed by one of the mental health Boards from practicing as unlicensed mental health practitioners if their license has been revoked or suspended by their licensing Board for sexual misconduct. This provision may be placed in Minnesota Laws chapter 214 or in chapter 148B (Social Work and Marriage and Family Therapy) and in chapter 148 (Psychology).
- ◆ The second issue on the agenda was to discuss the disposition of the Office of Unlicensed Mental Health Practice (Office). Although the Office does not license, register, or certify individuals to practice, it has the authority to discipline individuals practicing in the mental health field unlicensed. At present, the Office is under the jurisdiction of the Department of Health. However, the law that created the Board of Behavioral Health and Therapy abolished the Office effective July 1, 2004, but did not reassign the oversight duties of the Office. As a result, no body was given jurisdiction to discipline unlicensed mental health practitioners after July 1, 2004.
- ♦ One of two things needs to happen. Either the law needs to be made to explicitly prohibit the unlicensed practice in the mental health field and the Office remains abolished, or the Office of Unlicensed Mental Health Practice needs a new home. Senator Kiscaden assigned to the above referenced group of individuals with whom she met on January 6, 2004, the task of coming up with a solution. She asked for a resolution within one month—early February.
- ♦ Since the January 6th meeting, the Executive Directors have met with a representative from the Health Department and N. Hart. The group has agreed to pursue a resolution. In regards to the second issue, the group asked Senator Kiscaden to sponsor a bill this session to delay the abolishment of the Office of Unlicensed Mental Health until July 1, 2005. The extension would give the group time to work on solutions.
- ♦ The sense of the Board of Psychology is that everyone practicing as mental health practitioners should be licensed; i.e., no one should practice unlicensed.

G) Governor's Appointments Coordinator.

♦ J. Berns, Appointment Coordinator for Governor Tim Pawlenty attended the Board meeting and introduced himself to the Board. He reported that the new appointments to the Board should be approved by the end of February. He reported that the Governor's priority is that the Boards should reflect Minnesota's diverse population in regard to gender, race, etc.

H) Update on Rule Change for Educational Requirements.

• P. Walker-Singleton reported that the rule has been returned from the Revisor's office and the Statement of Need and Reasonableness (SONAR) has to be completed. When

the SONAR is complete, the Rule and the SONAR will be sent out with the notices. J. Romano will provide staff with information which may contribute to the SONAR.

I) Report from the Council of Health Boards (CHB).

◆ CHB representative, J. Peterson, and P. Walker-Singleton served on a subcommittee that reviewed a proposal (to the Legislature) from the American Association of Dental Assistants (AADA) that dental assistants be licensed as opposed to registered. The Board was presented with a copy of the subcommittee's report.

J) Independent Practice for Licensed Psychological Practitioners (LPP's).

- The Board began studying the problems with LPP licensure in the 1990's and in 2001, the Board formed an Ad Hoc Committee on LPP Licensure to prepare a proposal for Board action. The Committee proposed that the Board grant independent licensure to an LPP who has practiced under supervision for 3000 hours over a maximum of a three year period and has the endorsement of all Licensed Psychologist supervisors. The Committee's recommendation was that the name of the new licensure would be determined at a later time. N. Hart and the Legislative Committee were charged with drafting the language of a bill that would create the new licensure status for LPP's. As the drafting began, it became apparent that the proposed changes would require a major re-write of the Board's statutes and many questions developed that needed to be answered by the Board. The issue was brought back to the Board and the Board called for a joint meeting of the Legislative Committee and the Ad Hoc Committee on LPP Licensure to work out the answers. The Committees met, but because of the complexity of the issues no consensus was reached. After receiving that report, no further action was taken on the issue by the Board.
- On January 22, 2004, G. Jensen wrote a memorandum to the Board regarding the status of licensure for Licensed Psychological Practitioners. He proposed that the Board take one of four actions:
 - 1. Rescind the proposal of the Ad Hoc Committee on LPP Licensure.
 - 2. Postpone action on that proposal until a time certain.
 - 3. Request that the Legislative Committee finish drafting a bill to implement the Ad Hoc Committee's proposal.
 - 4. Develop a new plan designed to eliminate LPP licensure.
- ♦ G. Jensen moved, seconded by M. Farinacci, that the Board request the Legislative Committee to finish drafting the bill (#3).
 - J. Schaffer spoke against the motion stating that this is mainly a reimbursement issue, which is not an issue for the Board, but rather, an issue for a guild organization. In addition, a bill creating independent licensure at the master's level would be vigorously opposed by the Minnesota Psychological Association and possibly in the Legislature. This would also require a large amount of staff time, which may be wasted. Additionally, it may have a negative impact on the perception of the Board by its licensees for proposing legislative action that many of them oppose.
 - N. Hart reported that a discussion regarding independent practice has been attempted before and the Ad Hoc and Legislative Committees were unable to come to a consensus.
 - J. Peterson supported the motion as he felt that there *was* a consensus of what the Board would support and the only issue was what name to assign to LPP's practicing

- independently. He believes that the Board needs master's level licensees and there was a consensus that they should be independent.
- J. Romano was on the Ad Hoc Committee and pointed out that there was a 9-1 vote to move forward with independent practice for LPP's. There has been a major change now that Licensed Professional Counselor (LCP) licensure is available; perhaps the Board of Psychology does not need an LPP licensure.
- P. Walker-Singleton reported that the LPC bill also has a provision for grandparenting all LPP's to LPC's if they desire. There is no anticipated problem with reimbursement for LPC's. Master's level LP's will not be affected by any potential changes to the LPP licensure.
- G. Jensen reported that the Board should take affirmative action regarding the LPP licensure rather than wait for them to just switch over to LPC's one by one. He also reported that unlicensed people have more opportunity to see clients than he does as an LPP; it is difficult for LPP's to be reimbursed by Medical Assistance; other master's level licensees can supervise, but he cannot. Mr. Jensen also said that psychology is a different field from social work and he believes that getting rid of the master's level licensure by the Board of Psychology may result in a deficit of master's level training specifically in psychology. Some LPP's want to keep their identity as "psychology" practitioners—working from the psychology perspective.
- J. Romano added that LPP licensure has been in effect since 1991 and there are only 48 LPP's. He believes that these LPP's should be grandparented as LP's.
- S. Terhune agreed that it is more practical for LPP's to become LP's. The entry level into the profession has been defined as doctoral level.
- J. Peterson took issue with the belief that the only people who are qualified to practice independently are people who are trained at the doctoral level.
- J. Lee pointed out that LPP's who have been licensed since 1991 have now had 13 years of experience and may be qualified to be grandparented in.
- Voting "aye": G. Jensen, J. Peterson, M. Seibold. Voting "nay": M. Farinacci, J. Romano, S. Terhune, and T. Thompson. Abstaining: J. Lee. There being three ayes and four nays, motion failed.
- ♦ J. Romano moved, seconded by J. Lee, that the Chair of the Board appoint another Ad Hoc Committee to explore the possibility of eliminating LPP licensure and grandparenting existing LPP's as master's level LP's.
 - M. Seibold indicated that she would like to see the Committee's scope broadened to
 include the possibility of keeping some sort of master's level psychological practice,
 however, this amendment was not accepted.
 - Voting "aye": M. Farinacci, G. Jensen, J. Lee, J. Romano, M. Seibold, and T. Thompson. Voting "nay": J. Peterson and S. Terhune. There being six ayes and two nays, motion carried.
 - J. Schaffer polled members to determine interest in membership on the new Ad Hoc Committee on LPP Licensure. J. Romano, J. Lee, M. Seibold, and G. Jensen expressed interest and were appointed to the Committee. The chair suggested that others from the psychological community may be asked to participate as Committee members.

K) 19th ASPPB Mid-Winter Meeting & Third International Congress.

◆ The 19th Mid Winter Meeting and the Third International Congress of the Association of State and Provincial Psychology Board (ASPPB) has been combined into one meeting

this year. It will be held April 21-24, 2004 at the Marriott Chateau Champlain in Montreal, Quebec, Canada. Staff recommended that the Board send up to four representatives to the conference. J. Schaffer will be attending the conference and some of his expenses will be covered by ASPPB. Staff recommended that the Board cover the balance of his expenses also.

- ♦ M. Farinacci moved, seconded by S. Terhune that the Board send up to four members to the meeting and pay the balance of the expenses incurred by J. Schaffer. J. Romano suggested that the Board wait until more of the content of the meeting is revealed to decide how many representatives to send. J. Schaffer commented that the Board has more new members than usual and, therefore, advocates sending the new members to the ASPPB meeting.
- ♦ J. Peterson recommended that the Board wait a month before deciding who to send. P. Walker-Singleton reminded the Board that the next meeting of the Board may be too late to meet registration and other deadlines.
- ♦ Voting "aye": M. Farinacci, J. Lee, J. Peterson, M. Seibold, S. Terhune, and T. Thompson. Voting "nay": none. Abstaining: G. Jensen and J. Romano. There being six ayes and no nays, motion carried.
- ♦ J. Schaffer will speak to the eligible members about their availability to attend the meeting.

L) Sponsor Request for CE Approval.

- On three occasions, the Board has reviewed Sponsor Requests for approval of a workshop presented by Patrick Dougherty, MA, LP on the subject of Spring Forest Qigong. The Board has twice denied the request because the sponsor did not meet his burden to prove that the materials being presented meet the criteria for approval as continuing education for the purpose of license renewal. After his last request before the Board at the May 16, 2003 meeting, the Board voted to table this request until more scientific data could be provided regarding the connection between Qigong and the practice of psychology and until the parts of the course related to psychology can be pointed out. Mr. Dougherty addressed the Board at its January 30, 2004, meeting and presented additional information.
- ♦ Mr. Dougherty reported that he has rewritten his brochure to more accurately reflect the psychological background of the material and target psychologists as participants in his classes. He also presented for the Board's review, research on Qigong.
- ◆ J. Lee moved, seconded by T. Thompson, to approve the workshop as requested. J. Romano proposed a friendly amendment to the motion that Mr. Dougherty should make alterations to the statements in his brochure that reveals the scientific basis for his claims of effectiveness. The amendment was accepted. J. Romano stated that the description in the brochure should address the experimental nature. Voting "aye": M. Farinacci, G. Jensen, J. Lee, J. Peterson, J. Romano, and T. Thompson. Voting "nay": M. Seibold and S. Terhune. There being six ayes and two nays, motion carried.

- ◆ J. Romano moved, seconded by M. Farinacci, that the variance requests be approved on the basis that the licensees met the burden to prove that adherence to the rule would impose an undue burden on the licensees, that granting the variance will not adversely affect the public welfare, and that the alternatives proposed meet the rationale for the rule. check for \$250.00. Ms. Wadewitz states that she did not receive an Application for License Renewal, and the additional late fee would cause an undue burden. Board records do not show an address change and Licensee has listed the same home and business address on her renewal applications since initial licensure. J. Peterson moved, seconded by S. Application Review Committee recommended approval of the variance request from Applicant 04C-002 on the basis that the applicant met the burden to prove that adherence to the rule would impose an undue burden on the applicant, that granting the variance will not adversely affect the public welfare, and that the alternative proposed meets the rationale for the rule. I) Public Session.

II) Rescission of Board action.

III) Approval of Minutes.

A) Minutes of the Board Meeting of January 30, 2004.

J. Romano moved, seconded by S. Terhune, that the minutes of the Board Meeting of January 30, 2004 be approved as amended. Voting "aye": M. Farinacci, J. Hovland, G. Jensen, J. Lee, J. Romano, M. Seibold, S. Terhune, and T. Thompson. Voting "nay": none. There being eight ayes and no nays, motion carried unanimously.

IV) Rescission of Board Termination.

A) The license of Pamela Aasen, PhD, LP was terminated in accordance with MN Rule part 7200.3510. Dr. Aasen is asking the board to rescind its action of January 30, 2004, whereby her licensed psychologist license was terminated for failure to renew. J. Hovland moved, seconded by M. Farinacci, that the Board rescind its action of January 30, 2004 terminating the license of Pamela Aasen, PhD, LP (License Number LP2608). Voting "aye": M. Farinacci, J. Hovland, G. Jensen, J. Lee, J. Romano, M. Seibold, S. Terhune, and T. Thompson. Voting "nay": none. There being eight ayes and no nays, motion carried unanimously.

Administrative Matters.

B) Board Reappointments.

♦ Governor Tim Pawlenty reappointed J. Romano and J. Lee to serve second terms on the Board of Psychology. The two four-year terms will end January 7, 2008.

C) Rules Committee Update.

♦ J. Schaffer provided the update from the Rules Committee. The Rules Committee is continuing to go through the rules for cohesiveness. There have been two meetings of the Public Advisory Committee since the last Rules Committee meeting. The Committee plans to present the package to the Board within a couple of months, perhaps at a special Board meeting.

D) Meeting of the Ad Hoc Committee on Licensed Psychological Practitioner (LPP) Licensure.

- ♦ On Friday, February 20, 2004, the Committee met to discuss the future of LPP licensure in the state. The Committee members are J. Romano, chair, S. Hayes, M. Seibold, G. Jensen, and a member of the public, D. Ollendick, who was appointed to the Committee by Board chair, J. Schaffer. In addition to the Board's list of interested public, notices of the meeting were also sent to all 48 of the Board's LPP licensees; seventeen LPP's attended the meeting. The Committee engaged in discussion with the LPP's present to obtain information about their experiences since becoming licensed as LPP's and to get feedback on the concept of eliminating LPP licensure and grandparenting existing LPP's as LP's.
- The Committee moved that the Board adopt the following recommendation:
 - > That the Board rescind its previous vote to create independent licensure for LPP's.
 - That the Board grandparent existing LPP's as master's level LP's.
 - ➤ That the Board determine the parameters for eliminating LPP licensure.
 - That the Board determine the parameters for grandparenting existing LPP's as LP's.

Following discussion, there was a motion to table the issue. J. Lee moved, seconded by T. Thompson that the issue be tabled in order to allow the Committee to gather additional information and report back to the Board at the June 25, 2004 meeting. The Board requested that the Committee gather the following data:

- From other jurisdictions, information about their levels of licensure.
- From other jurisdictions, what experiences have they had as they transitioned from master's to doctoral level licensure.
- Future implications for the field of psychology if LPP's are grandparented.
- Information about issues related to insurance reimbursement.
- Will there be changes in supervision for LPP's. If so, what changes?
- Does ASPPB have information on what happens to the field of psychology without master's level licensure.
- Parameters for who is eligible for grandparenting.
- Number of LPP's to be grandparented.
- Demographics of master's level licensed psychologists in the state. (age, gender)
- The cultural competence of LPP's.

On the motion to table, voting "aye": G. Jensen, J. Lee, J. Romano, M. Seibold, S. Terhune, and T. Thompson. Voting "nay": M. Farinacci, J. Hovland, and J. Peterson. There being six "ayes" and three "nays", motion carried.

J. Hovland stated that she will join the Ad Hoc Committee on LPP Licensure for the duration of her term on the Board.

E) Request from the Minnesota Psychological Association (MPA).

◆ A part of MPA's legislative agenda for the 2004 session is to introduce a bill to change the name of the Board of Behavioral Health and Therapy (BBHT) to the Board of Professional Counselors. E. Super, PhD, LP, MPA President has written a letter asking for the Board's support in this effort. S. Terhune moved, seconded by J. Peterson that the Board take no position on this issue. Voting "aye": M. Farinacci, J. Hovland, G. Jensen, J. Lee, J. Peterson, M. Seibold, S. Terhune, and T. Thompson. Voting "nay": J. Romano. There being eight ayes and one nay, motion carried.

F) ASPPB's Midwinter Meeting/International Congress.

- ◆ The Board decided to send members to the combined 19th Midwinter Meeting and Third International Congress held by the Association of State and Provincial Psychology Boards (ASPPB) on April 21-24, 2004 in Montreal, Quebec, Canada. There was discussion at the January meeting of the Psychology Board centering on the cost of the trip. The Board can cover the cost of sending up to four members and to pay the balance of the costs for the Board chair that are not covered by the Association. (Chair J. Schaffer is a presenter; therefore, most of his expenses are paid by ASPPB.)
- ♦ The Board voted to send as many of the new Board members (T. Thompson, J. Lee, and G. Jensen) as possible and to cover Dr. Schaffer's costs not otherwise paid. Mr. Thompson and Mr. Lee can attend the meeting and as soon as we receive the state's permission for international travel, arrangements will be finalized.
- ♦ In follow up to the discussions at the January Board meeting, J. Berns, Governor Pawlenty's Appointments Coordinator, who attended the January 30, 2004 Board meeting, spoke to J. Romano and P. Walker-Singleton. On February 27, 2004, Heide Holste, from Governor Pawlenty's staff called with questions about the meeting in Canada. The entire process of how the Board made the decision to send members to Canada was explained to both Mr. Berns and Ms. Holste.
- ♦ In March 2004, a letter was received by another Health Licensing Board from State Representative Fran Bradley cautioning all Boards to carefully manage policy and fiscal matters of the Boards.
- ♦ In light of this correspondence, the Board of Psychology again discussed its decision to send representatives to the meetings in Canada.
- ♦ The Board's discussion included the following points:
 - The Board is keenly aware of the state of the state's economic status and has remained alert to the fact that its revenue consists of public funds that need to be managed conservatively. Every Board decision has a component having to do with cost and the availability of revenue. The decision to send members to these meetings was no different.
 - The Minnesota Board of Psychology found the topics of 2004 Midwinter Meeting and International Congress to be of great interest because of its focus on multicultural and other issues such as, professional psychology around the world, the impact of the changing gender composition of psychology, international networking, and global perspectives on legal, educational, and fitness to practice issues.
 - The Board of Psychology has more new members than usual, at this time. They receive an orientation from staff about the manner in which the Minnesota Board fulfills its mission to protect the public. However, the orientation is completed at ASPPB meetings, where members receive a new Board member orientation with a

- focus on national and international issues and perspectives through instruction from Board members, administrators, and attorneys from other jurisdictions.
- The knowledge brought back from the ASPPB meetings has shaped Minnesota's regulatory policies and discussions and ideas shared by attendees have been implemented to the benefit of licensees of the state in all areas of the Board's responsibilities.
- The Midwinter Meetings and International Congress Meetings give members historical perspective on Board issues, a global view of Board member responsibilities, and explains differences and similarities of Board functions in the jurisdictions.
- These meetings are a resource to help train Board members to perform the duties they were appointed to do. In addition, the communication networks established in such settings serves the licensees of the state as well as the complainants.
- ◆ J. Peterson moved, seconded by J. Hovland that the Board should send a letter to J. Berns stating that the Board has considered his concerns. The letter should include the Board's reasoning and explanations for wanting to send representatives to the meetings, and should point out that the Board only plans to send two representatives. Voting "aye": M. Farinacci, J Hovland, G. Jensen, J. Lee, J. Peterson, J. Romano, M. Seibold, S. Terhune, and T. Thompson. Voting "nay" none. There being nine ayes and no nays, motion carried unanimously.

I) Public Session.

A) Board Chair, J. Schaffer, called the public session to order at 9:45 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

II) Approval of Minutes.

A) Minutes of the Board Meeting of March 12, 2004.

G. Jensen moved, seconded by S. Hayes, that the minutes of the Board Meeting of March 12, 2004 be approved. Voting "aye": M. Farinacci, S. Hayes, G. Jensen, J. Lee, J. Peterson, J. Romano, M. Seibold, S. Terhune, and T. Thompson. Voting "nay": none. There being nine "ayes" and no "nays", motion carried unanimously.

III) Administrative Matters.

A) Rules Committee Update.

♦ J. Schaffer provided the update from the Rules Committee. The Rules Committee has scheduled three meetings in the next month. The Committee is still editing. It will review the Rules of Conduct at the meeting following this Board meeting.

B) Administrative Committee Report.

- ◆ The Administrative Committee, made up of Board officers, J. Schaffer, J. Romano, and M. Seibold met Friday, April 2, 2004 with P. Walker-Singleton.
- ♦ The Committee discussed a five year plan that is being written by Ms. Walker-Singleton. Costs saving measures were also discussed.
- ♦ The Committee plans on meeting quarterly to review the budget and to make recommendations if there are any budgetary items that require board action.

C) Ad Hoc Committee on Licensed Psychological Practitioner (LPP) Licensure Update.

- ◆ J. Romano reported that the Ad Hoc Committee met April 16, 2004 from 7:30 AM to 9 AM. The Committee discussed the following data gathered by the Committee and staff at the request of the Board:
 - ➤ Other states' master's level licensing-G. Schiff.
 - There are 28 jurisdictions that do not license at the master's level.

- Six jurisdictions (two are provinces) license master's level professionals, not as psychologists, and allow independent practice.
- VT and WV are the only states to license psychologists at the master's level.
- Five states, including VT and WV, license some type of psychology practitioner who can practice independently.
- Nineteen jurisdictions (Three are provinces; one a territory) license master's level professionals, not as psychologists, and do not allow independent practice. This list includes Minnesota.
- Six states license master's level professionals as school psychologists.
- ➤ Various issues-J. Hovland via e-mail.
 - The ability to pass the EPPP on the first try seems to correlate with doctoral vs. master's level education. Dr. Hovland did not find this correlation elsewhere.
 - In states with established counselor licensure, master's level licensees outnumber doctoral level licensees significantly.
 - She predicts that the Board of Psychology will not be flooded with master's level candidates for licensure, since most master's level programs are following CACREP standards (Council for the Accreditation of Counseling and Related Education Programs).
- > Cultural competence-J. Lee
 - Mr. Lee is concerned that, in general, the elimination of master's level licensure by this Board will diminish the availability of psychological services to underserved populations in the state.
 - He reported that it may also affect the availability of culturally competent psychological services.
- ➤ Do LPP's have the qualifications to practice competently if they are given the same practice privileges as LP's?-M. Seibold
 - LPP's must have master's degrees that follow the curriculum guidelines established by the Board of Psychology. These guidelines closely follow guidelines of the American Psychological Association for clinical training.
 - LPP's must pass the Board of Psychology examinations at the same levels as LP's.
 - The data in Minnesota show that master's level LP's have lower rates of disciplinary action as compared to doctoral level LP's. There are no cases of disciplinary actions against LPP's.
 - All of the Board's licensees—whether master's or doctoral level—are mandated
 to practice within their own level of competence. There is every reason to
 believe that LPP's converted to LP's would practice within their level of
 competence.
 - Dr. Seibold concluded that there is no evidence that LPP's converted to LP's
 would pose a danger to the public or would practice in ways that are outside of
 their scope of practice.
- Insurance reimbursement for LPP's: Why are they not getting reimbursed?-G. Jensen
 - Most HMO's and insurance companies only credential practitioners who can
 practice independently. LPP's cannot practice independently (without
 supervision).

- If an agency is a Rule 29 Clinic, licensed by the Minnesota Department of Human Services, the agency can bill for an LPP's services, if the services are billed under the supervisor's name.
- Rule 29 clinics employ master's prepared professions, such as Licensed Independent Clinical Social Workers, Licensed Marriage and Family Therapists, LPP's, and perhaps in the near future, Licensed Professional Counselors. All of these professionals can practice independently and are routinely reimbursed by HMO's and insurance companies, except for LPP's.
- Since an LPP's employer may have to hire/provide for a supervisor for an LPP, the employer sees this as a financial and time barrier to hiring an LPP.
- Employment opportunities for LPP's are very limited.
- HMO or insurance companies have guidelines on the amount they will reimburse LPP's, if at all. This also has a financial impact on a potential employer.
- ➤ The Committee offered that this Board appears to have three basic choices for the LPP's:
 - Leave as is.
 - Grandparent LPP's as LP's.
 - Keep the LPP licensure, but decrease the number of years of supervision.
- The committee is still in the data collection phase.

D) Funding the Office of Mental Health Practice (OMHP).

- P. Walker-Singleton informed the Board of a possible proposal for the future funding of the Office of Mental Health Practice (OMHP). There is a possibility that the Office may have to be absorbed and funded by certain of the health licensing Boards. The cost of running OMHP is \$104,000 per year.
- ♦ A proposal for funding the agency from July 1, 2004 to July 1, 2005 is to take the money from the special revenue fund and let the Boards of Marriage and Family Therapy, Social Work, Psychology, Medical Practice, Nursing, and Board of Behavioral Health and Therapy replenish the fund. (All of those Boards license people who practice in mental health professions.)
- Staff of the health licensing Boards is following up on the proposal.

E) ASPPB's Call for Officer and Award Nominees.

- ♦ Each year, the Association of State and Provincial Psychology Boards (ASPPB) requests from the member Boards nominations for vacant seats on its Board of Directors and for awards as an ASPPB fellow, the ASPPB State and Provincial Service Award (formally the Roger C. Smith Award), the Norma P. Simon Award, and the Ming Fisher Award. The deadline for nominations is May 24, 2004.
- ♦ G. Jensen moved, seconded by S. Hayes, that J. Schaffer be nominated for Member at Large of the ASPPB Board of Directors. Voting "aye": M. Farinacci, S. Hayes, G. Jensen, J. Lee, J. Peterson, J. Romano, M. Seibold, S. Terhune, and T. Thompson. Voting "nay": none. There being nine "ayes" and no "nays", motion carried unanimously.

F) Cost Saving Measure.

◆ Staff presented to the Board an idea for reducing expenses. The plan involves the use of post cards (at \$.23 per piece) to replace mailings of letters (at a minimum of \$.37 per piece). Instead of mailing an entire renewal packet at a cost of \$.60 each, staff is planning to mail to licensees a \$.23 post card to alert them of their upcoming renewal date and to invite them to download renewal forms and information from the website or to call the Board office for a renewal packet. Later, in this calendar year, we expect to change the language on the post cards to offer licensees to either download the forms, to call for a renewal packet, or to renew on-line.

Staff presented bar charts showing an initial 60% savings if post cards are used in comparison to standard mail based on the actual numbers of licensees we mailed renewal packets to during each month of the odd numbered calendar year of 2003 and the even numbered calendar year of 2002.

G) ASPPB Midwinter Meeting/International Congress.

♦ The Board approved travel to Montreal, Quebec, Canada for the Midwinter Meeting/International Congress for up to four Board members. Two members were able to make the trip. Also approved for payment by the Board was the portion of the expenses of J. Schaffer not covered by ASPPB, who is a presenter at the meeting.

We have now been informed that the request for approval of international travel was approved for only the travel expenses of J. Schaffer.

Two members, T. Thompson and J. Lee, had made flight arrangements for the trip on advice from staff, in an effort to get the lowest available fare, because the time to the trip was getting short, and because such travel had never been disapproved in past experience. C) Rules Committee Update

- ◆ J. Schaffer reported on the progress of the Rules Committee. The Committee is almost through its final review of the licensure rules. The Committee continues to discuss the question of whether to propose that an APA approved internship should meet rule requirements.
- ♦ J. Schaffer questioned whether the Board would prefer to review the proposed rules in sections (licensure rules, CE rules, and Rules of Conduct) in regular Board meetings, or whether the Board would prefer to hold one special Board meeting and consider all

proposed rules at once. The Board chose to have the Rules Committee bring the proposed rules for review in sections to several meetings.

♦ J. Schaffer presented for the Board's information a document on writing rules and legislation which was prepared for the 2004 ASPPB International Congress.

D) ASPPB Midwinter Meeting/International Congress Report

- Dr. Schaffer attended the ASPPB meeting and reported on his experiences there.
 - He reported that there was one major theme: differences and similarities in ethical standards and codes across the countries. There is a group are working on developing an international code of conduct, which may be adopted by jurisdictions, at their option. The international code may incorporate the philosophy of treating "a people" vs. treating "persons", which is characteristic of the practice of psychology in New Zealand.
 - Another general theme had to do with supervision. There is an Ad Hoc Committee working on standardized forms for evaluation of supervisees.
 - A third theme had to do with international training, education, and mobility.
 - Dr. Schaffer presented three issues that he thought the Board should think about.
 - California requires six hours of CE in supervision before an individual may be approved as a supervisor.
 - Related to the supervision issue is the legal ability that supervisors currently have and whether there is some way of moderating that.
 - The concept of therapeutic jurisprudence, which is akin to restorative justice. The idea is that what happens in the disciplinary process should not be only a deterrent; there should also be some form of justice for the victim.
 - Dr. Schaffer reported on three interesting factoids:
 - In Canada, disciplinary conferences are open to the public.
 - In the Northwest Territories of Canada, there are about 3-4 psychologists. Citizens there can only drive nine months of the year...when the rivers are frozen.
 - The entire Vermont Board of Psychology attended the meeting.

A) Board Chair, J. Schaffer, called the public session to order at 9:59 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

III) Approval of Minutes.

A) Minutes of the Board Meeting of May 14, 2004.

J. Romano moved, seconded by S. Terhune, that the minutes of the Board meeting of May 14, 2004 be approved as amended. Voting "aye": G. Jensen, J. Lee, J. Peterson, J. Romano, S. Terhune, T. Thompson, and J. Wolf. Voting "nay": none. Abstaining: S. Hayes. There being seven ayes and no nays, motion carried.

IV) Administrative Matters.

A.) Rules Committee Update

◆ J. Schaffer reported on the progress of the Rules Committee. The Rules Committee is close to finalizing the licensure rules, but did not complete them despite a 6-hour meeting on June 24, 2004. At that meeting, the Committee made a major change in the licensure rules. The Committee deleted all existing educational requirements for licensure, and will propose replacing them with a set of new rules delineating the educational requirements for licensure. The Committee will bring the Licensure rules to the Board for approval at the August meeting. When done with the Licensure Rules, the Rules Committee will work to finish the Continuing Education Rules, and then the Rules of Conduct.

B.) Communications Committee Update. (Year-to-Date Website Usage)

♦ L. Sherry reported on website usage as of June 16, 2004. She noted that the information is pulled from the website every six months. In reply to a question from S. Hayes, staff reported that they are receiving fewer phone calls requesting routine information.

C.) Application Review Committee (ARC) Request.

- ♦ On June 15, 2001, the Board approved a proposed rule change to accept APA-accredited doctoral programs as meeting educational requirements for licensure. At the May 17, 2002 Board meeting, then chair of the ARC, R. Maves, requested that the Board consider granting the Committee the authority to accept APA-accredited programs as meeting the educational requirements for licensure in anticipation of the passage of the proposed rule. The Board declined to grant such authority, because according to legal advice, to do so would be tantamount to using an unpromulgated rule, which is illegal.
- ♦ The chair of the sitting ARC, John Romano, made the following request on behalf of the Committee: Given that the Board has already approved APA accreditation as meeting educational requirements, and that the process of making this one rule change is taking so long, and, in the ARC's opinion, many applicants are unnecessarily delayed in having their applications approved, the ARC requests, as an interim procedure, that applicants from APA accredited doctoral programs be informed that they can submit a variance (similarly to theories of measurement variance approved several years ago) to meet one or more of the educational requirements based on receiving a doctoral degree from an APA accredited program. The ARC will then review the variance request and make a recommendation to the full Board. The consensus of the Board was that there is no need for Board action at this time, because according to MN. Rule 7200.6000, applicants are already able to request a waiver or variance for the rule containing the educational requirements for licensure.

D.) Ad Hoc Committee on LPP Licensure.

- ♦ At its January 30, 2004 Board meeting, the Board reconvened an Ad Hoc committee to study the appropriate disposition for its current Licensed Psychological Practitioner licensure level. The committee members are J. Romano, chair, M. Seibold, G. Jensen, J. Lee, S. Hayes, and D. Ollendick. The Committee met on May 14, 2004 and decided to bring two options to the Board for its consideration at the June 25, 2004 Board meeting. The options presented are:
 - a. Leave LPP licensure as it is, or
 - b. Grandparent in current LPP's as LP's and eliminate LPP licensure.
- J. Romano presented the options to the Board. After discussion, the consensus of the Board was that it is willing to consider the option of converting qualified LPP licensees to LP's and eliminating LPP licensure, but the Committee had not presented specific criteria for doing so.
- ♦ G. Jensen moved that
 - The Board rescind its previous motion to create independent licensure for LPP's.
 - That the Board grandparent existing LPP's as master's level LP's.
 - That the Board determine the parameters for eliminating LPP licensure.
 - That the Board determine the parameters for grandparenting existing LPP's as LP's.

There was no second to that motion.

♦ J. Wolf moved, seconded by S. Terhune, that the issue be referred back to the Ad Hoc Committee with the sense that the Board is interested in converting the existing LPP's to LP's. I) Public Session.

II) Approval of Minutes.

A) Minutes of the Board Meeting of June 25, 2004.

III) Administrative Matters.

A) Legislative Committee Update

- ◆ S. Terhune reported on the progress of the Legislative Committee. The Committee met on August 4, 2004 and discussed the following issues:
 - The Committee reviewed some possible housekeeping changes.
 - The Committee will review the crimes against providers bill that was dropped from the Board's 2003 legislative agenda. The focus of the Committee is to address the language issues that prompted the Board to drop the bill before and to attempt to make the language less ambiguous.
 - The Committee will propose changes to the definition of practice of psychology.
 - The Committee will discuss proposed language changes at its next meeting on August 25, 2004.

B) Rules Committee Update.

• J. Schaffer provided the update from the Rules Committee. Dr. Schaffer reported that the Board will review the licensure rules later in today's Board meeting. The Committee's next step is to re-review for cohesiveness, the rules of Continuing Education and then the Rules of Conduct.

C) Ad Hoc Committee on LPP Licensure.

At its June 25, 2004 meeting, the Board requested that the Ad Hoc Committee on LPP Licensure present at the August Board meeting specific criteria for transferring qualified LPP's to LP's and

eliminating LPP licensure. The Ad Hoc Committee met and presented parameters for the Board's consideration. The Committee recommended that the Board of Psychology:

- Rescind its previous vote to create independent practice for LPP's.
- Transfer to LP licensure individuals who:
 - (a) complete degree requirements for the LPP licensure and make application to the Board for licensure as an LPP by December 31, 2005.
 - (b) pass both the EPPP and PRE by December 31, 2006; and
 - (c) document a minimum of two full years (or part time equivalent, but not less than half time) of supervised practice after receiving LPP licensure, but before December 31, 2010. Supervised practice shall consist of two hours per week (at least one hour face-to face) of supervision for full-time practice, or equivalent for part time practice.
- Stop accepting LPP applications after December 31, 2005.
- All LPP's who wish to transfer the LPP license to a LP must have met all requirements within four years from December 31, 2006, or from the date of initial LPP licensure, whichever is later.
- Sunset the LPP licensure as of December 31, 2010.
- ♦ S. Terhune moved, seconded by M. Farinacci that the proposal be amended so that an LPP cannot transfer licensure to LP status unless the LPP has no unresolved disciplinary actions or complaints pending in any jurisdiction. Voting "aye": M. Farinacci, G. Jensen, J. Peterson, J. Romano, M. Seibold, S. Terhune, T. Thompson, and J. Wolf. Voting "nay": none. There being eight ayes and no nays, motion carried unanimously.
- ♦ S. Terhune moved, seconded by M. Farinacci that the proposal be amended so that applicants must be Minnesota residents on December 31, 2005, to eliminate the possibility that unknown numbers of individuals would come to Minnesota for master's level LP licensure, since the Board has already determined the entry level into LP licensure shall be a doctoral degree. - **B**) The Board also discussed the possible impact of rejecting settlements, proposed by Complaint Resolution Committees to resolve complaints. This discussion was held in Executive Session because of the need to use actual non-public case-specific data as examples.

II) Public Session.

A) Board Chair, J. Schaffer, called the public session to order at 9:52 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

III) Approval of Minutes.

IV) Administrative Matters.

A.) Rules Committee Update.

◆ J. Schaffer reported on the progress of the Rules Committee. The Rules Committee continues its work finalizing the rules of licensure not previously addressed by the Committee and will work on these rules at its meeting following this Board meeting. After completing the Licensure Rules, the Rules Committee will work to finish the Continuing Education Rules, and then the Rules of Conduct.

B.) Legislative Committee Update.

♦ S. Terhune reported on the progress of the Legislative Committee. He reported that the meeting that had been scheduled for August 25, 2004 was postponed and rescheduled for

September 16, 2004. The Committee will discuss the Crimes Against Providers language, which was removed from the 2003 legislative agenda, proposed changes to the language of the statute having to do with licensed psychological practitioner's (LPP) scope of practice, and some housekeeping changes to the Psychology Practice Act. The Committee will also review at its next meeting, proposed language to convert existing LPP's to licensed psychologists and sunset LPP licensure. In reply to a Board member question, P. Walker-Singleton explained the process the Committee will follow to get the language passed into law, which includes meeting with other stakeholders, finding legislative sponsors, working with the sponsors to obtain the necessary hearings in both houses, and testifying before legislative committees.

C.) Executive Director Personnel Subcommittee.

- ♦ At the June 25, 2004 Board meeting, J. Schaffer requested that J. Romano create, resurrect, or revise a procedure for completing regular performance reviews of the Executive Director. A Personnel Subcommittee was formed to devise the procedure and report back to the Administrative Committee of the Board. J. Lee and M. Farinacci volunteered to sit on the subcommittee, along with subcommittee chair, J. Romano.
- ♦ The Subcommittee met and created a proposed procedure. The Subcommittee then met with the Administrative Committee, which approved the document for presentation to the full Board for adoption at the September 10, 2004 meeting.
- ♦ The proposal is as follows:
 - **1.** The Administrative Committee (AC) is responsible for the evaluation procedure of the Executive Director (ED).
 - **2.** Prior to each performance review, the ED shall review and update the ED position description, if necessary.
 - **3.** An ED biennial performance review shall be initiated in odd numbered years in February and shall be completed by May 1st by the Board's AC. The performance review is best completed during odd years to coincide with the most recent biennial report to the legislature and the most recent budget papers.
 - **4.** Members of the Board shall be solicited for their opinions about the ED's performance via the performance evaluation survey developed for the Board.
 - **5.** The Board staff shall be solicited for their opinions about the ED's performance via the performance evaluation survey developed for the staff.
 - **6.** The ED shall complete a brief assessment of self and of Board operations during the past two years, including successes, challenges, and operational needs of staff and staff retention and turnover. The assessment is to be shared with the AC. The ED shall attach the most recent biennial report, budget papers and any audit reports.
 - 7. Results of the performance evaluation surveys (all surveys are completed anonymously, except for an indication of Board staff or Board member) shall be collated, summarized and shared with the ED as well as the total Board in Executive Session by the Board Chair.
- ♦ The Administrative Committee moved approval of the proposal. Voting "aye": S. Hayes, G. Jensen, J. Lee, J. Peterson, J. Romano, M. Seibold, S. Terhune, T. Thompson, and J. Wolf. Voting "nay": none. There being nine ayes and no nays, motion carried unanimously.

 - **5.** Online universities and courses and ways to monitor their quality of education.
 - **6.** Mobility for psychologists between jurisdictions.
 - 7. Changes in experiential requirements for licensure.
 - **8.** The international consortium which has been formed to discuss a universal code of conduct for psychologists.

I) Executive Session.

A) On the recommendation of the Complaint Resolution Committee, the Minnesota Board of Psychology adopted a Stipulation and Consent Order that Indefinitely Suspends the license of Michael Rhubee, M.S.Ed., LP.

II) Public Session.

A) Board Chair, J. Schaffer, called the public session to order at 10 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

III) Approval of Minutes.

A) Minutes of the Board Meeting of September 10, 2004.

S. Hayes moved, seconded by T. Thompson, that the minutes of the Board meeting of September 10, 2004 be approved. Voting "aye": S. Hayes, G. Jensen, J. Lee, J. Romano, T. Thompson, and J. Wolf. Voting "nay": none. Abstaining: M. Farinacci. There being six ayes and no nays, motion carried.

IV) Administrative Matters.

A.) Rules Committee Update.

◆ J. Schaffer reported on the progress of the Rules Committee. The Rules Committee is working on rules for EPPP procedures and license termination. The Committee will then work on finalizing the rules of continuing education and the rules of conduct.

B.) Legislative Committee Update.

- ♦ S. Terhune reported on the progress of the Legislative Committee. The Legislative Committee moved approval of proposed changes to the Psychology Practice Act.
- Below are the proposed changes and the actions taken by the Board:
- **A.** Regarding Licensed Psychological Practitioners (LPP). The Committee's proposal was that qualifying LPP's be allowed to convert their licensure to licensed psychologist (LP) licensure and that LPP licensure be eventually eliminated. The changes would:
 - 1. adjust the Board composition so that at a future date, there would be no requirement to have LPP's as members of the Board;
 - 2. create a "conversion" option to LP licensure for LPP's who qualify;

- 3. give deadline dates for LPP's to complete specific steps towards converting to LP licensure:
- 4. give a date that the licensure of all remaining LPP's would terminate, and LPP licensure in the state would be eliminated.

Board Action on amendment to #1 above.

- 1. The proposed language would have taken the current LPP seat on the Board and made that seat available for appointment to either an LP or LPP. J. Romano moved, seconded by J. Lee that the Committee's motion be amended to keep the seat reserved for an LPP, but to state that after January 1, 2012, the seat shall be filled with an LP. Voting "aye": M. Farinacci, S. Hayes, J. Lee, J. Romano, T. Thompson, and J. Wolf. Voting "nay": G. Jensen. There being six ayes and one nay, motion carried.
- **B.** Regarding the Definition of the Practice of Psychology. (Minn. Stat. 148.89, subd. 5) The Committee's proposal was to amend the definition to add a phrase that makes the definition of the practice of psychology apply to the work of forensic and industrial organizational psychologists.
- **C.** Regarding Licensure for Volunteer Practice. (Minn. Stat. 148.909) The Committee's proposal was to remove the provision stating that the Board may grant licensure for volunteer practice to only former licensees.
- **D.** Regarding Supervisee Duties. (Minn. Stat. 148.925, subd. 6) The Committee's proposal was to add a reference to the specific subdivision (Subd. 5) of Minnesota Statute 148.89 referred to in this law. Subdivision 5 describes what duties a supervisee for licensure is allowed to perform.
- **E.** Regarding Disciplinary Remedies Available to the Board for Violation of the Psychology Practice Act. [Minn. Stat. 148.941, subd. 2(c)] The Committee's proposal was to remove the word "continued", which appears before the word "licensure". This change makes it clear that the Board is able to impose the same sanctions against applicants as it can against licensees.
- **F.** Regarding the Section on Exemptions from Licensure. [Minn. Stat. 148.96, subd. 3(b)] The Committee's proposal changes the words "agencies" and "facilities" to "agency" and "facility". The change makes it clear that the "agency" or "facility" referred to must be a "federal, state, county, or local government agency or facility".
- **G.** Regarding Crimes Against Providers. (Minn. Stat. 148.977) This is a proposal for a new provision to the Psychology Practice Act. The provision would inform providers and the public of the rights providers have when they are victims of a crime that they know was committed by a client or a former client. The provision allows the provider to disclose the identity of the client or former client and to acknowledge the professional relationship to the appropriate law enforcement agency. The provision does not allow the provider to disclose private information in the client's record not specifically related to the crime.

BOARD VOTES:

The Legislative Committee moved approval of items A through G above. The Board voted unanimously to approve each item.

C.) Board of Psychology Remodeling Schedule.

♦ The building owners are remodeling the health licensing Boards' offices. The Board of Psychology's remodeling dates are Friday, October 22, 2004 through Friday, October 29, 2004. During much of that time, staff will have little access to office equipment, but will provide services as possible. L. Sherry presented to the Board the remodeling schedule.

D.) Biennial Report for Fiscal Years 2003 and 2004.

◆ P. Walker-Singleton presented for the Board's information, the latest Biennial Report to the Legislature.

E.) Proposed 2005 Board Calendar.

• P. Walker-Singleton presented a proposed calendar of Board meeting dates for calendar year 2005. The Board approved the calendar by consensus.

PUBLIC SESSION

Board Chair, J. Schaffer called the public session of the meeting to order at 10:07 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

1. Minutes of the Board Meeting of November 5, 2004.

S. Hayes moved, seconded by J. Wolf that the minutes of the Board meeting of November 5, 2004 be approved. Voting "aye": M. Farinacci, S. Hayes, J. Lee, J. Peterson, J. Romano, M. Seibold, S. Terhune, T. Thompson, and J. Wolf. Voting "nay": none. Abstaining: G. Jensen. There being nine "ayes" and no "nays", motion carried.

2. Administrative Matters.

a. Rules Committee Update. J. Schaffer gave an update on the progress of the Rules Committee.

- ◆ The Rules Committee is still working to finalize the Rules of Conduct. Perhaps the Committee will have to bring the Rules back to the Board for approval, ½ at a time.
- ♦ The final draft of the Rules of Continuing Education (CE) was presented to the Board for approval. Dr. Schaffer summarized the Committee's proposed changes for the Board:
 - 1. The Committee reorganized the section of the CE rules regarding the types of CE activities eligible for approval, making changes in order to simplify the list and make it user-friendly. The new list contains all eligible CE offerings, beginning with the types of CE licensees use most often and then it continues to other types of CE.
 - 2. The Committee eliminated Individually Designed Continuing Education, because 40 hours of CE within two years does not appear to be a burdensome requirement.
 - 3. The Committee added an audit system to be applied to 10% of the renewing licensees in order to reduce the processing time for CE.
 - 4. The Committee added a provision allowing for automatic approval for CE approved by the American Psychological Association, the Association of State and Provincial Psychology Boards, or other national professional organizations as determined by the Board.
 - 5. The Committee added a provision to allow for the discontinuance of the automatic approval by the Board of six-month time-limited variances for completion of CE. In addition, if CE is not completed by the renewal date, the renewal will be incomplete and the licensee will have to pay the late fee.

The Rules Committee moved approval of the proposed continuing education rules. The Board proposed no changes to the rules as presented and voted on the Committee's motion. Voting "aye": M. Farinacci, S. Hayes, G. Jensen, J. Lee, J. Peterson, J. Romano, M. Seibold, S. Terhune, T. Thompson, and J. Wolf. Voting "nay": none. There being ten "ayes" and no "nays", motion carried unanimously.

- **b.** Administrative Committee Update. The Administrative Committee met on December 2, 2004. The Committee was updated by J. Vangsness and P. Walker-Singleton on the status of the fiscal year (FY) 2005 budget and the budget planning for the next biennium of FY 2006-2007. J. Schaffer reported that the Committee invited Juli Vangsness, Accounting Supervisor for the Health Licensing Boards' Administrative Services Unit to attend a Board meeting so that the information can be presented to the full body. Ms. Vangsness will attend the January 28, 2005 Board meeting.
- c. Board Sponsored Continuing Education (CE) Activity. At the November Board meeting, J. Schaffer reported that the Maryland Psychology Board had used a budget surplus to sponsor a CE activity, which was free of charge to their licensees, on the subject of supervision. Following discussion, J. Romano moved, seconded by J. Peterson that the Minnesota Board investigate offering a free CE to licensees, if revenues allow, before June 30, 2005, the end of the current fiscal year. J. Romano suggested cultural competence and ethics/boundaries as possible topics. Voting "aye": M. Farinacci, S. Hayes, G. Jensen, J. Lee, J. Peterson, J. Romano, M. Seibold,

- **d.** Psychology Board's Representative to the Program Committee for the Health Professionals Services Program (HPSP). Each year, the Board of Psychology appoints a representative to HPSP's Program Committee. J. Peterson volunteered to continue as the Board's representative, and S. Hayes volunteered to be the alternate representative for the 2005 calendar year.
