EXECUTIVE SESSION

Board Chair, M. Seibold, called the executive session of the meeting to order at 9:07 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis. Minnesota, and a quorum was declared present.

PUBLIC SESSION

Board Chair, M. Seibold called the public session of the meeting to order at 9:20 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

1. Approval of Minutes

a. Board Meeting of December 9, 2005.

J. Romano moved, seconded by S. Hayes that the minutes of the Board meeting of December 9, 2005 be approved as amended. Voting "aye": S. Hayes, G. Jensen, J. Lee, J. Peterson, J. Romano, S. Terhune, T. Thompson, and S. Ward. Voting "nay": none.. There being eight "ayes" and no "nays", the motion carried.

b. Board Meeting of November 4, 2005, Executive Session.

T. Thompson moved, seconded by J. Jensen that the minutes of the Executive Session for the November 4, 2005 Board meeting be approved as amended. Voting "aye": S. Hayes, G. Jensen, J. Lee, J. Peterson, J. Romano, S. Terhune, T. Thompson, and S. Ward. Voting "nay": none. There being eight "ayes" and no "nays", the motion carried.

2. Administrative Matters

a. Rules Committee Update. S. Terhune reported that all members of the Rules Committee are working on the Statement of Need and Reasonableness (SONAR) and will exchange comments by e-mail. This compiled information will then be reviewed by N. Hart and P. Walker-Singleton.

- **b. ASPPB 2006 Midyear Meeting.** P. Walker-Singleton announced the dates and expense details for the 21st Midyear Meeting in April, 2006 at Sandestin, Florida and requested that the Board decide whether to send a representative and to decide who should attend. The Board budget can support up to six conference attendees. The following individuals expressed an interest and availability: N. Hart, S. Ward, S. Hayes, P. Walker-Singleton and J. Wolf.
- **c.** Council of Health Boards' (CHB) Representative. P. Walker-Singleton submitted a request that a member be selected to represent the Board of Psychology on the CHB. S. Ward agreed to be the alternate representative to the HPSP and the regular representative to the CHB.

3. Waivers/Variances.

Applicant LP 0701 requested a waiver of the late renewal fee. J. Romano moved, and S. Hayes seconded a motion to <u>approve</u> the request for a waiver of the late renewal fee (Rule part 7200.3500) for Applicant LP 0701. Voting "aye" were S. Hayes, G. Jensen, J. Lee, J. Peterson, J. Romano, S. Terhune, T. Thompson and S. Ward. With eight "ayes" and no "nays," the vote carried unanimously.

Applicant LP 3341 requested a waiver of the late renewal fee. It was moved by J. Romano and seconded by J. Voting "aye" were S. Hayes, G. Jensen, J. Lee, J. Peterson, J. Romano, S. Terhune, T. Thompson and S. Ward. Voting "nay", none. The motion was carried unanimously.

The Application Review Committee recommended <u>denial</u> of variance request from Applicant 06C-133 to MN Rule 7200.1300, Subp. 4, B (4), Educational Requirement for Licensure. Voting "aye" were S. Ward, T. Thompson, S. Terhune, J. Romano, J. Peterson, J. Lee, G. Jensen and S. Hayes; voting "nay", none. The vote carried unanimously.
