February 24, 2006

PUBLIC SESSION

Board Chair, M. Seibold called the public session of the Special Board Meeting to order at 10:43:30 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

1. Rescind Board Termination.

The name of Marlys Blomquist, PhD, LP was placed on the list of names for Board termination for non-renewal. At the January 27, 2006 Board meeting, the Board voted to terminate Dr. Blomquist's license. Following the meeting, staff found that Dr. Blomquist had written to the Board and requested voluntary termination of her license and requested an application for emeritus status.

D. Sellin-Beckerleg requested that the Board rescind the January 27, 2006 action terminating the license of Marlys Blomquist. J. Peterson moved, seconded by T. Thompson that the January 27, 2006 Board action be rescinded. Voting "aye": G. Jensen, J. Lee, J. Peterson, J. Romano, T. Thompson, and J. Wolf. Voting "nay": none. There being six "ayes" and no "nays", the motion carried unanimously.

2. Adoption of APA Rule.

The Rules Committee moved adoption of the following resolution approving and adopting the APA rule:

CERTIFICATE OF THE BOARD OF PSYCHOLOGY; RESOLUTION ADOPTING RULE

Adoption of Rule Governing Educational Requirement, Rule 7200.1550.

I, Myrla Seibold, do hereby certify that I am a member and Chair of the Board of Psychology, a board duly authorized under the laws of the State of Minnesota, and that the following is a true, complete, and correct copy of a resolution adopted at a meeting of the Board of Psychology, duly and properly called and held on the 24th day of February, 2006, that a quorum was present, and that a majority of those present voted for the resolution which has not been rescinded or modified.

“RESOLVED that the rule relating to the educational requirements for licensure in the form set out in Revisor of Statutes draft, file number AR 3453, dated November 28, 2005, identified as Minnesota Rules, part 7200.1550, are approved and adopted, pursuant to authority vested in the Board of Psychology by Minnesota Statutes, sections 148.905, subdivision (7), 148.905, subdivision 2, and 214.06, subdivision 1. Pauline Walker-Singleton, Executive Director of the Board of Psychology is authorized to sign the Order Adopting Rules and further is authorized to modify the rules if necessary to obtain the approval of the rules by the Revisor of Statutes or the Administrative Law Judge and to perform the necessary acts to provide that the rules shall have the force and effect of law”

Voting “aye”: G. Jensen, J. Lee, J. Peterson, J. Romano, T. Thompson, and J. Wolf. Voting “nay”: none. There being six “ayes” and no “nays”, the motion carried unanimously.

3. Adjournment.

J. Romano moved, seconded by J. Wolf that the meeting be adjourned. Voting “aye”: G. Jensen, J. Lee, J. Peterson, J. Romano, T. Thompson, and J. Wolf. Voting “nay”: none. There being six “ayes” and no “nays”, the motion carried unanimously. The meeting was adjourned at 10:54 AM.
