EXECUTIVE SESSION

- **1.** On the recommendation of the Complaint Resolution Committee, the Minnesota Board of Psychology adopted an Order for Unconditional License of Donna Bahr, PsyD, LP.
- **2.** The Professional Responsibility Examination Committee reported that the questions on the examination have been changed to eliminate the chance that an applicant can pass the examination as a result of the previous security issues.

PUBLIC SESSION

Board Chair, M. Seibold called the public session of the meeting to order at 9:55 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

1. Approval of Minutes.

- a. Board Meeting Minutes-June 23, 2006.
- J. Romano moved, seconded by S. Ward that the minutes of the Board meeting of June 23, 2006 be approved as submitted. Voting "aye": M. Fulton, S. Hayes, G. Jensen, J. Lee, T. Nguyen-Kelly, J. Romano, T. Thompson, S. Ward, and J. Wolf. Voting "nay": none. There being nine "ayes" and no "nays", the motion carried unanimously.

2. Administrative Matters.

- **a. Meet the New Board Members.** The Governor made appointments to the Board of Psychology. He reappointed Myrla Seibold, PhD, LP to a third term on the Board. For her first term, Dr. Seibold served out less than ½ of a term of a previous Board member and was, therefore, eligible for reappointment. Governor Pawlenty appointed to the Board, Margaret Fulton, PhD, LP replacing Jack Schaffer, PhD, LP and Thanh Son Thi "Lisa" Nguyen-Kelly, PhD, LP replacing the late Scott Terhune, PhD, LP.
- **b.** Continuing Education (CE) Planning Committee. J. Wolf reported that the Committee has secured a date for the next Board-sponsored continuing education activity. The Continuing Education and Conference Center at the University of Minnesota St. Paul campus has been reserved for April 20, 2007. The Committee is considering topics for the CE, including Autonomy

vs. Dependency over the Lifespan and Confronting Anxiety in a Culture of Fear. M. Seibold suggested aging as a topic for the Committee's consideration. J. Romano recommended considering a format of a keynote speaker plus smaller breakout sessions.

The Committee will continue to meet to further develop ideas and will report to the Board.

c. Association of State and Provincial Psychology Boards' (ASPPB) $46^{\rm th}$ Annual Meeting of Delegates.

ASPPB will hold its 2006 Annual Meeting of Delegates on October 25-29, 2006 at the Catamaran Hotel in San Diego, CA. Staff prepared a tentative budget and recommended that the Board send four representatives to the meeting.

The Board decided by consensus to send, subject to availability, J. Wolf, M. Seibold, M. Fulton, and P. Walker-Singleton. If Dr. Fulton is unable to attend the meeting, J. Romano was named as her alternate.

11. Emeritus Registration.

12. Other Business.

a. Follow up on the Inter-jurisdictional Practice Certificate (IPC)

At the June 23, 2006 Board meeting, the Board discussed the Association of State and Provincial Psychology Boards' (ASPPB) proposal to develop a new mobility opportunity for psychologists

who wish to practice as consultants in other jurisdictions without licensure. ASPPB requested feedback on the proposal from the member jurisdictions.

After discussion, the Board directed staff to convey to ASPPB that the Board supports the concept of another mobility option for psychologists, however, the provisions of the IPC, as proposed, needs more development. The Board stated that the issues raised by the proposal are important ones for jurisdictions that have never addressed them before, but the Minnesota Board is not ready to "endorse" the IPC, believing that the concept needs more development.

In addition, the Minnesota Board has in place a Guest Licensure law that appears to meet Minnesota's needs regarding the same or similar issues discussed in the IPC proposal. The positive aspects of Minnesota's guest licensure law as we see them include the fact that it allows consultants, presenters, educators, and expert witnesses quicker, easier, more streamlined access to practice for a short time when they are not licensed in this jurisdiction; the law does not interfere during disaster or emergency relief efforts by requiring a lengthy credentialing process. Minnesota has had the law in its current form since 1996 and it adequately addresses those issues in this state.

Based on our own experience, we reduced the number of days an individual is allow to practice under guest licensure from 60 days (as allowed by the IPC) to 30 days, because the Board found that 60 days allowed an individual in a border state, for example, to maintain a lucrative practice in Minnesota one day a week with only guest licensure. The Board found that to be too frequent and not in the interest of protecting the public to allow practice that often with no assurance that the guest licensees know or adhere to the Minnesota Psychology Practice Act. The Board found 30 days to be adequate to allow licensed psychologists to complete temporary tasks with little intrusion. In the past 10 years, we have received no complaints from guest licensees that 30 days was too short.

The Board concluded its comments to ASPPB by stating that the IPC had restrictions Minnesota's guest licensure law does not have, such as requiring that in order to qualify for the IPC, the individual must have no disciplinary action. (We require no unresolved disciplinary action or pending complaints.) Also, the IPC does not allow psychotherapy, treatment, or diagnosis. These are skills needed for disaster or emergency relief efforts, which we do cover in the law.

Finally, the Board wondered why the credential is called a "certificate", but the process is called "registration"?

Following receipt of the Board's comments, Barb Van Horne, PhD, MPH, responded on behalf of the ASPPB Board stating that the information provided was "very helpful" and that it "sheds new light on the process."

b. Memorial for the late Scott Terhune, PhD, LP.

Dr. Terhune's widow contacted the Board of Psychology office and provided information about a memorial set up in Dr. Terhune's honor. The Board decided that most of them will transmit their own contributions to the memorial, but that some may ask staff to transmit the contributions.

c. Article for the Minnesota Psychological Association's Newsletter.

The Board will not have a contribution to submit to the next issue of the *Minnesota Psychologist*. However, G. Jensen volunteered to prepare for the following issue an article on the current Board members.

11. Adjournment.

J. Romano moved, seconded by S. Hayes that the meeting be adjourned. Motion carried unanimously. The meeting adjourned at 10:59 AM.
