## **PUBLIC SESSION**

Board Chair, M. Seibold called the public session of the meeting to order at 10:01 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

#### 1. Minutes of the Board Meeting of November 3, 2006.

#### 2. Administrative Matters.

**a.** Continuing Education (CE) Planning Committee Update. J. Wolf updated the Board on the progress made by the Committee. The Committee met following the November 3, 2006 Board meeting. Dr. Wolf reported that the Committee is planning to present the following speakers on the program:

Panelists: Tom Huntley, PhD, State Representative and Chair, House Health Care and Human Services Finance Division (Duluth); Jeff Liechter, PhD, LP (Detroit Lakes); Harvey Linder, PhD, LP, Former Board of Psychology member (Hennepin County); Craig Stevens, PhD, LP (Virginia).

The Committee is continuing to contact and solidify commitments from speakers and panelists.

- T. Nguyen-Kelly recommended that in advertisement materials, the Committee also include refugees as a part of the population disadvantaged by poverty.
- **b. Minnesota Responds.** On November 16, 2006, S. Hayes represented that Board at a meeting of the Minnesota Responds Task Force. Ms. Hayes reported that the meeting focused on the Emergency Systems for Advance Registration of Volunteer Health Professionals (ESAR-VHP) draft compliance requirements. Ms. Hayes provided the Board with the draft requirements and pointed out the items she considered to be the most important points.
  - ♦ Each state is required to develop an electronic system for managing volunteer data based on the data definitions and schema to be presented in the HRSA ESAR-VHP Guidelines. Minnesota has met this requirement.
  - ♦ Each electronic system must be able to register and collect verified credentials of priority health professionals. The list of priority health professionals includes psychologists. Minnesota is a Category A state which means that it must meet the requirements by August 2007 and report on compliance in the End-of-Year Progress Report that is due December 2007.
- c. Presentation on the Health Professionals Services Program (HPSP). Each year HPSP gives the Board an overview of the Program and statistical information. K. Roberts presented to the Board information about participation by Board and fiscal year, caseloads of the case managers, statistics and information about referrals, discharges, and utilization review.
- **d. Board Officer Elections.** The Board held its annual election of Board officers for the 2007 calendar year. Officers elected: M. Seibold-Board Chair; T. Thompson-Board Vice Chair; S. Hayes, Board Secretary.

#### 11. Other Business.

- **a.** P. LaBrocca presented an Agreement for Corrective Action for the Board's information.
- **b.** MN Stat. section 270C.72 mandates that the Board of Psychology revoke the license of a licensee with overdue state tax liability. P. LaBrocca presented for the Board's information an Order for Revocation issued pursuant to the provisions of that law.
- **c.** P. LaBrocca presented to the Board instructions and information on sending "secure" emails.
- **d.** S. Ward informed the Board that she attended a meeting of the Council of Health Boards during which a review panel consisting of twelve Council members presented its review of a legislative proposal to license naturopathic doctors (HF4205/SF3232). Council members gave feedback on the review panel's draft report to the Legislature.
- e. M. Seibold represented the Board of Psychology at meetings of a mental health task force formed by the Department of Human Services (DHS). Legislation passed in June 2006 charged DHS, in conjunction with the mental health licensing Boards, with evaluating the requirements for licensed mental health practitioners to receive medical assistance reimbursement. The DHS representative who staffed the task force issued a draft report entitled, *Baseline of Competency: Common Licensing Standards for Mental Health Professionals*.

The Board thoroughly reviewed the report and discussed the flaws in the report in content and method. J. Romano moved, seconded by M. Fulton that the Board authorize Myrla to write a letter to the author of the report, Gary Cox, stating that the Board of Psychology will not endorse the report in its current form. Voting "aye": M. Fulton, S. Hayes, G. Jensen, J. Lee, T. Nguyen-Kelly, J. Romano, T. Thompson, S. Ward and J. Wolf. Voting "nay": none. There being nine "ayes" and no "nays", motion carried unanimously.

M. Fulton moved, seconded by T. Thompson that the Board create a Committee on the DHS Task Force Report to write a minority report with or without other health licensing Boards and submit it to DHS without further input from the Board. Volunteers to serve on the Committee were: M. Seibold, M. Fulton, G. Jensen, and T. Nguyen-Kelly. Voting "aye": M. Fulton, S. Hayes, G. Jensen, J. Lee, T. Nguyen-Kelly, J. Romano, T. Thompson, S. Ward and J. Wolf. Voting "nay": none. There being nine "ayes" and no "nays", motion carried unanimously.

# 12. Adjournment.

J. Romano moved, seconded by S. Hayes that the meeting be adjourned. Motion carried unanimously. The meeting adjourned at 12: 15 PM.
