PUBLIC SESSION

Board Chair, M. Seibold called the public session of the meeting to order at 9:14 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

1. Minutes of the Board Meeting of December 8, 2006.

T. Thompson moved, seconded by J. Wolf that the minutes of the Board meeting of December 8, 2006 be approved as amended. Voting "aye": M. Fulton, G. Jensen, J. Lee, T. Nguyen-Kelly, J. Romano, T. Thompson, S. Ward, and J. Wolf. Voting "nay": none. There being eight "ayes" and no "nays", motion carried unamimously.

2. Administrative Matters.

- **a.** Continuing Education (CE) Planning Committee Update. J. Wolf provided the following update:
 - All three speakers on the program have confirmed.
 - o All panelists are confirmed, except one. The Committee is working on obtaining someone to sit on the panel who is a state legislator, preferably a member of a health committee. Dr. Wolf asked for suggestions of legislators from the Board. G. Jensen suggested Representative Mindy Greiling and T. Nguyen-Kelly recommended Senator Mee Moua.
- b. Committee on DHS Task Force Report Update. M. Seibold reported that the Department of Human Services (DHS) has submitted a final draft and recently a final report. The Committee has written a response to the final draft and will be meeting following this Board meeting to review DHS' final report. At the meeting, the Committee will determine what changes, if any will need to be made to its response in order to address DHS' final report. Dr. Seibold summarized the Board's response. She pointed out that the Committee took issue with the following:
 - o DHS' process used to assemble the task force and conduct meetings was flawed.

- The DHS report itself was flawed; there was no data developed to support statements/allegations in the report.
- o DHS' recommendations in the report are skewed because there was actually no study made. In addition, the make up of the task force was heavily weighted to one profession and voting was allow by whomever attended each meeting, not taking into account that actual task force members were not always present and each meeting was attended by non-task force members.
- o The recommendations in the DHS report differ from psychology licensure requirements. While the Board does not, at this point, have to change licensure requirements, if the recommendations become law, psychology licensees may not qualify for reimbursement through DHS.
- The DHS recommendations will create poor results for underserved and rural populations in Minnesota.
- The report does not state how individuals licensed as master's level licensed psychologist will qualify for reimbursement through DHS.
- **o** In the report, the issue of reimbursement is being confused with the issue of licensure.
- **c. ASPPB 2007 Midyear Meeting.** P. Walker-Singleton reported that the 22nd Midyear Meeting of the Association of State and Provincial Psychology Board (ASPPB) will be held April 26-29, 2007 at the Louisville Marriott Downtown in Louisville, Kentucky. The Board's budget can support sending up to five representatives to the conference.

The Board determined that the following individuals should represent the Board at the meeting: J. Romano, M. Fulton, T. Nguyen-Kelly, N. Hart, and P. Walker-Singleton. J. Wolf will attend if one of the others is unable to attend.

3. Waivers/Variances.

a. Each of the following licensees requested approval of a six-month time-limited variance to complete requirements for continuing education (CE). Each licensee has submitted the required CE plan in compliance with MN Rule 7200.3400, subpart 2.

J. Romano moved, seconded by M. Fulton that the variance requests be approved on the basis that the licensees met the burden to prove that adherence to the rule would impose an undue burden on the licensees, that granting the variances will not adversely affect the public welfare, and that the alternatives proposed meet the rationale for the rule. Voting "aye": M. Fulton, G.

Jensen, J. Lee, T. Nguyen-Kelly, J. Romano, T. Thompson, S. Ward, and J. Wolf. Voting "nay": none. There being eight "ayes" and no "nays", motion carried unamimously.

- **b.** Karen Jeffords-Brown, MA, LP (LP1793) renewed her license in November 2006 and her next renewal will be due November 2008. In order to renew in November 2006, the licensee presented evidence of 40 hours of CE. Licensee contacted the Board office to see if she could use an activity completed last September 2006 to renew her license in 2008. As is the case with all licensees who earn more than the required 40 hours of CE for renewal, Ms. Jeffords-Brown was told that Minn. Rule 7200.3820 states that the CE used for renewal must have been completed during the preceding renewal period and the September 2006 activity would not fall within that timeframe for her 2008 renewal. Ms. Jeffords-Brown submitted a variance request to the Board requesting that the Board apply the September 2006 continuing education activity to her November 2008 renewal.
- S. Ward moved, seconded by J. Wolf that the variance request be denied on the basis that the licensee did not meet the burden to prove that adherence to the rule would impose an undue burden on the licensee. Voting "aye": M. Fulton, G. Jensen, J. Lee, T. Nguyen-Kelly, J. Romano, T. Thompson, S. Ward, and J. Wolf. Voting "nay": none. There being eight "ayes" and no "nays", motion carried unanimously.
- c. George L. Horvat, PhD, LP called the Board office during the week of January 8, 2007 stating that he did not receive his renewal materials. He was told that he could download the renewal form from the Board's website, which he did. Staff explained that he had now incurred a late renewal fee and that he had to pay the fee, but he could request that the Board waive the fee in the event that his reasons for making the waiver request meet rule requirements for a waiver. It is the Board's practice to mail notices of license renewal approximately 45 days in advance of the renewal deadline date. In accordance with that practice, notices for December 2006 renewals were mailed to licensees on November 16, 2006.
- Dr. Horvat's renewal notice was mailed to his Blountstown, Florida address, the Board's address of record on November 16, 2006. However, the mailing was returned to the Board office on November 28, 2006, with a postal service yellow sticker stating, "Temporarily Away, Return to Sender." If we had been provided with a forwarding address, the renewal packet would have been re-mailed to the new address immediately. Minnesota Statute section 13.41, subdivision 2(b) states that a licensee who is subject to a health licensing Board, must designate to the Board a residence or business address at which the licensee can be contacted in connection with the license. It is the licensees' responsibility to notify the Board if they change addresses before their next renewal.
- J. Romano moved, seconded by M. Fulton that the waiver of the late renewal fee (Rule part 7200.3500.) be denied on the basis that the licensee did not meet the burden to prove that adherence to the rule would impose an undue burden on the licensee, and that the granting of the waiver will not adversely affect the public welfare. Voting "aye": M. Fulton, G. Jensen, J. Lee, T. Nguyen-Kelly, J. Romano, T. Thompson, S. Ward, and J. Wolf. Voting "nay": none. There being eight "ayes" and no "nays", motion carried unanimously.
