EXECUTIVE SESSION

On the recommendation of the Complaint Resolution Committee, the Minnesota Board of Psychology adopted the following actions:

1. A Stipulation and Consent Order allowing Mark Trelstad, Psy.D. (terminated) to Surrender his license to practice psychology in Minnesota.

2. A Stipulation and Consent Order placing the license of John Baumgart, M.S., LP in a Restricted and Conditional status.

PUBLIC SESSION

Board Chair, T. Thompson called the public session of the meeting to order at 9:24 AM, in the Psychology Board Conference Room, at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

1. Minutes

a. Board Meeting of October 10, 2008.

J. Brown moved, seconded by J. Wolf that the minutes of the Board meeting of October 10, 2008 be approved as submitted. Voting "aye": C. Bonnell, J. Brown, M. Fulton, G. Jensen, J. Lee, M. Seibold, S. Ward and J. Wolf. Voting "nay": none. Abstaining: S. Hayes. There being eight "ayes" and no "nays", motion carried.

2. Administrative Matters.

a. Presentation on the Health Professionals Service Program (HPSP) in December. HPSP is a diversion program for impaired licensed health professionals, which is funded by revenue from the health licensing Boards. Each year, Program Manager, Monica Feider or her designee gives the Board an overview of the Program and statistical information. An HPSP representative will appear at the Board meeting on December 19, 2008 at 10:30 AM.

b. Task Force on the Mental Health Needs of Deaf & Hard of Hearing Children (D/HH). This Task Force held its first meeting October 30, 2008. The two keynote speakers, Laurel Wills, MD, specializing in pediatrics at Hennepin County Medical Center and her sister Karen Wills, Ph.D., LP, ABPP, a Neuropsychologist with Children's Hospital and Clinics, spent much of their

private lives and all of their professional careers working with children and youth who are Deaf or Hard of Hearing (D/HH). Their shared keynote address focused on the mental health care needs of D/HH children and youth. Particularly, they covered socioeconomic stressors, cultural stressors, and communication strategies for the D/HH children, youth and their hearing families. The superintendent of Minnesota State Academy for the Deaf and President of Volunteers of America—Minnesota discussed their joint effort in creating the first in-house day treatment program to address behavioral issues of D/HH youth.

The Mission and Goals Statement of the Task Force was distributed, along with notes from the keynote address, Newborn Hearing Screen Statistic for infants born September 1, 2007 through June 30, 2008 and a Position Statement from the National Association of the Deaf on Mental Health Services for Deaf Children. Time did not permit discussion on all the issues. Among the invited guests were representatives from various governmental and private agencies, such as John Gournaris, Ph.D., LP, Mental Health Program Director for the Deaf and Hard of Hearing Services Division of Minnesota Department of Human Services, the Executive Director from the MN Board of Social Work and MN Board of Nursing and the Board of Psychology. The Task Force is scheduling four meetings to take place within the next year. The results from a study, which surveyed mental health agencies and providers who work with D/HH children and youth and which formed the Task Force, will be mailed to all Task Force participants.

c. Renewals for Converting Licensed Psychological Practitioners (LPP). The Board is currently phasing out LPP licensure by allowing them to complete certain requirements so that they may convert licensure from master's level LPP's to master's level LP licensure. Many LPP's have already converted. Some are working on their last step, which is to complete two full years (or the equivalent in part-time) of post-licensure supervised employment.

We are at a point in the cycle where a number of the remaining LPP's were licensed as LPP's approximately two years ago and are ready for their first license renewal. At approximately the same time, they are also completing their two years of supervised experience. An LPP has to have an LPP license in effect in order to convert. However, for some, the dates are lining up such that their LPP licenses need to be renewed by the end of the month, their two full years of supervised employment ends sometimes within the same month, but the ARC and the Board meetings are scheduled so that their LPP license expires before they can have their documents reviewed for conversion. In order to have an LPP license to convert, the LPP would have to pay the biennial fee of \$250 to renew the LPP license and within a few weeks pay the \$500 fee to convert from LPP to LP. All Board fees are non-refundable and cannot be adjusted.

M. Seiger and P. Walker-Singleton brought this issue to N. Hart for legal advice. Mr. Hart proposed that in order to address the situation, the Board consider adopting a resolution and a delegation of authority to the Application Review Committee (ARC).

The *resolution* reads as follows:

RESOLVED: It is presumed to be unduly burdensome for LPP's who have completed the requirements for conversion **and** who have applied for conversion to LP before their LPP renewal deadline, to have to renew their LPP license to ensure continuous licensure. Based on this presumption, the Board shall grant a blanket variance of Minn.R.7200.3400 (Renewal Deadline) to all applicants for conversion from LPP to LP, by allowing them to comply with this rule by submitting their completed applications for conversion and paying the requisite conversion fee on or before their original LPP renewal deadline. Applicants will still have to document compliance

with the CE requirements set forth in Minn.R.7200.3400, subpart 1. Their LPP license will be deemed renewed and in effect until their conversion application is approved, and their LP issued. In the event that an LPP conversion application is denied, then the LPP license will be formally issued for the duration of the renewal cycle, or until a new LPP conversion application is submitted and approved.

M. Seibold moved, seconded by S. Hayes that the resolution, as stated above, be adopted by the Board of Psychology. Voting "aye": C. Bonnell, J. Brown, M. Fulton, S. Hayes, G. Jensen, J. Lee, M. Seibold, S. Ward and J. Wolf. Voting "nay": none. There being nine "ayes" and no "nays", motion carried unanimously.

The *Delegation of Authority* reads as follows:

The Application Review Committee is delegated the authority to approve applications for conversion submitted pursuant to Minn. Stat. sec. 148.907, subd. 5 (2008), and issue licenses to approved conversion applicants, pursuant to Minn. Stat. sec. 148.905, subd. 1 (4).

S. Hayes moved, seconded by M. Fulton that the Delegation of Authority, as stated above, be adopted by the Board of Psychology. Voting "aye": C. Bonnell, J. Brown, M. Fulton, S. Hayes, G. Jensen, J. Lee, M. Seibold, S. Ward and J. Wolf. Voting "nay": none. There being nine "ayes" and no "nays", motion carried unanimously.

d. Continuing Education (CE) Planning Committee Update.

S. Hayes presented the following update from the CE Planning Committee meeting on October 24, 2008.
