EXECUTIVE SESSION

Board Chair, T. Thompson called the executive session of the meeting to order at 9:15 a.m., in the Psychology Board Conference Room at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.

1. In the Matter of Suzanne James, Ph.D., L.P., License No. LP0159

On recommendation from the Complaint Resolution Committee, the Board adopted the Stipulation and Consent Order for the Licensee which included a practice restriction, supervision of the Licensee by a Board approved psychologist, supervisor's reports, treating therapist's reports, a boundaries course, a report on the boundaries course from the Licensee and the instructor, coursework, and a general health maintenance provision.

2. In the Matter of the Dorrance W. Larson, Ed.D., L.P., License No. LP4137

On December 19, 2008 the Board adopted a Stipulation and Consent Order which placed the Licensee's license to practice psychology in a **conditional status**. On recommendation from the Complaint Resolution Committee, the Board granted the Licensee an Order for Unconditional License.

PUBLIC SESSION

Board Chair, T. Thompson called the public session of the meeting to order at 9:41 a.m., in the Psychology Board Conference Room at 2829 University Avenue Southeast, Minneapolis, Minnesota, and a quorum was declared present.
