EXECUTIVE SESSION

The Board met in closed session beginning at 9:15 a.m. to consider matters of a disciplinary nature regarding individuals under its jurisdiction.

Board members convened to consider the matter of Bruce Thordal, Ph.D., LP and the proposed Findings of Fact, Conclusions, and Final Order presented by the Complaint Resolution Committee. Benjamin R. Garbe, Assistant Attorney General, appeared and presented oral argument on behalf of the Complaint Resolution Committee. Dr. Thordal and his attorney appeared and presented oral argument on behalf of the licensee. Board members Chris Bonnell, JD, Jean Wolf, Ph.D., LP, and Patricia Stankovitch, PsyD, LP did not participate in the deliberations nor did they vote in the matter. Angelina M. Barnes, Executive Director of the Board and Patricia LaBrocca, Regulations Analyst for the Board, did not participate in the deliberations. Daphne Lundstrom, Assistant Attorney General, was present as legal advisor to the Board.

Board members convened in closed Executive Session to consider the Petition for Unconditional License of Ronald Odden, MS, LP. Mr. Odden fully complied with all remedies identified in a May 13, 2011 Stipulation and Consent Order, including completion of a boundaries course, report on boundaries course from licensee, report on boundaries course from instructor and a civil penalty of \$1,000.00. P. Orud moved, seconded by S. Ward to accept the recommendation of the CRC for issuance of an unconditional license. Voting aye: J. Leichter, S. Ward, P. Orud, P. Stankovitch, J. Wolf, B. Dollins, L. Else, C. Henley, and R. David. Voting "nay": none. Abstaining: J. Brown and C. Bonnell. Motion carried.

Board members convened in closed Executive Session to consider the Petition for Unconditional License of Suzanne James, Ph.D., LP. Dr. James closed her practice in the State of Minnesota and retired from psychology. Dr. James petitioned for an unconditional license prior

to allowing her to submit a request to voluntarily terminate her license. Dr. James fully complied with the remedies identified in a September 28, 2009 Stipulation and Consent Order, including following an identified practice restriction, supervision, submission of supervisory reports, treating therapist reports, boundaries course, report on boundaries course by licensee, report on boundaries course by instructor, and specified coursework. J. Leichter moved, seconded by C. Henley to accept the recommendation of the CRC for the issuance of an unconditional license. Voting aye: J. Leichter, C. Henley, S. Ward, P. Orud, P. Stankovitch, J. Wolf, and R. David. Voting "nay": none. Abstaining: L. Else, B. Dollins, J. Brown and C. Bonnell. Motion carried.

PUBLIC SESSION

Board Chair, C. Bonnell, called the public session of the meeting to order at 10:00 a.m., in the Minnesota Board of Psychology Conference Room, at 2829 University Avenue Southeast, Suite 320, Minneapolis, Minnesota, and a quorum was declared present.

4. Rules Committee Report

A. Barnes reported that the Board passed the Committee's proposed modifications to RD4001 at the October 7, 2011 Board meeting. The Committee's revisions were incorporated into the draft and sent to the Revisor of Statutes. The Revisor provided a draft back and Board staff are in process of reviewing the content. Once draft is complete SONAR will be initiated and anticipated to be complete by December 15, 2011. A draft of SONAR will be provided to the Rules Committee for review. Following approval of SONAR language, a Notice of Intent to Adopt will be published along with RD4001 language and supporting SONAR.

After publishing the Notice of Intent to Adopt, the Board will await any requests for hearing. Components of the rules garnering 25 or more requests for hearing will necessitate a public hearing in front of an independent Administrative Law Judge (ALJ).
