

**MINNESOTA BOARD OF PSYCHOLOGY**  
**Minutes of the 470th Meeting**  
**May 22, 2015**

**8. DHS Autism Program**

DHS officials proposed implementing a structure where unlicensed professionals would practice under the supervision of a licensed professional. After a preliminary review and discussion of the plan, DHS officials and the Executive Director agreed to keep communicating in regards to this matter.

**9. Executive Director's Report**

Executive Director, A. Barnes, provided an oral update on the budget and on the database project and its progress.

**10. Rules Committee**

Committee Chair, R. David, introduced the proposed rules changes to the Board. After a review by the Board the committee moved to approve the rules package as amended.
