EXECUTIVE SESSION

The Board has accepted the licensee's voluntary surrender of his license, and the licensee shall not reapply for licensure for a period of ten years.

4. Rules Committee Report

The Minnesota State Register published the Minnesota Board of Psychology (Board) Request for Comments in the State Register on Monday, October 19, 2015. The Board office is openly accepting public comment on the proposed rules related to the EPPP admission as well as the requirement of supervision plans with the Board for postdoctoral supervised employment. Comments will be accepted and considered until December 24, 2015 by 4:30 pm.

After the Request for Comments the Rules Committee will meet January 22, 2016 to discuss and consider the Responses to the Request for Comments.

Following any discussion and/or modifications, the Statement of Need and Reasonableness (SONAR) will be drafted, and a Notice of Intent to Adopt will be published.

The Rules Committee authorized Dr. Scott A. Fischer, Ph.D., LP, Board Chair to pursue as a Chair's Initiative that includes the creation of a Public Advisory Committee (PAC) on Forensic Psychology in Family Court in Minnesota. The mission of the PAC is: "To serve as a forum for stakeholders to communicate their opinion and share their expertise on defined topics with the Minnesota Board of Psychology and its Rules Committee."

A PAC Committee Charter has been drafted and is under review by Dr. Fischer. The Composition of the PAC will likely include members from the following respective stakeholders: Minnesota licensed attorney in good standing with an established practice in family law, Minnesota licensed psychologists with education, training and experience in providing forensic services in family court, individuals with experience in the family court system including but not limited to a parenting time consultant, guardian ad litem (GAL), parenting time expeditor (PTE), or an individual with alternative dispute resolution (ADR) experience, and public member(s).

The Committee shall report to the Minnesota Board of Psychology Rules Committee and ultimately to the Minnesota Board of Psychology with respect to its findings and recommendations.

5. Administrative Committee Report

The Administrative Committee met following the Board meeting and discussed grievance updates, budget, ED Performance Evaluation, and delegated authority audit.

6. Executive Director Report

Executive Director, A. Barnes, provided an update on the following issues: complaint resolution expert review update, ASPPB annual meeting report, Department of Health survey, FARB Seminar report, MPA legislative update, online services, and café conference evaluations. A. Barnes also provided the Board a quarterly budget report.
