

Eyelash Technician Licensing



If you're anxiously awaiting the arrival of grandfathered eyelash technician licenses, here are a few updates and reminders!

IMPORTANT: Read this update *after* reading [Eyelash Technician Licensing Breaking News](#). The steps below apply to grandfathering candidates who completed an eyelash training course before July 1, 2017. If you did not complete an eyelash training course before July 1, 2017, you are not eligible for grandfathering.

Here's what you can do now:

Complete Eyelash Grandfathering Course

Review Current Laws and Rules

To help you prepare for becoming a license holder and for your laws and rules test, you can begin reviewing [MN Rules Chapter 2105](#) and [MN Statute Chapter 155A](#).

Read & Comment on Proposed Rules

The proposed rules for eyelash technicians, salons, and non-grandfathered training are available on the [Board's rulemaking page](#). Please read the proposed rules and comment on any changes you would like to see. Comments must be submitted by **September 11, 2017** at 4:30 PM.

REMEMBER: Eyelash technicians will be required to follow all laws and rules in [MN Statutes 155A](#), [MN Rules 2105](#) and [2110](#). The proposed rules would be in addition to existing rules.

Study for Exams

The content outlines for the required State Laws and Rules Exam and Eyelash Extension Theory Exam are available now. Starting on page 19 of PSI's [Candidate Information Bulletin](#), you can view all topics that will be tested on. *Note: The Written Practical Exam is not required for grandfathering applicants.*

On **September 1, 2017**, you can sign up for and take the MN State Laws and Rules Test through the Board's testing vendor, PSI. Be sure to check out PSI's [Candidate Information Bulletin](#) for more information.

Review Eyelash Technician Grandfathering Application

On **September 1, 2017**, the application to get a grandfathered Eyelash Technician Operator or Salon Manager License will be available on the [Board website's homepage](#). You can submit this application between November 1, 2017 and January 31, 2018.

Take Eyelash Extension Theory Exam

On **November 1, 2017**, you can sign up for and take the Eyelash General Theory Test through the Board's testing vendor, PSI. Be sure to check out PSI's [Candidate Information Bulletin](#) for more information.

Unlicensed eyelash extension service providers have a grace period until February 1, 2018 to meet compliance with Board laws and rules. After February 1, 2018, any eyelash extension service providers acting unlawfully may face penalty.
