# The following must be submitted for your application to be processed:

- Completed Application
- Fee: \$195 (processing within 15 business days) or \$345 (expedited processing within 5 business days)

Checks or money orders may be made payable to Board of Cosmetology. Fees are deposited the first business day after receipt. Processing time begins when your application and payment are received in the Board office. Business days do not include weekends or state determined holidays. Incomplete applications will be returned and subject to additional processing upon receipt back in the Board office.

Certification(s) of Licensure from each state in which you have ever been licensed

Contact each state's Board to have a Certification of Licensure mailed directly to the Board office. Certifications are only valid for 90 days from date of receipt and should certify each license, training hours, exams passed, and so on.

- If you are or were licensed in a state that does not issue license certifications, complete and attach the Supplemental Verification Form (available at <a href="mailto:mn.gov/boards/cosmetology">mn.gov/boards/cosmetology</a>) along with a photocopy of your license in that state.
- If your certifications do not verify at least one active license, you will need to complete a Skills Course at a licensed Minnesota cosmetology school. See page 3 for instructions.
- If your certifications do not verify completion of the minimum training hours listed above, you will need to provide evidence of an
  active license for at least three years OR complete the remaining training hours and the Practical Skills Test at a licensed
  Minnesota cosmetology school. See page 3 for instructions.
- O Original passing results from the Minnesota State Laws & Rules Examination

<u>All</u> applicants\* are required to take and pass the State Exam, including applicants who were previously licensed in Minnesota. Your original score report must be attached to this application. Exam results are valid for one year. \*If you currently hold an <u>active</u> operator or salon manager license in Minnesota, you do not need to retake this exam.

O Proof of passing a General Theory Examination

If your license certifications do not verify completion of a general theory exam, you must take and pass the Board-approved General Theory Examination for your license type (Cosmetologist, Esthetician, Nail Technician, or Eyelash Technician). Your original score report must be attached to this application. Exam results are valid for one year.

O Proof of passing a Practical Examination

If your license certifications do not verify completion of a practical exam, you must take and pass the Board-approved Written Practical Examination for your license type (Cosmetologist, Esthetician, Nail Technician, or Eyelash Technician). Your original score report must be attached to this application. Exam results are valid for one year.

You may be wondering ...

If I get a Cosmetologist or Esthetician license, will I need an Eyelash Technician license?

No, not in Minnesota. Eyelash extension services are included in your scope of practice.

# Can I get a license just for nails and waxing?

No, not in Minnesota. If you're trained in nails and skin (waxing) but not in hair care, you must obtain an Esthetician license <u>and</u> a Nail Technician license. The only way to do both with one license is to become a Cosmetologist.

# Can I transfer my manager/master license?

No, not in Minnesota. Once you obtain an Operator license, you may apply for a Salon Manager license by submitting a complete Salon Manager License Application and fee payment to the Board.

# Licensee Responsibility

# You, as a licensee, will be responsible for the following:

# O License Renewal

Your license will expire on the last day of your birth month in the third year of your license cycle. If you fail to renew on or before that date, your license will expire and you will not be eligible to work. Late fees will be applied to any license that is not renewed on time. Current renewal requirements and applications are available at <a href="mailto:mn.gov/boards/cosmetology">mn.gov/boards/cosmetology</a>.

## O Verification of Salon License

If you are working in a salon, it is your duty to ensure it has a current license.

# O Compliance with Laws and Rules


As a licensee, you are responsible for ensuring compliance with all applicable laws and rules. Civil penalties of up to \$2,000 per violation can be assessed to you, to your Designated Licensed Salon Manager, and/or to the salon for not following laws and rules established by the Board.

## O Notice of Changes

If you change your legal name or address, you must notify the Board within 30 days of the change. Address changes may be completed online at <a href="mailto:mn.gov/boards/cosmetology">mn.gov/boards/cosmetology</a>. Name changes must be reported by completing a Name Change Form and submitting it to the Board office by mail or in person with proper documentation and fee payment required by Minnesota Statutes Section 155A.25. Per Minnesota Rule 2105.0190, subpart 2, a cosmetology license in your former name is invalid as of the 31st day of your new legal name.

## 5. Determine Additional Requirements

The following flowchart is offered to help you determine what, if any, additional training hours or coursework you may need to complete before you submit your application. If the requirements you determine are <u>not</u> confirmed by your Certification(s) of Licensure, your application will be returned as incomplete and you will be required to complete any and all remaining training hours and/or additional coursework determined by the Board Licensing Division upon its formal review of your application and certification(s). This will delay your licensure and possibly result in additional requirements if your other licenses, exam results, and/or Certification(s) of Licensure expire during the application process.

IMPORTANT: Skills Course Certificates and License Transfer Course Completion Certificates are valid for one year from date of course completion.

TENNESSEN WARNING: The information you as an individual provide on this application will be used by the Board to assess your qualifications for licensure. It may also be used to determine whether you have violated any statutes or rules the Board is empowered to enforce. You are not legally required to complete this application; however, if you fail to do so, the Board will be unable to process this application or sisue a license. If the information provided shows a violation of any statutes or rules enforced by the Board, you may be subject to disciplinary action by the Board including the assessment of civil penalties. Using fraud or deception to obtain a license may be used as a basis for disciplinary action. Further, if you choose to apply. Minnesota Statutes § 270C.72, subd. 4 requires that you provide your social security number or individual taxpayer identification number for the purpose of identifying individuals owing delinquent taxes. Upon the Minnesota Department of Revenue's request, the Board must provide it with a list of all applicants, including their name, address, business name and address, and social security number or individual taxpayer identification number.

Except for your name and address, application information on individuals is private data while the application is pending and generally will not be disclosed outside of the Board and its staff. In circumstances authorized or required by law, however, the information may be disclosed to others, including the Attorney General's Office, the Minnesota Department of Revenue, the state or legislative auditor, persons contacted for purpose of verification or investigation, and persons who obtain a court order to receive the information. After issuance of a license, the information provided, except your social security number and any nondesignated addresses becomes public data and may be released to anyone upon request.
